



## District 2 Final Set – Ed Flynn And Mike Kelley

On Tuesday, by an unofficial count of 5,083 (56.4%) to 2,860 (31.7%), South Boston native Ed Flynn, a Navy veteran and son of former Mayor and Ambassador Ray Flynn, topped the field of seven candidates for the District 2 City Council seat held by Bill Linehan, who did not seek re-election. This sets up a general election contest between Flynn and South End resident Mike Kelley, former aide to Mayor Tom Menino, who finished second. The other 5 candidates com-

bined for 1,071 votes. 9,011 votes were cast.

Citywide less than 15% of the 390,000 registered voters came out to vote on a gorgeous fall day. Mayor Marty Walsh garnered 62.5% of the vote to his nearest challenger Tito Jackson who received 29.5% of the vote. The 2 other candidates recorded the remainder. District 2 turnout was slightly better than the citywide percentage coming in at over 16%.


The preliminary showed that Flynn captured the South Boston Wards

with wide margins. He did very well outside of his hometown, making inroads in Bay Village, Chinatown and the South End. Kelley found it difficult to get any traction in South Boston, trying to rely on better results in the South End and sections outside of South Boston, which don't appear to have materialized.

Both candidates believe that they have room to grow their vote, but Kelley clearly has the more daunting task with the primary differential being at 2,223 votes right now.



### Agreed: State needs to improve transportation system. Not agreed: How to pay for it

As senators released a new survey yesterday showing that residents are willing to pay more for transportation-system improvements, the Massachusetts Taxpayers Foundation released its own report raising alarms about the state's ability to maintain and improve the commonwealth's transportation infrastructure. SHNS's Michael Norton at the Telegram covers the Senate-survey side of the story, while Bruce Mohl at Commonwealth magazine and Shira Schoenberg at MassLive have the foundation report covered. Bottom line: No one is proposing a specific plan on how to raise new funds for transportation

improvement. Which is where we were before yesterday's reports were released.



# “A true son of South Boston”

**O**n Saturday morning, September 23, under beautiful blue skies at the corner of Bolton and F Street, friends and family members gathered to witness the unveiling of the Private Brian R. Mahoney memorial square signage. The late Brian R. Mahoney, who loved South Boston with every step and every breath he took, was a writer, Editor in Chief, police officer, community activist, veteran, and veteran's activist.

Navy veteran, Edward “Ed” Flynn, was the master-of-ceremonies for this event. Brian's beautiful wife, Kelly, and his handsome son, Brian, along with two of Brian's brothers, Robert and Dennis, were in attendance. Also present were veterans from

the Thomas J. Fitzgerald and Paul J. Saunders Post, Congressman Stephen Lynch, Representative Nick Collins, Boston City Councilor Michael Flaherty, Ray Flynn, his wife Kathy, and Jack Hart.

Sister Florence Kahler said the opening prayer, and along with Sister Lois Connors (both Sisters of Saint Joseph) blessed the newly-installed memorial street sign and wreath in memory of Brian. Congressman Lynch, who had previously requested that our flag be flown over the U.S. Capital Building in honor of Brian, presented this flag to Brian's wife, Kelly.

“There are two kinds of people in South Boston,” said Congressman Lynch. “There are those who are ‘from’ South Boston and those who are ‘of’ South Boston. Brian was ‘of’ South Boston because he was

dedicated to his community...and to his country.”

Ed Flynn said, “Brian believed in helping veterans and military families,” Flynn said. “...and ensuring they were treated fairly. He coordinated the Veterans Express trips to Washington D.C., and was the Chief Marshall for South Boston's Evacuation Day parade.

Young Brian Mahoney, Cornell graduate and current law student, thanked everyone on behalf of his family for attending this dedication ceremony. He's proud of his dad's commitment to the community throughout the years and will never forget him. “I still remember the day last year and experiencing such a feeling of loss,” young Brian said. “But I also remember all of the great times with him and the support

of this community for my family after our loss. That's why he loved South Boston.

Brian's brother, Robert, also spoke briefly and stated that Brian loved his wife, his son, community and country. Brian's brother, Dennis, then said that Brian's love for South Boston exceeded anything he has ever known; without doubt an undying love for his home town.

Sister Lois Connors concluded the dedication with a closing prayer and more heartfelt words that personified the life of Brian Mahoney. “He was a true son of South Boston in matters of civic and veteran's affairs,” Sister Connors concluded. “When I think of Brian, I think of his passion in his faith, life, community, family, and his patriotism.”



## The Wine Guy Hispania!

When most people think about Spain, they think of its beautiful cities, like Barcelona and the Capital, Madrid; if you ask someone who loves wine what Spain means to them, you'll get a lot of different answers, because there are lots of great wines. Spain is about a lot more than just Sangria.

Like other countries in Europe, wine

has been a part of Spain through the ages, but really got organized when the Romans took over the region and re-named it Hispania; 'gotta' love those Romans! They taught the native population how to grow and manage the grapes and how to make wine.

Today, there are more than sixty different growing regions and scores of different grape varieties, but two of the most prominent are Tempranillo and Granacha, or what we call Grenache.

From the Jumilla region, in the northern part of the country, some of the country's most popular reds are produced from vineyards that were on the verge of disaster less than thirty years ago. A destructive louse, called Phyloxerra, destroyed nearly all the vine in the region and growers had to start over. They not only met that challenge, but in the process, became one of the most modern wine-producing regions in the country and are still leading the way today.

The family of Juan Gil have been making wine since 1916 and the current crop is well-represented by its Bodegas Hijos Juan Gil 2014,

(\$13.99). The wine has a very dark cherry color with purple tones, and powerful aromas of red berries with toasted and smoked notes from their aging in the oak barrels. It shows good structure with ripe and sweet tannins. There is great depth in the mouth with a perfect balance between fruit, alcohol and the oak tones which make it very really great for so many meat-based Tapas dishes that are popular in this region.


Among the higher-end wines in this region, one of the most famous is the Bodegas El Nido Clio; its Bodegas El Nido Clio, 2014, (\$44.99), is rich and supple, with notes of dark red cherries, plums and dried fruit, soft tannins and a very long, lingering finish. This vintage is the most recent one available, but you might also see a 2010 here and there; if you do, grab it, as it will be drinking well until the early 2020s.

From Bodegas Luzon comes its most popular wine, by the same name, Finca Luzon, 2014, (\$12.99), a blend of Monestrall and Syrah grapes. This wine has a bit of spice on the nose, in addition to red cherry

and blackberry tones; the tannins are soft and the finish is notable, but not overpowering. Pair this one with roasts, beef stews or grilled lamb.

The Monterebo vineyards produce some of the best quality wines in the region, with one in particular, Monterebo Vinos Joven, Jumilla, 2014, (\$13.99), offering exceptional quality for the price. This is a drier red, with smoked tones and earthy notes; great with stronger cheeses like Stilton or Muenster, but also delicious with hearty red sauce-based dishes. So, if you're looking for a change of pace, keep an eye out for wines from this wonderful region!

The Juan Gil winery is located in the heart of the Jumilla country, in the middle of a stretch of land owned by the Juan Gil family. The history of Juan Gil dates back to 1916 when Juan Gil Ximénez (great grandfather of the current generation of Juan Gil) built a small cellar in the city of Jumilla. It was the third generation who bought the land to the outskirts of the city and moved the cellar there, where the vineyards were close by and they could enjoy the beautiful Jumilla landscape.

#### **NEW ENGLAND PATRIOTS (-9) over Carolina Panthers**

-The Panthers lost their first game of the season in Week 3, falling to the New Orleans Saints 34-13 in Carolina. The same Saints who gave up 36 points to the Patriots in Week 2 in New Orleans. Make no mistake, I do believe the Panthers will make a run for a Wild Card spot in the NFC, but you have to be honest about who they are as a football team through three weeks.
