Amazon's Final Decision May Hinge On Housing Costs

Walsh: Boston's Amazon bid won't include incentives

From a Bloomberg Radio release: "In an interview with Bloomberg Radio's Bay State Business program (Monday night), 106.1 FM/1330 AM, 4 PM to 6 PM, Boston Mayor Marty Walsh said that in its bid for Amazon's second headquarters due Thursday, the city will not include a detailed package of financial incentives and will wait to negotiate any incentives with the company if Boston makes it past the first round of Amazon's selection process."


Report on millionaire's tax: Welcome back, Taxachusetts!



riends, family, anti-drug advocates and concerned residents visited the South Boston branch of the public library to hear from and buy a signed copy of The Southie Pact, a novel by Kevin Devlin. Although a work of fiction, the story line draws from 'real life on the streets of South Boston' and, as Devlin says was his motive, offers a wake-up call to those who may be turning a blind eye to the scourge of drugs.

"The Southie Pact" is about the damage that drugs do to ordinary people and to their community and how drugs ruin the lives of those who succumb and the effect that lingers on the lives of those left dealing with the pain of senseless loss. It's also a story of hope.

The main plot is about a group of teenagers in South Boston, who lose a friend due to a drug overdose, and form a "Pact" not to let this happen again. But life isn't quite as obliging as they sadly discover in subsequent years. Although the setting is in Southie, the drug epidemic has caused heartbreak and death in every other community in this nation; and, as Devlin notes, "is not just a Southie problem".

Ed Flynn Calls For AirBnB Regulation

Boston City Council
District 2, announced this
week that if elected he will file an
ordinance related to the regulation
of short-term rental platforms in
the City of Boston. Flynn cited the
City of Cambridge's regulation as
a starting point; however, Boston
must look to improve upon their
ordinance to ensure that large
companies are not depleting our
housing stock.

"After hearing from residents throughout the district, it has become clear to me that high concentrations of corporate, short term rentals are increasing costs and driving displacement in our neighborhoods. There are public safety and quality of life issues that must be addressed as well," said Flynn. "We must also focus on absentee landlords skirting the rooming house laws - essentially creating mini-hotels

for profit. These actions gouge the rental market and create a shortage of rents that working people can afford."

Flynn cited data compiled by the Alliance for Downtown Civic Organizations (ADCO) which concluded:

- Chinatown is experiencing the most rapid AirBnB growth three times that of Boston and 37% annual growth.
- Boston's ownership/listing concentration statistics nearly double those of New York and Washington, D.C.
- The number of AirBnB units owned by multi-neighborhood hosts is almost four times the average for other major U.S. cities, stressing the residential fabric of our communities.

Flynn conveyed that he would partner with current City Councilors that have held hearings on short term rental



platforms to find comprehensive ways to address this issue. In addition, Flynn would look at registration and inspection requirements for the city.

Flynn said, "If elected, it is my hope that this regulation will begin

to alleviate our resident's concerns regarding what these short-term rentals are doing to the rental market, the public safety aspect and quality of life issues that have arisen, and maintaining the residential feel of our neighborhoods."

Old Ironsides Returns this Friday Will Pass By Castle Island with a 21 Gun Salute

eautiful, Magnificent, Majestic: These are just 3 of the words so often used to describe the USS Constitution; also, affectionately known as Old Ironsides. The aforementioned terms to describe the world's oldest commissioned warship fit, even when this historic sailing vessel is sitting still in dry dock. But when it is under full sail as it enters and leaves Boston Harbor as it has so often done, it becomes even more impressive.

After nearly 3 years of renovations in its dock at the Charlestown Navy Yard, it is preparing to set sail once again this Friday, October 20th to take part in celebrating the 242nd birthday of the United States Navy. It will also be the 220th anniversary of



the Constitution's first launch.

It will start at 10am on Friday morning, as it leaves its dock and heads for Castle Island here in Southie. South Bostonians are quite familiar with Old Ironsides, as it has graced us with its presence countless times, while parading by the massive crowds so often lined up to watch it

pass. As it passes, it will fire a 21-gun salute with its cannons, which should take place right around 11:30 am. But you may want to get there early. This is something you won't want to miss and as often as it has thrilled the crowds with this salute, it never gets old.

There will also be another salute

- 17 guns will be fired as the USS Constitution passes by the United States Coast Guard Station.

The renovations made to the ship are said to be state of the art. Any ship more than 200 years old is certain to need repair and refurbishing from time to time and in this case, it was thorough. But the priority with the repairs and renewal for the Constitution was to be sure to make everything look exactly the way it did when it was first launched 220 years ago. One tour of the ship will bring you back to that bygone era when our nation was just beginning. A fascinating journey back in time is how most people, who visit the ship, describe the experience.

So, mark the time, set your devices, be reminded in whatever way you must, but try not to miss the return of Old Ironsides – The USS Constitution this coming Friday, October 20th. The best place to watch it pass by is, as always, Castle Island in South Boston.

ers, it's going to be a big day on Beacon Hill today. From SHNS's Colin Young: "A group of senators that has been writing health care cost control legislation will release its bill Tuesday and one of its chief sponsors said the bill is 'a very substantial piece of legislation.' Sen. James Welch, who led the Senate's health care cost containment working group, said the bill will balance shortand long-term cost control strategies." Things to keep an eye out for: Medicaid reforms, pharmaceutical price controls and other hot-button issues.

Baker confident that 'one way or the other' state will overcome subsidies setback

For a guy staring at a \$100 million-plus hole punched into the state's health-care insurance market, the governor doesn't sound all that alarmed. From SHNS's Matt Murphy at the Telegram: "Gov. Charlie Baker is looking for ways to offset the expected loss of federal subsidies to health

insurers through the end of the year, but deferring to Congress for now to put money behind 2018 Affordable Care Act payments that insurers rely on to keep plan costs lower. ... 'The first piece is the rest of this calendar year for people who currently have insurance, which runs through Dec. 31. I think one way or another we'll figure out a way to make sure that that gets taken care of,' Baker told reporters Monday."

Lab chief fired after breathalyzer results withheld from attorneys

Yup, it's another crime-lab scandal. The head of the Office of Alcohol Testing was fired Monday after a report found the office withheld documents from defense attorneys pursuing a lawsuit challenging the reliability of breathalyzer test results, report Aimee Ortiz and Maria Cramer at the Globe. Just as in past scandals, slews of defendants may soon be lining up to have convictions tossed as a result. One attorney tells the Globe "every single breathalyzer test case" since 2011 could be called into question.

Rep. Collins Leads Effort in House to Restore BFD And Non-Profit Funding Secures and Restores over \$2.75 Million in Local Funding



arlier this year, State Representative Nick Collins joined his colleagues in the Massachusetts Legislature to shape a compromise budget between the House and Senate that included funds for South Boston programs. The spending plan also reaffirmed a commitment to educa-

tion local aid, substance abuse treatment, developmental services, and children and families statewide. Following a pattern of recent budget uncertainties, gubernatorial vetoes affected many important programs in the neighborhood, but Representative Collins was able to restore and secure these funds in the House of Representatives through months of advocacy.

"It takes strong advocacy in the Legislature to deliver for our community, especially when there is a budget deficit," said Rep. Nick Collins. "I am committed to continue working with my colleagues to secure funding that ensures a high quality of life in our city and in our neighborhood, and I am proud that we got it done again this year."

Each budget cycle since he was first elected, Rep. Collins has worked with his colleagues to increase funding for a wide range of programs, including family services, substance abuse programs, youth development initiatives, public safety resources, and job training. In recent years of fiscal

uncertainty, there has been a pattern of gubernatorial vetoes. This year the fourth term legislator was able to secure and restore funding for the Boston Fire Department, South Boston Health Center, South Boston Neighborhood House, Camp Harbor View, The Gavin Foundation, The Laboure Center, Julies Family Learning, The South Boston Collaborative, South Boston en Accion, and the JFK Library Foundation.

"I am proud of the work we in the Legislature do to secure these important funds. However, it is clear that nothing can be taken for granted" said Rep. Collins. "Our strategy has been to make sure that the importance of these programs is not misunderstood, and working with our colleagues we were able to make the case that these funds are critical to the wellbeing of the people of Boston. It's what I am sent to the State House to do, and I am honored to represent the people of South Boston and Dorchester in the House of Representatives."

Gubernatorial vetoes are now sent to the Senate for consideration.

Boston Community Preservation Committee Seeks Members

he Boston City Council's Special Committee on the Community Preservation Act has announced the application process for recruitment of individuals to serve on the City of Boston's Community Preservation Committee (CPC). Beginning Thursday, October 19, 2017, residents can apply to be one of the four members that will be appointed by the Boston City Council by December 2017.

The Community Preservation Committee, which was created by ordinance, is a board consisting of nine total members. Five members, by statute, represent City boards and commissions. The remaining four members are appointed by the Boston City Council with the following requirements for each of the seats: one seat requires expertise in open spaces, housing and/or historical preservation; one seat requires expertise in development, business, finance, and/or construction; and the two remaining seats will be for individuals with a history of community involvement. CPC members serve a three-year term in a volunteer capacity, and must be residents of Boston who are not City of Boston employees.

"As the first citywide elected official to have supported the Community Preservation Act, I am thankful for the partnership of Mayor Walsh, my City Council colleagues and the numerous advocates and voters across Boston in achieving last November's results," said Boston City Councilor At-Large Michael Flaherty, Chair of the Special Committee on the Community Preservation Act. "I look forward to this next stage of the Boston City Council appointing residents of our city to be part of the process of how we allocate the revenue that is consistent with the goals and ideals of moving Boston forward. Further, as we are going through a period of rapid growth and displacement, I want to focus on the creation of more affordable housing - particularly senior continued on page 14

any, perhaps all of you of you, are aware of the wild fires that have ravaged parts of California over the past days. While wildfires are hardly new for the state, the intensity and destruction of these most recent ones are without precedent.

The areas that were hit this time included vast parts of Napa, Sonoma and Yuba Counties. Hundreds of thousands of acres and scores of homes and businesses were destroyed; most sadly, more than 30 people are known to be dead, with hundreds more missing.

Napa and Sonoma are home to some of the world's best vineyards and wineries and thousands of bottles stored onsite. Many of these have been totally destroyed; the exact number won't be able to be determined for some time. This area has been responsible for producing about 85% of the state's wine- a business that was valued at 32 billion dollars in 2016.

More than 8,000 firefighters are currently fighting the blazes in multiple areas throughout Northern California. ABC News has reported that, "With firefighters stretched thin throughout the state, federal agencies as well as neighboring Nevada and nearby Washington state are assisting with resources. Authorities said 1,000 fire departments from San Diego to Oregon have joined the ef-

fort. Requests for resources have also gone out to Idaho, Montana, North and South Carolina, New Mexico, Arizona, as well as Australia".



Analytics, which provides economic and capital markets analysis, concluded that "relevant economic factors that determine a city's desirability from a business location standpoint include environment, human business capital, cost (housing), quality of life, transportation and geography. Boston landed in the top three for human capital and business environment, but was considered the most expensive city behind the New York metro area.

Moody's also framed their analysis to target the Boston metropolitan area, which would include Somerville. Somerville is taking the regional approach, which is an approach that was recently developed to attract the life sciences to the regional cluster along the MBTA Red Line. Somerville is on both the Red and Orange Line. While housing costs in the core of Boston are notably high and Somerville has seen a marked increase in housing costs, the rapid transit access corridor through Boston presents an opportunity to achieve multiple objectives, including bringing access to jobs to the outlying neighborhoods including Dorchester, Roxbury and Mattapan, not to mention South Boston.

Then, along comes Worcester. Worcester is digging deep to woo an Amazon headquarters, with a proposal to offer up to \$500 million in local property tax breaks. The incentive package would be spread out over 20 years. It boasts that technology talent can be drawn from the city's nine college and universities, most notably Worcester Polytechnic Institute. Joe Quinlivan, Amazon Robotics' president and chief operating officer, is a WPI alumnus. Their bid highlights how the cost of living in Worcester is lower than in Boston and Seattle, where Amazon is headquartered. The average single-family home in Worcester costs about \$234,000. In comparing Worcester to Seattle, the bid shows how much house you can buy with about \$575,000. In Seattle, that amount gets you a two-bedroom, one-bath home; in Worcester, you can have a five-bedroom, house with three full baths.

Amazon has targeted the Boston area for large-scale expansion outside of the HQ2 potential, both in sorting and distribution centers and in corporate offices. This summer, the e-commerce giant confirmed plans to open a

150,000-square-foot office in Boston's Fort Point neighborhood and hire 900 workers. Meanwhile, a 1 million-square-foot fulfillment center in Fall River employs more than 1,400 workers

Responses to Amazon's HQ2 request for proposals are due today Oct. 19, and the city is finalizing its proposal to the e-commerce giant. Walsh said it was his hope that Boston proceeds to a second round. From there, he said, the city could be more specific regarding potential sites within the city that could host an 8 million-square-foot campus, as well as a potential incentives package. The mayor stated that the city has a primary location in the bid, but there are other areas in the bid as well. Walsh said, "We're in the competition to win the competition."

housing, veterans housing, and workforce housing."

The Community Preservation
Committee's primary responsibilities include: approving an administrative budget for the City's
Community Preservation program; developing an annual Community
Preservation Plan; reviewing project applications and making recommendations for funding approval.
Further, CPC members are required to meet with regularity and engage with community groups throughout

the City as needed.

"I am honored to continue partnering with Councilor Flaherty as we establish the Community Preservation Committee," said Councilor Andrea Campbell, Vice Chair of the City Council's Special Committee on the Community Preservation Act. "This group will be instrumental in realizing the benefits of the Community Preservation Act, and making sure those benefits reach every neighborhood in the City of Boston. I encourage residents to apply, and look forward to working with my colleagues to select a diverse group of experts and

community-involved leaders to serve on the CPC."

Alongside the Boston City Council's Special Committee on the Community Preservation Act, the City of Boston has appointed Christine Poff as the Director of the City's Community Preservation Program. In this role, Director Poff is responsible for determining community needs, ensuring transparency in the funding allocation process, and completing annual reports on CPA projects and expenditures.

"My hope is that community members from every neighborhood

will apply to be on the Community Preservation Committee. We are estimating that we will have about \$20 million annually to allocate to parks, historic preservation, and affordable housing. It's a big task and we want a large, diverse group of applicants for the Committee," urged Director Poff.

-The 3-3 Jaguars have been a better team on the road this season. They'll travel to Indy in Week 7, attempting to bounce back from a 27-17 loss at home to the Rams on Sunday. Jacksonville has "bounced back" nicely this season, winning each game that's come after a loss. I expect them to keep that trend going against a 2-4 Colts team coming off a loss in Tennessee on Monday night. The

Jaguars' pass defense ranks third in the NFL, allowing just 166 pass yards per game. Jacksonville's run defense isn't quite as good, but the Colts have yet to see one of their running backs rush for 100 yards in a single game this season. I'll continue to put my money on rookie running back Leonard Fournette, who shouldn't be slowed down by an Indianapolis defense allowing a leaguehigh 32.5 points per game this season. Jaguars on the road by a touchdown.

CAROLINA PANTHERS (-3) over Chicago Bears

-The 2-4 Bears are looking for their second straight win, as they host a 4-2 Panthers team coming off a loss at home to the Philadelphia Eagles on Thursday Night Football. Problem for Chicago is, Carolina has a 3-0 road record this season, having won in San Francisco, in New England, and in Detroit. With extra time to prepare, there's no reason why Cam Newton shouldn't find a way to squeeze out another road win against a Bears defense that allows 25 points per game. Rookie quarterback Mitch Trubisky still has a long way to go for me to be scared to bet against him at home. And the Panthers are one of the best teams in football. Give me Carolina by 10.

DALLAS COWBOYS (-6) over San Francisco 49ers

-The 2-3 Cowboys are coming off their Week 6 bye in a desperate situation. They've lost two straight — both at home, to the Rams and Packers — and are in third place in the NFC East, with the 5-1 Eagles and the 3-2 Redskins ahead of them in the standings. At first, we thought Ezekiel Elliott's suspension was reinstated, but after another appeal, he's able to play again. So that's another reason to take Dallas. San Fran just released veteran linebacker NaVorro Bowman last week, and the 49ers are still looking for their first win of the season. They'll turn to rookie quarterback C.J. Beathard, who will make his first NFL start Sunday at 4 p.m. An interesting stat, however, is that San Francisco has only lost one game by more than three points, and that was in Week 1 to Carolina. While it's tempting to take the six points here, I think Dallas is due for a statement win, and no better time for that than against an 0-6 team, even if it is in San Fran. Cowboys by 10.

CINCINNATI BENGALS (+5.5) over Pittsburgh Steelers
