Believe it or not, Election Day is next Tuesday September 4, the day after Labor Day.

The election for State Representative to replace now Senator Nick Collins, who will also be on the ballot, highlights the political action here in South Boston. David Biele, and attorney and former staff director for then-Representative Nick Collins, is running, as well as Matt Rusteika, a former energy conservation manager with the Commonwealth of Massachusetts.

## State Senator Nick Collins Endorses David Biele for State Representative

# Letter to the Editor



Dear Neighbor,

I want to take this opportunity to share with you the important work we were able to accomplish for South Boston this year in the Legislature. I am proud to have been elected to serve you in my new role as State Senator, and will continue to fight for what is important for our community.

In the FY19 Budget, I was able to secure operating funds for important programs in South Boston including substance abuse programming at the South Boston Collaborative; narcotic use reduction programs at the South Boston Community Health Center; youth development programs

like the South Boston Youth Ambassador Program and South Boston Leadership Initiative; a total immersion recovery program at the Gavin Foundation; youth transportation for summer camp; and senior programming at the South Boston Neighborhood House.

This year in the legislature, I successfully led an effort requiring Massport to implement Ship-to-Shore power capability at Flynn Cruiseport in the Economic Development Bill. The measure would have ships coming into port to plug into the electric grid rather than using diesel engines that emit fossil fuels into the air. This legislation also includes mandatory environmental impact reporting on Massport activity at Flynn Cruiseport and the Conley Cargo Terminal. This will bring accountability to Massport's environmental obligations and help to create a healthier neighborhood for our families to live and grow.

We also passed the Environmental Bond Bill which included \$1million in capital funds for new tree planting and geo-tracking across Boston and the creation of a trust for the long term

preservation and maintenance of Castle Island and Marine Park in South Boston.

In addition to all this we have passed automatic voter registration, strengthened election integrity, created additional tools to address the substance abuse epidemic, reformed our criminal justice system, raised the minimum wage to \$15 an hour, established responsible regulations on short-term-rentals, and laid a framework for a sustainable energy future in the Commonwealth, and passed first in the nation Alzheimer's legislation to provide new training for doctors and more resources for those living with the disease, as well as support for their family members.

I was proud to join my colleagues in passing the BRAVE Act. This veteran's legislation addresses employment protections, tax exemptions, burial expenses, court programs, medical care, and also continues to recognize those who serve and who have served our country. We will continue to prioritize legislation that strengthens, protects, and supports our families, children, veterans, seniors, and workforce.

Over the past three years, \$15

million has been invested by the State in transportation infrastructure and safety measures across South Boston. This work includes new signals, speed mitigation measures and safety improvements currently underway on Day Blvd., pedestrian bridge repairs along Old Colony Avenue connecting residents safely from the Maryellen McCormack Housing Development to Moakley Park, conversion of the City Point Bus Layover Facility on East First Street to allow for passenger pick up and drop off. A passenger platform was added to sidewalks for access as well as additional benches and much needed lighting, just to name a few.

I will continue to work together with my colleagues in the Legislature to ensure that funding is available for more transportation investments that serve all of South Boston.

As we enter the final weeks of summer, I want to thank you for giving me this opportunity to represent you in the State Senate. I will continue to advocate for the issues that are important to our community and bring as many resources as possible to it.

Secretary of State, Governor and the local State Representative seat should spark interest, but concern has been raised over the date of September 4. Massachusetts statute requires the primary to be held on the seventh Tuesday before the general election, which this year would have fallen on Sept. 18. But that happens to coincide with the beginning of the most important Jewish holiday, Yom Kippur, which begins that Tuesday evening. In such an instance, state law mandates the secretary of state choose a primary date "within 7 days of the second Tuesday in September" — that's seven days before or after Sept. 11.

Secretary of State William Galvin said he couldn't choose Tuesday, Sept. 11, itself because that is also a Jewish holiday, Rosh Hashanah. And the secretary, a Boston Democrat, said he did not want to choose Thursday, Sept. 6, the first day back to school for many children, including most Boston Public School students. Mondays and Wednesdays pose troubles of their own, his office said, with few voters associating those days with going to the polls, and there are a host of religious and cost-related reasons not to hold an election on a Friday, Saturday, or Sunday. He emphasized the constraints of the law and calendar: "I think we picked the best date we could

## Councilors Flynn, Baker Call for 20 MPH Speed Limit Hearing

Last week, Boston City Councilors Ed Flynn and Frank Baker called for a hearing to examine the merits of lowering the speed limit in the City of Boston to

20 MPH, unless otherwise posted, as well as a discussion of other traffic calming measures to improve road safety for all. The speed limit in the city was most recently low-

ered from 30 MPH to 25 MPH on January 9, 2017 as part of the city's Vision Zero initiative, no serious or fatal crashes in Boston by 2030. The order has been sent to the Committee on Planning, Development and Transportation.

"In the final analysis, Councilor Baker and I want to open up this dialogue to ensure we are doing all we can to try to save lives and realize Vision Zero. We believe that infrastructure changes, like speed humps and raised crosswalks, are necessary for traffic calming; however, a combination of these physical changes and a lower speed limit will improve public safety for all," said Flynn. "Data from the city's website and the AAA Foundation for Traffic Safety recently indicated that the chances of a serious or fatal crash at 30 MPH is 50%, while at 20 MPH the chances significantly drop

to 18%. We thank Mayor Walsh and his staff for their strong leadership on Vision Zero and efforts to make Boston safer for all."

Councilor Baker said, "We were already successful in lowering the speed limit to 25 miles per hour on public ways subject to the control of the city. One of my top constituent complaints is the need for lower speed limits, more enforcement, and various traffic calming measures, like raised crosswalks, speed humps, narrowing traffic lanes, and bump-outs. As elected officials in the City of Boston, we need to help eliminate traffic fatalities on our city's streets. Further lowering of the street speed limit is an important step in the right direction."

It makes you ask the question; Is he there to serve the voters and constituents in the Fourth District, or is he there to serve himself and his law practice?

The Boston Herald followed up yesterday, August 28, 2018, with an Editorial calling out the blatant conflict of interest, having Attorneys approving judges and clerk magistrates, and then appearing before them. The Editorial states, "The Scales of Justice are looking a little off-kilter here in Massachusetts, and the Governor's Council is to blame...Astonishingly, six of the eight councilors are currently serving as attorneys,

who may directly or indirectly have business in courtrooms in front of the judges they helped install. This obviously creates the potential for a massive conflict of interest and damages the perception of integrity in the judicial system."

It is time we remove this Conflict of Interest and remove one more Attorney from the Governor's Council.


Joining him is his Queen, **Milly Pena**, who matches Dan in her en-

*This week, Danny shared his thoughts on some of the top stories in the sports world:*

**I**'m actually on vacation this week. But here I am, for you, getting a couple things off my chest. First and foremost, when I return next week, I'll have some exciting news to share regarding my podcast. So, make sure you turn on your phone and subscribe to "The Danny Picard Show" right now.

The week before the NFL regular season begins is always a good time to get out of town and shut it down for a few days. The fourth week of preseason games this weekend are pretty much meaningless, unless you're a player battling for one of your team's final roster spots. But that's more exciting for them, than it is us. For the most part, here in New England at least, we know who the key pieces will be for the Patriots this season. But I'm not going to lie, I'm surprised about Eric Decker's retirement announcement last weekend.

As I wrote in my column for The Boston Metro newspaper just a few weeks ago, Decker seemed like the perfect Bill Belichick "diamond in the rough" signing. He's 31 years old. It was a one-year deal with a max value of \$2.1 million, with a cap hit of \$1.5 million, but only \$75,000 was

guaranteed, in the form of a signing bonus. So, for the Patriots, it was a low-risk, high-reward deal. And for Decker, it was a way to prove himself in a single season with a Super Bowl contender, playing with one of the best quarterbacks in the league in Tom Brady, and having an opportunity to play an even larger role early on in the season, with Julian Edelman serving his four-game suspension.

But, after just three preseason games with the Patriots, Decker has decided to call it quits. Here's what he had to say about it, via instagram:

"It has been my childhood dream and my passion to play the game of football. I was very fortunate and blessed to have had the opportunity to have those dreams fulfilled and to have played with such extremely talented and hard-working teammates, coaches and staff. This has been a passion inside of me since I was a little boy but I know now it is time to hang my helmet up and start a new chapter in my life. I love football and always will. It will continue to be a part of my life. I'm looking forward to spending more time with my wife and kids. I want to give a special thank you to my

family, friends and fans for all your support on this incredible journey. It's been an amazing chapter in my life. I look forward to the future and many adventures ahead."

My first reaction to this is, he actually wrote this himself. This wasn't a note written by a PR director or anything like that. This was from the heart, from Decker himself. But the whole thing still surprises me. It's not like he's a dinosaur. And he says he still loves football. I can't tell whether his retirement is mental, physical, or both.

Watching the preseason action that he saw with the Patriots, it was clear that it just wasn't working out for him. Sloppy routes, mental lapses, dropping balls. So, by watching his performance, I guess nobody should be surprised that he won't be on the team this year. But I'm surprised that he actually looked that bad to begin with. Again, he's 31, not 41. And the opportunity was there for him to play a pretty big role on a Patriots offense that's looking for help.

Maybe he just didn't want it bad enough, and he didn't fully realize that until he showed up to Foxboro and Belichick was ripping

him a new one in the film room. That's the way it seems. But, man, if being a Patriot right now, with a chance to win the Super Bowl isn't enough to motivate you, then I don't know what to tell you. It's kind of a bad look for Decker, to be completely honest. Perhaps he was told he was going to get cut, and because of his veteran status, the Patriots gave him an opportunity to announce that he's leaving on his own terms. That's also very possible, because again, Decker looked terrible in the preseason.


So Decker will move on. And so will the Patriots, as they try to look elsewhere for a wideout to at least fill the void for Edelman's absence in the first four weeks of the season. Maybe they'll stay within the organization under their "next man up" philosophy. Or maybe, just maybe, they'll give Dez Bryant a call, who, as I write this on Tuesday morning, is still a free agent.
