ocal elected officials take action, on the heels of a Boston Globe editorial that, in yet another apparent swipe at South Boston by its editors, attempts to paint local elected officials and residents as backward-thinking and narrowminded. However, these editors, one can argue, displayed their journalistic indolence by framing the desire to bring additional scrutiny to a massive real estate development project as NIMBYism. "How deeply insightful of them. That worn-out label must

have taken a lot of thought", one resident said, as she smirked.

In response, in a letter to the editors of the Boston Globe, by Senator Nick Collins and Representative David Biele, referencing a bill that they filed to require a full review by the Legislature and the state inspector general's office, they stated, "...any suggestion of NIMBYism falls flat, based on the fact that South Boston has seen more Article 80 projects permitted than any other part of Boston since 1996, creating many new housing and affordable housing opportunities in the community and across Boston. Recycling old themes and demeaning lingo, absent these facts, causes the editorial to miss the mark by a long shot. The public good, transparency and accountability – the purpose of our bill - should always come first."

And finally, if nothing else, stop and think back to the first time you saw that special someone and what it was that made your heart move like it never has before and celebrate the love of your life. Just a little background...our day of love actually came about when the Emperor Claudius executed two Christian men with the name Valentinus during the third century on or around February 14th and the early Church decided to honor them. Also, as far as historians can tell, neither of them was related to the Hallmark family.

If you intend to pledge your love, a great way to show it is with bubbles-sparkling wine or Champagne, to be exact; here are a few worth considering....

Piper Heidsieck Brut, NV, Aye, Champagne, France, (\$37.99), is one of the oldest labels from the region and relatively small by French standards; however, the great balance and acidity of this wine consistently makes it a real value. It's fantastic with shellfish, lighter cheeses and chocolate-dipped strawberries.

If you want to move it up a few notches, try a Vintage Champagne; most years are non-vintage years, designated by the "NV" on most labels. Every once in a while, however, a "Vintage Year" is declared when all the elements for making exceptional wine are at hand. A great example of this at a relative value, is Veuve Clicquot Brut Rose, Vintage 2008, Champagne, France, (\$84.99).The Wine Spectator-France describes it as, "Rich and smokey on first impression, yet harmonious and elegant overall, with sleek acidity and a minerally underpinning deftly married to flavors of strawberry pate de fruit, toast, mandarin orange peel and crys-



tallized honey." This is a great aperitif before any meal and would go really well with anything diamond, if you're so inclined.

If a domestic label is more to your (and your budget's) liking, you should consider Roederer estate Multi Vintage Brut, Mendocino County, California, (\$25.99), a blend of 60% Chardonnay and 40% Pinot Noir. It's aged for two years on lees and that gives it a great acidity, coupled with delicious notes of green apples and lemon zest. Have this one with some oysters on the half shell or scallops wrapped in bacon and you won't be sorry.

J Cuvee 20, Russian River Valley, Napa, California, (\$31.99), is ripe, refreshing and buttery, made from 54% Chardonnay, 43% Pinot Noir and 3% Pinot Meunier, all of which combine to give delicious flavors of light green apple, melon and caramel, with a long finish. Have this one before or after a meal or immediately after a proposal,(hopefully, accepted!).

Boston Sword & Tuna Breaks Ground on New Maritime Facility

he \$20M development project expands the seafood industry cluster in South Boston

Representatives of Boston Sword & Tuna (BST) and Pilot Development Partners, Inc. (Pilot) joined Congressman Stephen Lynch, Mayor Marty Walsh, the Massachusetts Port Authority (Massport), and local officials in a celebration to kick off the construction of a new headquarters for BST, which expands the seafood industry cluster in South Boston.

"I am very happy to welcome Boston Sword and Tuna to South Boston," said Congressman Lynch. "As someone who worked in the Port of Boston, I value the fact that the Massport Marine Terminal has provided great jobs for residents for many years and companies like Boston Sword and Tuna will help strengthen our community and advance commercial and industrial development." The \$20M development project creates a nearly 50,000 square foot state-of-the-art seafood processing plant for BST on a portion of a 6.5-acre Massport-controlled waterfront property known as Parcel 6. Parcel 6 is part of the so-called Massport Marine Terminal (MMT). Massport has a lease agreement with the Boston Economic Development and Industrial Corporation (EDIC) on the 40-acre site through February 2070.

"Boston Sword and Tuna has an incredible history from its Sicilian roots to its new roots in Boston, and now having their own building on Boston's waterfront," said Mayor Walsh. "This company is part of a growing seafood processing cluster that is important to Boston's working port and our economy as a whole. I look forward to seeing their continued success as they grow their business and serve their customers here in Boston and around the world." The seafood processing plant will include 36,000 square feet of processing area, a test kitchen for new product trials, 10 loading bays, a small gym for employees, and 13,000 square feet of mezzanine office space. A catwalk structure will also be built inside the plant to give customers and visitors a birds-eye-view of the facility during tours. Currently, BST is a tenant at the Harbor Seafood Center on Seafood Way.

"Having our own building in South Boston will have a big impact on how we do business," said BST President Michael Scola. "The bigger space will enable us to meet internationally recognized quality standards that will allow us to grow and better serve our customers globally. The new facility will also give our employees a much bigger and brighter work environment. They deserve it because they all work so hard to make us the best seafood company out there."

Scola came from a family of fishermen with roots in Sicily, Italy. Through the years, his family has left footprints along the South Boston waterfront, starting from the R&P Seafood/Shellfish (R&P) company on Fish Pier, which his father co-founded in 1972. Scola and his brothers, Paul and Steven, eventually took the reins of R&P. Then, in 1999, they started adding divisions in pursuit of becoming America's one-stop-shop for seafood. In 2003, BST was born and merged with R&P in 2007. In 2010, Scola partnered with Larry Dore, whose 30 years of experience in the seafood industry helped guide the company's continued growth.

The company currently has 135 employees from the Greater Boston

area and has plans to hire 15-20 more local workers in the next couple of years. "I applaud Boston Sword & Tuna, as well as Pilot Development, for seeing the potential in the Massport Marine Terminal," said State Representative David Biele (D-4th Suffolk). "The Port of Boston is alive and well. I am encouraged to see these types of investments in the South Boston Waterfront." In June 2017, Massport tapped Pilot to develop Parcel 6 at the MMT. Pilot was approved to sublease a section of the vacant lot to BST in November 2018. "Boston Sword & Tuna is a leader in the seafood industry," said Kathryn Maynes, Vice President of Pilot Development Partners, Inc. "We're thrilled to have a wonderful client to support the seafood industry and the employees that they will be bringing to this part of the working Port of Boston.

Plans for the new building are environmentally-friendly. The building's design complies with Massport's Floodproofing Guidelines and meets the Leadership in Energy and Environmental Design (LEED) certifiability standards. "We have designed the project with climate **continued on page 7**

Councilor Flynn Hearing on After Hours Construction Issues

Cites Quality of Life Concerns Throughout District

B oston City Councilor Ed Flynn announced that he will call for a hearing next week regarding the issue of after hours and weekend construction. Flynn relayed concerns brought to his office from residents throughout District 2 related to construction work being done outside permitted hours - early in the morning, late in the evening, or on the weekend or holidays without permits.

Moreover, community leaders called attention to permits granted for after hours and weekend work in the South End, while others pointed to issues of public safety, rodent control, and adhering to approved plans.

"Whether I am in the South End, South Boston, Chinatown, Beacon Hill, Back Bay, the Bay Village, or Downtown - resi-



dents frequently express concerns regarding the issues associated with construction work being done outside of permitted hours, or being done illegally without a permit at all on weekends and holidays," said Flynn. "I will be calling for a hearing next week as I believe a discussion is warranted when it comes to the process and enforcement, accountability and penalties, and any gaps that exist to help us improve the quality of life for the people of Boston. In addition, we need to ensure developers are making sites secure and safe for our communities in all phases, performing suitable rodent control, and adhering to approved plans."

change in mind," said Eden Milroy, President of Pilot Development Partners, Inc. "We are adding more earth to the property and constructing the building 4 feet higher than usual based on calculations for sea levels and flood levels in 2070." Construction is scheduled to be completed by the end of 2019. The location will keep BST within 3 miles from Logan International Airport. "Investing in the working port is essential to keeping these industries vibrant," said Boston City Councilor At-Large Michael Flaherty. "The Scola family has been down on the South Boston waterfront for decades, providing good jobs and great seafood."

"The working port in Boston has provided quality blue-collar jobs for generations," said Boston City Councilor Ed Flynn. "I am thrilled to see marine industrial development moving forward and Boston Sword & Tuna building a new home at the Massport Marine Terminal." "This development represents a major milestone for the Port of Boston and the city's maritime history continues to flourish," said Acting Massport CEO John Pranckevicius. "This is just the first of what will be a number of seafood and maritime businesses on this blank canvas section of South Boston. We are delighted to see the Scola family and Boston Sword & Tuna grow their business on the Massport Marine Terminal. The proximity to Logan Airport, the interstate highway, and the Port of Boston make the Massport Marine Terminal a strategic location for future maritime businesses.

Pilot is also intending to develop a seafood processing plant or cold storage facility on an adjacent portion of Parcel 6. A 280-space mixeduse garage for maritime industrial uses, with a 2,500 square foot meeting hall for the International Longshoremen's Association (ILA) and a 5,000 square foot seafood/sandwich shop anticipated to be operated by BST, are also being proposed on the boundary along Fid Kennedy Avenue. The Massachusetts Port Authority (Massport) owns and operates Boston Logan International Airport, public terminals in the Port of Boston, Hanscom Field, and Worcester Regional Airport. Massport is a financially self-sustaining public authority whose premier transportation facilities generate more than \$18 billion annually and enhance and enable economic growth and vitality in New England. port negotiated a deed restriction in 2014 with Exelon Corp., the plant's previous owner, prohibiting residential housing on the Edison site, knowing that residential users of this land would disrupt the area and its maritime logistics. Simultaneously, the underlying zoning at the Edison site requires marine industrial and commercial uses, in order to protect and support port operations. Disregarding these safeguards would be a disservice to the Commonwealth and the region; it would endanger over \$850 million in public investments in port infrastructure in and around Conley Terminal, challenging the site's long-term productivity. Our bill seeks to put Massport's deed restriction on the same level as other public land interests across the Commonwealth. Public land interests routinely require public bidding, input on valuation or authorization by the Legislature. Lifting this deed restriction without any competition or public input would be unprecedented, and our legislation calls for transparency."

For the City of Boston's part in this chronicle, Boston City Councilors Michael Flaherty and Ed Flynn, due to what they say has been a multitude of concerns raised by the South Boston community, commercial and maritime industry representatives, the International Longshoremen's Union, the Boston Carmen's Union Local 589, and the entire South Boston elected delegation, has prompted them to file for a hearing to discuss the halting of the Article 80 process as it applies to 776 Summer Street (historically known as the Edison Power Plant).

"The community's anxiety and concern surrounding the proposed 1,344 residential units, especially in light of Massport's existing residential deed restriction is a clear indicator that we need to discuss the Article 80 process, as it relates to this project," stated Councilor Flaherty. "Further, community members have already spent an extensive amount of time attending meetings and yet have not been given the opportunity to review the alternative site plans for the site. Two years of meetings for a proposed project that may not even move forward warrants a discussion with city and state planners."

"There are many significant 'quality of life' concerns caused by the proposal in front of us. South Boston community members - who have clearly voiced their concerns with the Article 80 process - have called upon us, their elected officials, to look at the range of matters that will be impacted should this project move forward as is," stated Councilor Flynn.

The City Council hearing order - which was filed in the Council Session on Wednesday, January 30, 2019 - was signed on to by Councilor Lydia Edwards, **Councilor Annissa Essaibi-**George, Councilor Althea Garrison, Councilor Kim Janey, Councilor Tim McCarthy, and Councilor Michelle Wu. Congressman Stephen F. Lynch, State Senator Nick Collins, and **State Representative David** Biele are also working with city and state officials to ensure there is full transparency throughout this process for South Boston residents and taxpayers alike.

same thing with AEW. Who is signing there? What's happening? Who's on the roster? They're going to be on TV, but which channel and which night? Tuesday nights would make the most sense because WWE Smackdown leaves Tuesdays and goes to Fridays this October when it moves to FOX. So there's just so much going on with AEW. What's their main event in May? You'd assume Chris Jericho is going to be in that main event. Kenny Omega would make a great partner in that match . . . There's just so much unknown it's exciting with All Elite Wrestling, where, with the WWE, not that we have all the answers, but we definitely have far more of an outline as to where they're going to go.

DP: There's no question that AEW has already affected and improved the WWE product over the last month. We saw Finn Balor in the main event at the Royal Rumble against Brock Lesnar. They had "The Revival" doing a segment with Vince McMahon. They had Sasha Banks against Ronda Rousey. Zack Ryder is back on TV. And that's just naming a few . . . So there's no question that AEW is actually already showing to be a great thing for WWE. JB: Vince McMahon is best when he's got his back against the wall, which, in 2018 and 2019 that seems to never happen. But when Vince is challenged, he's at his best in the pro wrestling world. DP: What does AEW do for a TV deal? JB: Tuesday nights. It has to be

Tuesday nights.

DP: Yeah but what station? **JB:** I've heard a couple differ-

ent options. I've heard TNT. I've heard TBS. I've heard WGN. I don't know. I think the time is more important than the channel. I think they're going to get a good network. The Khan family is the perfect group, it seems like . . . There are a lot of interesting pieces with AEW, in terms of people who haven't run a wrestling company before. PATS WIN SIXTH SUPER BOWL, FAVORITE FOR SUPER BOWL LIV

he New England Patriots defeated the Los Angeles Rams, 13-3, on Sunday in Atlanta to win their sixth Super Bowl championship. It marks the Patriots' third Lombardi Trophy in the last five years.

Julian Edelman was named Super Bowl MVP, becoming the seventh wide receiver to claim that prize.

The real story of the game though was the Patriots' defense, holding the Rams' high-powered offense to just a thirdquarter field goal. Rams quarterback Jared Goff was 19-for-38 with 229 passing yards, zero touchdowns, and one interception. Goff was also sacked four times.

On the other end, Tom Brady's numbers weren't that much better, going 21-for-35 with 262 passing yards, zero touchdowns, and an interception. But it was Brady's fourth-quarter drive which resulted in a Sony Michel two-yard touchdown run that made the difference.

With the game tied at 3-3 and just under 10 minutes left in the fourth, the Patriots got the ball back at their own 31-yard line, and Brady put together a picture-perfect drive, completing four straight passes to move the ball down to the Rams' 2-yard line, where Michel pounded it in to give the Pats a 10-3 lead with seven minutes left.

Los Angeles responded with a nice drive of its own, taking the ball down to New England's 27-yard line, but that's when Patriots cornerback Ste-



phon Gilmore intercepted a deep pass intended for Brandin Cooks with four minutes remaining. The Patriots then picked up several first downs and killed the clock until Stephen Gostkowski sealed the deal on the win with a 41-yard field goal that gave the Pats a 13-3 lead with 1:12 left in the game.

According to BetOnline.ag, the Patriots are the early favorite to win next year's Super Bowl LIV in Miami, at +600. The Kansas City Chiefs have the second-best odds to win it all at +700, followed by the Rams at +800, and the New Orleans Saints at +900.

This offseason will bring plenty of rumors regarding the future of certain Patriots players like Rob Gronkowski and Devin McCourty, who left the door open to retirement when asked about next season's status during Super Bowl week. Both Gronkowski and McCourty have one year left on their respective contracts.

Tom Brady said he'll be returning. Bill Belichick will be back. So will Josh McDaniels and offensive line coach Dante Scarnecchia. It would be shocking to see the Patriots not do everything in their power to try and convince Gronkowski and McCourty to return for at least one more run.

It's possible that Gronkowski signs another revised contract for next season, similar to the one he signed before this past season, which added \$4.3 million in additional incentives to his \$8 million base salary. Gronkowski has a base salary of \$9 million next season.

EDELMAN NAMED MVP, MAKES HOF CASE

he Patriots' 13-3 win over the Rams on Sunday was the lowest scoring Super Bowl in NFL history.

It wasn't pretty, but somebody still has to get the Super Bowl MVP.

That award went to Julian Edelman, who finished with a game-high 10 catches for 141 yards, which included a big 13-yard reception over the middle during the only touchdown drive of the game.

It was the perfect ending to a season that began with a PED suspension. Edelman was forced to sit out the first four games of the regular season for violating the league's policy on performanceenhancing substances. Edelman's appeal was denied, and the Patriots went 2-2 without him to begin the season.

Edelman missed all of the previous season with an ACL tear, and did not take part in last year's Super Bowl LII loss to the Philadelphia Eagles. Sunday's win over the Rams marks his third Super Bowl championship.

The MVP performance has created quite the stir in the "Pro Football Hall

of Fame" debate. Is Edelman worthy enough to one day be inducted? Some say he has more work to do. Others say it should be a no brainer to put him in.

Edelman's story in itself is enough to at least put him in the Hall of Fame conversation.

The Patriots drafted Edelman in 2009, in the seventh round out of Kent State, where he had been a quarterback. He didn't become a 1,000-yard receiver until 2013, when he caught 105 passes for 1,056 yards and six touchdowns in 16 games.

He has three Super Bowl rings, and a total of 1,412 receiving yards and five touchdowns in 18 playoff games. He's even thrown a touchdown pass in a play-off game, and played defensive back in the early stages of his NFL career.

Edelman has turned into — arguably — the most crucial element of the Patriots' offense, outside of Tom Brady of course. And his career is not done yet.

Whether he ever ends up getting into the Hall of Fame remains to be seen. But as of right now, he most certainly deserves to be in the conversation.
