# **EDITORIAL** Was The WWII Memorial Targeted For What It Represents?

f you ask most locals why they think our World War II Memorial was defaced earlier this week, they would tell you they suspect it was targeted for what it stands for. This newspaper has been inundated with calls, letters, emails and social media posts saying they are not convinced it was just rowdy visitors in town for the holiday that had too much to drink. The belief by the overwhelming majority of those who contacted us say they are pretty

sure it was deliberately targeted, because it was a symbol of what gives most of us pride in country and community.

We only have to look at what's been taking place around the country by out of control thugs, who feel that if they see a symbol that they personally dislike and disagree with, all they have to do is demand those symbols be removed and they can get their way. And if they don't get their way, they are also convinced they are entitled and have the right to destroy them. The fact that these disgruntled thugs HAVE been getting their way and getting away with it these last couple of years, because people in positions of authority are too cowardly to stand up to them and in some cases agree with the thugs, only encourages more of it.

Someone doesn't like a statue of a historical military figure or one standing in a church courtyard or the name of a street, a plaque on a building, or our FLAG, it must come down. This is the mentality running wild by a vocal and dangerous few in this nation and is actually enabled by those who should know better.

Our war memorials are sacred to South Bostonians, current and former, as well as to every American who loves this country. The names engraved on them are those of 'True American Heroes'. The time to tolerate those, whose values are so twisted that they would vandalize



this or any other symbol of American pride, as well as those who by their silence and cowardice enable and encourage these actions, must come to an end now.

lways a strong voice and a steady hand in the community, John Mullen USMC, wore the designation, 'veteran', as a badge of honor, symbolized by his Thomas Fitzgerald Post service cap. An active participant is all things related to veterans over the years, from the annual Memorial Day March to Mass and Exercises, the Vietnam Memorial and Services to the launching, along with fellow veteran and activist the late Brian Mahoney, of the Veteran's Express, Mullen, 89, passed away this week.

The ironic twist of fate is noted here, in that his death

coincides with the disgraceful vandalism of the World War II Memorial located at the entrance to the Pleasure Bay walkway. News stations and media outlets around the country have descended on the South Boston neighborhood to gauge reaction and witness the collective efforts to deal with this egregious act. It is a memorial that Mr. Mullen passionately helped to bring to fruition.

The groundbreaking happened in 2002 with the City of Boston's Edward Ingersoll Browne Trust Fund providing a \$150,000 grant that was soon matched by a fundraising committee organized by



Mr. Mullen and members and friends of the Fitzgerald Post 561VFW. Designed by architect Robert Shure, who has been on site assisting in the cleanup efforts, the memorial lists, in alphabetical order, each veteran's name and the branch of service.

The symbolism of the timing of this desecration and Mr. Mullen's death is poignant in its actuality. Family and friends have expressed their relief that he had passed before the vandalism was reported and believe that divine intervention played a role in sparing him from the anguish that would he would feel that the assault on democracy had arrived at his doorstep.

ell, South Boston survived another St. Patrick's Day/Evacuation Day and for the most part, it turned out well. Kudos to State Senator Nick Collins for a job well done at the breakfast. He kept it classy and respectful, while still being a good time. 
As we all are now aware, the day after the festivities brought some bad news. Our World War II Memorial on Day Blvd. had been vandalized and badly damaged. Few people believe that it was the work of visiting drunken celebrants and virtually no one believes it was the work of locals. No, most believe it was the calculated work of anti-American/anti-military leftist punks, who wanted to send a loud and clear message of protest. People of that ilk are well aware of what war memorials honoring our veterans who gave their lives for this country mean to the residents of patriotic communities like South Boston. They oppose everything our nation stands for and take every opportunity to tear our cherished monuments and symbols down. Do I have proof of this? Not yet. I'm expressing my opinion on this and what seems to be the opinion of many, both within and outside of this neighborhood, who are furious at what happened also have said they believe. It was also reported that similar type vandalism occurred on war memorials at Mount Hope Cemetery in Mattapan.,

It's hoped that if those who defaced the monument are caught by police, they will be prosecuted to the fullest extent of the law – no slaps on the wrists, no leniency from the court. And of course, we all know that there are many who wish that they had been caught in the act by neighborhood people and had received a heavy taste of street justice for their crimes. So many creative methods of that style of justice have been suggested and most cannot be printed in a family newspaper. The anger and desire to cause harm to people, who would do what they did is highly illegal, yet understandable.

In the aftermath of this incident, neighborhood people along with so many supporters from outside the community from far and wide have come together to do their part to restore the memorial and make it as it should be - a beautiful and proud symbol that honors true American heroes who gave

all so that the rest of us can live in freedom.

Like South Boston's other war memorials and war memorials all across this nation, our World War II Memorial stands as a reminder of the sacrifices made by the men and women in uniform, who from the time our country began, right through the present day, tower in stature and greatness far and above the cowards, who sneak around in the darkness of night to deface and disrespect their memory.



## **REP. BIELE MAKES HOUSING TOP LEGISLATIVE PRIORITY**

Co-sponsored legislation to provide relief from high costs of housing

ith over 5,000 bills filed in the Massachusetts legislation this session, Representative David Biele has cosponsored and supported several pieces of legislation to address the high costs of housing in Boston and to protect senior residents.

• An Act regarding state income tax credit for renting unsubsidized properties at below market rents. This legislation would provide property owners with a tax credit for renting units at below market rents;


• An Act relative to low income housing eligibility for disabled veterans. This bill would exempt veterans' disability payments from being counted toward eligibility for housing;

• An Act relative to the just cause eviction of elderly lessees. This bill would prohibit landlords from evicting elderly residents over the age of 75 without just cause; and

• An Act providing tax relief for rent burdened individuals and families. This bill would allow residents who make less than 100% of the average median income to make tax deductions on rent payments, up to \$4,100.

"Increasing housing costs are one the biggest quality of life issues facing residents in Boston, if not the biggest, and it is important to look at ways to provide relief for residents" said Rep. Biele. "I am proud to support these bills which incentivize property owners to charge below market rents for private units by providing tax credits, provide financial relief to working families and veterans when it comes to housing costs, and protect elderly residents from being evicted from their homes without just cause."

## Senator Nick Collins Delivers

The reviews continue to come in that this year's St. Patrick's Day Breakfast was a successful debut by the new host, Senator Nick Collins.

n a prelude to the live event, the gathering was warmed up by emcee, Clerk Mike Donovan. He introduced the several speakers, who addressed the attendees with important messages. They included by Chief Marshal John Beatty, emphasizing respect for the traditions, Police Commissioner Will Gross, in his Irish brogue, emphasizing public safety and community (he also claims to be 2% Irish). Entertainment was provided by Bob Fowkes and Curragh's Fancy and by Celtic Classics, fiddlers Alanna and Julia Tryder, accompanied by Liam Hart on keyboard.

In a show of harmony, Senator Collins was introduced by his former colleague and predecessor host, former Senator Linda Dorcena Forry. Collins arrived to the tune of "If you're Irish come into the parlor there's a welcome there for you". Grace and the invocation were delivered by Bishop William Dickerson II of the Greater Love Tabernacle in Dorchester and Reverend Father Joe White, Our Lady of Good Voyage Parish. The national anthem of Ireland was sung by Cambridge Police Deputy Superintendent Pauline Wells and the United States national anthem was sung by parade chairman and Veteran, Brian Bishop.

The location of the event at the Raymond L. Flynn Cruiseport received rave reviews and those in attendance said it was the most comfortable they have ever felt at this event. Not surprisingly, the Mayor and former Ambassador himself along with his wife Cathy were beaming. The theme of history and the influence of immigrants over generations was underscored by the multicultural and multi-ethnic attendees from across the 1St Suffolk Senate District, as well as political leaders from around the Commonwealth, who joined their colleagues in government to enjoy the St. Patrick's and Evacuation Day festivities. A tribute to Irish immigrants was on display courtesy of John McColgan, the City of Boston Archivist and his staff.

With a raucous crowd already pumped up, Collins, admittedly not a comic, chose to regale the crowd with his rendition of Hamilton's



signature song, "You'll Be Back" directed at Governor Charlie Baker's presumed British roots. Although the Governor reminded folks that his mother, the late Elizabeth Ghormley, was solid Irish. .

Congressman Stephen Lynch, City Councilors Michael Flaherty, Ed Flynn and Frank Baker, as well as Rep. David Biele combined for entertaining song and political barbs. Also on the dais were Senate President Karen Spilka, Lt. Governor Karyn Polito, and Senator Edward Markey, Congresswoman Ayanna Pressley and City Council president Andrea Campbell. A host of colleagues from the Senate, House of Representatives and City Hall were also on hand.

One of two highlights was a personal video message from former Vice President Joe Biden recalling Collins support of his short-lived presidential run in 2007. He also warmly greeted Mayor Marty Walsh, Congressman Steven Lynch and others and wishing he was there. The other was the powerful tenor voice **continued on page 12**

ast Sunday, John McColgan and the Boston City Archives Team unveiled an enduring exhibit on Irish Immigrants in the City of Boston at the Annual St. Patrick's Day Breakfast. with the speed of light. It was first met with disbelief. Who would do such a thing was the question most asked? Then the anger and sadness set in, as residents made the trek to the beach to see for themselves what every Southie social media site had reported. People took photos and video and shared them with friends and family who then shared them as well. Nearly every major news media outlet in the city picked up on it and they, too, descended on the area to cover the story. The other big question is – WHY?

This past Monday morning residents woke to find the beautiful memorial covered in dark oil. The perpetrators got all the sections and even the benches and plaques surrounding it. It was deliberate, it was no accident. Residents who discovered it immediately called police and our local elected officials also quickly arrived on site. Residents, among them Rob Ryan, Bob Ferrara, Ned Morrissey and others, rushed down, as soon as they got the word, and all joined in and tried to remove the oil, but it was not to be; at least not yet.

It was a thick and greasy substance and it had already seeped into the granite and it was resisting every attempt to clean it with common household and even the industrial cleaner that people were using. Later in the day, equipment such as pressure washers and other machinery was brought in for the job, but still, little progress was being made because the oily substance was so deeply absorbed and resistant. Yet no one on site was willing to give up on the effort. They continued to work for hours in the cleaning attempt.

State Representative David Biele, on the seen for hours, worked in cooperation with State Senator Nick Collins contacting DCR and other state officials to get cleanup crews there as soon as possible. This was clearly a priority to everyone. Congressman Stephen Lynch and City Councilors Ed Flynn, a US Navy veteran himself and City Councilor Mike Flaherty were working as well to bring in resources. The Massachusetts State Police were combing the area looking for any hint or clue that might lead to the identity of who was responsible.

The next day, Tuesday, the effort continued. At 9am, there was a meeting at the location where again, cleanup crews, volunteers, elected officials, the original architect and designer Robert Shurer, state, city and private agencies and throngs of onlookers were set to get back to work. Even the news media returned to report on the progress. It was clear to all by now that it would take professionals with specific equipment to join in if the efforts were to be successful and they too were there.

But then another group arrived that warmed the hearts of everyone on the scene. The K-1 students from the Perry Elementary school and their teachers showed up, carrying and waving American Flags and together with all the adults who were there, recited the Pledge of Allegiance. The students then had a history lesson at the site and were told by their teachers how the people named on the memorial gave their lives to keep our country free. It was impressive and wonderful to watch.

The WW II memorial has been here for nearly 20 years. And though from time to time there has been minor damage caused to it, sometimes by severe weather conditions, other times by careless litterbugs, nothing could compare with what had happed to it last weekend. Getting the monument built took a lot of time, effort, money and a lot of love. A committee was formed by local residents. The efforts included fundraising, bringing in the best landscapers and taking bids from the most reputable designers and builders of such memorials and of course, the finest materials were used in the process to make sure it would and will stand the test of time.

As Tuesday progressed, calls by people from far and wide offering to help in any way they could were coming in. People from as far away as New Hampshire, Maine and even 2 people from Texas called to offer their expertise and support. This story has clearly touched a nerve, as well as people's hearts and souls.

Everyone wanted to lend a hand. Francisco Urena, Secretary of Veteran's Services was there as was Tom Butler from Massport, Tom Lyons, who has always been active and in command of veteran's issues, John 'Bubba' Maddox from the MBTA with news that the 'T' would be providing special coating for the monument's surface once it had been restored which would protect it from future vandalism. The 'T' might also consider covering all of South Boston's monuments with the same substance Maddox stated. One observer/volunteer stated that this is becoming almost like a joint effort with near military precision, which would be fitting. Former Mayor Ray Flynn was there helping as was Anthony Gilardi. There seemed to be no end to the folks turning out to help rectify the terrible wrong that had been done.

It was noted by many that the very weekend the monument was defaced, John Mullen, who served in the United States Marine Corps in WW II, part of that 'Greatest Generation', had passed away. John Mullen was very instrumental in getting the memorial built and helped oversee the entire process from start to finish. John, with the enormous help of then DCR commissioner David Balfour who pulled out all the stops on behalf of Southie's veterans, paved the way with permits and assisted with the planning. It's believed that John Mullen probably WWII Memorial continued on page 7





didn't know of what had happened before he passed. It would have greatly saddened him if he did.

Among the ideas being floated to head off any future attempts to vandalize this and our other war memorials are surveillance cameras and increased lighting. Though it's hoped that an attack like this will never again take place, it's always best to be prepared. Most people don't believe that this was a random act of vandalism, nor do some officials. It's thought to have been a targeted attack directed specifically, because of what the memorial stands for. The consensus all around the community seemed to be that those responsible must be dealt with and dealt with severely. If anyone has any information that might lead to the identities of the vandals who did this, they are asked to call the State Police at 617-740-7710.

This effort will be ongoing and it's a cooperative effort to be sure by those so hurt and angered by what happened. And as so often happens, no matter how bad an occurrence is, something positive can be found. In response to the outpouring of help and support that this incident brought out, State Representative David Biele put it perfectly when he stated the following" Whenever the darkness strikes, the light always rises up to meet it." The spirit of South Bostonians has once again confirmed those sentiments as so many good folks have come together for a common cause.

2018 A to Z wineworks Chardonnay, Oregon, (\$15.99). This Chardonnay radiates with a beautiful shine in the glass and notes of lemongrass, key lime, honey, pear and white peach. Deeper aromas of grapefruit, honeydew, pineapple and graham crackers come through and the broad palate is fresh with vibrant acidity exhibiting all the characteristics of a true cool climate wine with aromatics and flavors in perfect harmony. Modest in alcohol, the 2018 A to Z Chardonnay is a standout food-friendly wine, finishing in a round and generous manner. Shellfish, seafood and Tuscan wings on the grill all come to mind.

2017 Penfolds Koonunga Hills Chardonnay, Southwest Australia, (\$15.99), reflects Penfolds' multiregion, multi-vineyard blending policy, which enables winemakers to source the best parcels of fruit to produce consistently high-quality wines from each vintage. A light to medium bodied Chardonnay with distinctive primary fruit characters, sustained intensity and a subtle underlay of moderate oak. This wine has been produced since 1991 and though it's a relatively large production wine, it typically drinks longer than most; the producer says it will gain in quality through 2021. Might be a good addition to your Easter table.

#### Château de Tracy 2017 Pouilly-Fumé, Loire Valley, France,

(\$21.99), is a consistent winner and justifiably so. The vineyard of the fortress of Château de Tracy has been owned by the d'Assay family for 600 years; in French terms, they've settled in and probably will stay around. They've produced a rich, well-balanced wine with a strong herbal element as well as apple, citrus and spice. Still a young wine bursting with fruit, it will be better when it softens. Cheese and seafood dishes are naturals wit this one.


2017 Decoy Sonoma County Sauvignon Blanc, California, (\$19.99). Duckhorn Vineyards has been crafting Napa Valley Sauvignon Blanc since 1982 and while the 2017 vintage was very strong



for Sonoma County in general. Decoy's white wines are real standouts. This bright and aromatic wine offers enticing layers of lemon and lime zest, as well as lovely notes of honeydew and nectarine. On the palate, refreshing acidity mingles with a subtle undercurrent of sweet fruit that carries through to a refreshing, vibrant finish. It's lightness and balance make it a great choice for a wide range of foods, especially lamb and ham.

## Wallace's 'Final Confession' Gets TV Debut Sunday in Chicago





## **Evacuation Day Honored and Celebrated At The Dorchester Heights**

s impressive as the presence of political leaders, South Boston High School's ROTC color guard, Minuteman re-enactors and the straight-backed soldier playing taps, nothing compares to the image of weathered veterans and bright-eyed grammar school students standing with South Bostonians honoring history.

As the Minutemen fired three shots

into the air at Dorchester Heights, the tribute began on the 243th anniversary of Evacuation Day. The holiday, officially observed in Suffolk County, commemorates the withdrawal of British forces from Boston on March 17, 1776, in the early stages of the Revolutionary War. American troops had brought cannons from Fort Ticonderoga in New York to fortify Dorchester Heights, eventually causing the British to retreat.

South Boston Citizens Association President Thomas McGrath opened the ceremonies by thanking all of the volunteers who helped make the near month-long efforts by the community to keep the spirit of this holiday alive. s the Conor McGregor lovefest over yet?

Don't get me wrong, Mc-Gregor is as polarizing an individual as they come. There's no denying that. But sometimes the obsession with him is a little much. Mainly because he can sometimes be too much. And his act can get old, quick.

Cue the losers who will read that and say, "Oh yeah, Danny? I bet you wouldn't say that to his face!"

No [expletive].

What I would say to his face, though, is that he should take my advice and leave UFC for good and go straight to the WWE. That's right, I said it. McGregor should go to the WWE.

As I watched McGregor parade around Boston during St. Patrick's Day weekend, I couldn't help but wonder, "Would he be dropping the puck at the Bruins game, or would he be causing chaos at Sunday's parade had he beaten Khabib Nurmagomedov in his last UFC fight in October?"

Probably not. Why? Because his trip to Boston wasn't about promoting his next fight. It was about one thing and one thing only: promoting his "Proper Twelve" Irish whiskey brand. I'm sure he loves St. Patrick's Day. And what better place to celebrate St. Patrick's Day than right here in Boston? But it's not like this is the first St. Patrick's Day. Mc-Gregor saw a perfect opportunity to promote his whiskey brand — a brand that has a lot less to do with fighting than the last call at Murphy's Law on a Saturday night might lead you to believe.

McGregor is an entertainer. He always has been. And he continued to prove that last weekend before he was told to take a hard left on L Street and leave the parade because of the chaos he was creating on Broadway.

Again, he was promoting his whiskey brand. He used his fame to once again stir the pot of gold he's been carrying around for quite some time now. And it became more evident than ever before that the fight game is no longer his only priority.

There's a reason for that. McGregor — as over the top and obnoxious as I find him to be most of the time — is a very smart guy. He's not just polarizing. He's polarizing in a calculated manner. He knows when he can get a rise out of the

masses. He understands when he's moving the needle. And he takes that momentum and makes the most of it, arguably better than anyone in the history of sports and entertainment has ever done.

It's all led to an extremely successful brand. The McGregor brand, not the whiskey brand. I have no idea what the sales have been for "Proper Twelve."

The McGregor brand is still strong. But it's not as strong as it once was. How do I know that? Because had he not tapped out to Khabib, he wouldn't have been running around Boston all weekend promoting his whiskey brand. He probably would've been preparing to defend his lightweight championship against either Khabib in a rematch or against current No. 1 contender Tony Ferguson.

McGregor is not doing that, because he lost. In fact, if you take into account his loss to Floyd Mayweather in the boxing ring, McGregor has lost his last two fights, and has lost three of his last five.

It's safe to say that Mc-Gregor's next fight is a mustwin, if he wants to keep his mystique alive, and keep his fight brand strong. There's really only one place he can control that though. And it's in the WWE.

If you laugh at the thought of McGregor in professional wrestling, then you haven't been paying attention. At next month's WrestleMania 35 at a sold out MetLife Stadium, the co-main events involve two of the biggest names in UFC history: Ronda Rousey and Brock Lesnar.

Both Rousey and Lesnar hold the WWE's top championships. And Rousey might even close out WrestleMania in just her second year in the company, which is probably the top accomplishment in the business.

So it's not like the WWE is where UFC stars go to die. It's actually the complete opposite. It's where they go to strengthen their brand to prevent it from dying.

This past weekend, while Mc-Gregor paraded around Boston as a walking alcohol advertisement, one thing was clear.

He should give Vince McMahon a call as soon as possible.

# REPORT: BETTS REJECTED \$200 MILLION EXTENSION

midst reports of Mike Trout's \$430 million deal, Joel Sherman of the New York Post reported on Tuesday that Red Sox outfielder Mookie Betts has rejected several contract offers made by the Boston Red Sox over the last two years.

According to Sherman, a source said that Betts rejected an eight-year, \$200 million deal after the 2017 season. That would roughly come out to the same average annual value as Bryce Harper's 13-year, \$330 million deal.

Betts is under contract and arbitration eligible through the 2020 season. Now that Trout will no longer be part of that same free-agent class, all eyes will be on Betts after the 2020 season.

At 26 years old, Betts is a year younger than Trout and will be 28 years old if and when he hits free agency. Turning down a contract that's worth less than \$300 million at this point would seem like nothing more than common sense. In fact, any offer less than a total of \$300 million right now should seem like a slap in the face.

The Red Sox and Betts avoided arbitration this winter by agreeing to a one-year, \$20 million deal for 2019. If the reigning American League MVP puts together another MVP-caliber season in 2019, then he'll most likely make even more in arbitration next winter, before free agency begins the winter after that.

## PATRIOTS RE-Sign Ryan Allen

he Patriots and Ryan Allen have agreed to a one-year deal that will keep the 29-year-old punter in New England for the 2019 NFL season. Allen was a free agent, but the Patriots will keep him around for at least a seventh season, after first signing him as an undrafted free agent back in 2013.

Allen has spent six seasons in New England, and has put a total of 153 punts inside the 20-yard line in 96 games, with 34 touchbacks.

He was used five times in Super Bowl LIII, pinning three of those five punts inside the Los Angeles Rams' 10-yard line, in a 13-3 Patriots win.

In other cities, a move like this might not seem like such a big deal. But here in New England, holding onto a key piece of the special teams is something that can't be overlooked, considering how much stock Bill Belichick puts into "all phases of the game."

# TROUT SIGNS Largest deal In Sports History

Just when you thought Bryce Harper and Manny Machado were the biggest winners this offseason, Mike Trout goes and one-ups them both.

According to reports, Trout and the Los Angeles Angels have agreed to a 12-year, \$430 million extension. It is the largest contract in the history of professional sports.

The average annual salary comes out to \$36 million per year, which bests Zack Greinke's average annual salary of \$34 million per year.

Trout's deal is just the latest mega contract to be dished out by an MLB team in the last month.

Harper agreed to a 13-year, \$330 million deal with the Philadelphia Phillies a few weeks ago, and just before that, Machado signed a 10-year, \$300 million deal with the San Diego Padres.

Also, Colorado third baseman Nolan Arenado agreed to an eight-year, \$260 million contract at the end of February.

Trout, 27, would've been a free agent after the 2020 season. Instead, the Angels have ripped up the final two years of his previous deal and will now keep him in LA through the 2030 season.

The two-time American League MVP set career highs in OPS (1.088), on-base percentage (.460), and walks (122) during the 2018 season, in which he played 140 games. In eight years in the majors — all with the Angels — Trout has a career batting average of .307 and a career OPS of .990.

Trout has only played in three Postseason games — all in 2014 — going 1-for-12 with a solo home run and three walks, as his Angels got swept in the ALDS by the Kansas City Royals.
