Time for a REAL Plan to Clean up Methadone 'Mile'

ince the festering problem on what's known as 'Methadone Mile' came to a head several weeks back, there have been renewed discussions on what to do about it. Most Bostonians are familiar with this area and many South Bostonians find themselves having to travel through it to get to Boston Medical Center, to their jobs and to area colleges. The people who live in the area itself have been complaining about it for years and yet, it took the beating of a Suffolk County House of Correction officer to bring on a sweep of the area.

Yes, there are people along that strip who are in great need of help and the services the local clinic provides. A plan, a REAL plan should be in place by now to help those trying to break free, permanently, of their addiction get that help. There must be a bet-

ter way than just constantly dispensing daily doses of Methadone, which so often just prolongs the addiction. But along with those in legitimate need of treatment, who frequent Methadone Mile, there are criminals lurking about there to prey on them, Drug dealers are everywhere and along with the sight of people actually injecting themselves in broad daylight with these additive and deadly drugs are the dealers all too willing to keep selling it to those afflicted. This, along with the muggings, assaults and robberies that happen so often there, makes the area dangerous and almost off limits to people, who live there or need to pass through.

No American city should allow a place like 'Methadone Mile, where people are in fear for their safety, to continue to exist the way this location has.

It's time for real solutions to be put in place that actually solve the problem and clear up those streets. Nothing less than a permanent plan should be accepted by the people of Boston. No more quick fix, temporary Band-Aids should even be considered.



They are tax policy, transportation infrastructure, judicial appointments, social services and health, as well as higher education. These sources include a look ahead at the coming week in state government and summaries and analyses of the past week, re-caps of a range of state government activity, as well as links to other news.

Healey now finds herself at the center of the RMV storm

WGBH's Mike Deehan reports that the RMV Merit Rating Board could decide today to give the heave to the leader of the unit that failed to process thousands of alerts about dangerous drivers.

But perhaps the board should reprimand and/or fire itself? The Globe's Matt Stout reports that the obscure three-person panel, which apparently hasn't met in years, includes none other than Attorney General Maura Healey, who's previously been critical of the Baker administration's handling of the RMV records-keeping saga and scandal.

In other RMV news, from the Herald's Mary Markos: "Union president slams Charlie Baker for knownothing stance in RMV scandal." Specifically, the union is furious that a recent RMV audit actually named low-level state employees, reports SHNS's Chris Lisinski.

Suffolk Downs South? Developers to pitch casino and racetrack for Wareham

Boston's Suffolk Downs may have hosted its last race earlier this summer. But Chloe Shelford at Wareham Week reports that a Quincy-based development team plans to unveil a proposal for a casino and horse-racing complex in Wareham, with press events scheduled today in Quincy and Wareham. Notos Group LLC, a partnership led by developer Thomas O'Connell, is pitching the project.

The Globe's Jon Chesto and South Coast Today have more on the proposed project that's seeking to obtain what others have failed to obtain: A coveted gaming license in southeastern Massachusetts. SHNS's Colin Young (pay wall) reports that the proposal will require a legislative change to state law.

Meanwhile, MGM Springfield celebrates its first anniversary of glitz

Speaking of casinos in Massachusetts, Peter Goonan at MassLive reports that MGM Springfield officials are praising the first-year performance of their gambling mecca in downtown Springfield – despite the casino's failure to come close to its own monthly revenue projections. And, of course, there's the companywide staff reductions. Don't forget about them.

Warren apologizes yet again to Native Americans

She wouldn't be doing this if it wasn't still a problem, perhaps picked up in her own internal polling, to wit: U.S. Sen. Elizabeth Warren yesterday apologized yet again to Native Americans for her past claim of tribal ancestry, saying she was "sorry for the harm I have caused," as the AP's Elana Schor and Josh Funk at WGBH.

The Herald's Hillary Chabot writes that the latest apology is a sign that

Warren's ancestry claims aren't going away – and that President Trump and Republicans are already practicing their "Pocahontas" chants should the surging Warren win the Democratic nomination for president.

Loyalty tests: Markey-vs-Kennedy puts pressure on Dems to choose

As U.S. Rep. Joseph Kennedy III mulls whether to challenge U.S. Sen. Ed Markey next year, the state's senior senator, Elizabeth Warren, has released a video endorsing Markey, saying he has her "full support" as a "true progressive" in the Senate, reports Fausto Menard at WBUR.

So is this an early blow to Kennedy's nudge-Markey-out-of-the-way strategy? Yes, but Warren is also saying very nice things about Kennedy too, as she and other Dems walk a local endorsement tightrope, reports the Globe's Victoria McGrane and James Pindell.

Btw: There's plenty of speculative and counter-speculative reports out there about who might run for what in Massachusetts, depending on what Kennedy ultimately decides to do. Among other things, McGrane and Pindell report Attorney General Maura Healey's camp is shooting down the idea that Healey might be eyeing her continued on page 8

Residents, park users encouraged to take online survey and share ideas at 'Mini Common' neighborhood events

he Boston Parks and Recreation Department (BPRD), in partnership with the Friends of the Public Garden (the Friends), is collecting public input about the future of the Boston Common through an expansive public engagement process: on the Common, around the City, at open houses/public meetings, and via an online survey.

As America's first public park, Boston Common is one of the most treasured greenspaces in the world. The overarching goal of the new Master Plan is to create a Common that will serve all people of Boston and visitors while protecting this special place for decades to come.

BPRD and the Friends are hosting a series of Park Presence Days on the Common and around the City. A movable kiosk - playfully dubbed the 'Mini Common' - will allow the public to learn more about the master planning effort, provide feedback on the park today, and share ideas for the future. The first round of public outreach will be conducted:

"Boston Common has always been a park by and for the people of our city," said Boston Parks Commissioner Ryan Woods. "Thanks to the \$28 million Mayor Martin J. Walsh committed from the sale of the City's Winthrop Square garage, we are now able to augment the current historic levels of funding to fully renovate America's first public park while preserving its rich heritage. We now look forward to the input of residents, businesspeople, institutions, and park users to help shape this master plan as we map out the future of this historic meeting ground in the heart of Boston."

Led by Weston & Sampson, the consultant team has been studying the park and meeting with stakeholder groups since April 2019. The Boston Common Master Plan includes the development of a set of principles, goals and objectives to guide the work; an inventory of the park's existing conditions and resources; an assessment of current and future park needs; and the public engagement process that is underway. The final plan will define a strong, clear vision that will celebrate the history of place and craft a comprehensive revitalization strategy for this legacy public open space asset.

"This outreach process is designed to make sure that the Boston Common truly lives up to its reputation as 'the people's park' – accessible and welcoming to all, supporting a wide variety of uses that reflect the needs of the community today and into the future," said Liz Vizza, Executive Director of the Friends of the Public Garden. "We have a once-in-a-generation opportunity to create a bold plan that ensures this iconic public green space continues to thrive and fulfills the needs of the millions of people who enjoy it every year."


About the Boston Parks and Recreation Department

It's that time of the year when a wine lover's fancy turns to pinker things. While Provence is always at the top of many lists, there are a number of other regions that offer worthy alternatives.

It couldn't be farther from France's southern regions, but the latest country turning out some great rose wines is New Zealand. *Terra Sancta Estate Pinot Noir Rosé, Central Otago, New Zealand,* (\$25.99). It is no secret that today many of the world's best Pinot Noirs are coming out of Central Otago,

New Zealand. In addition to their red Pinot, Terra Sancta makes this gorgeous rosé. Far from an after-thought, the grapes for this rose are carefully selected from two individual blocks specifically for the rosé style. Delicate and perfumed, this wine screams summer. Try it with some broiled scallops or lollipop lamb chops.

Closer to home, Cep Vineyards Hopkins Ranch Rose, Russian River Valley, 2017, (\$23.99). Cep is the "second label" of the ultra-premium estate Peay VinCep is the "second label" of the ultra-premium estate Peay Vineyards. Super-drinkable, fresh, yet complex and balanced, this is one of our favorite summertime rosés. Rosewater, sweet orange, and watermelon flavors lead into a refreshingly dry finish. Produced in very small quantities so buy what you can get your hands on! This is certainly one of the best Rosé wines to buy right now. It's great with pesto pasta, Caesar salads, or just by itself. Definitely worth the effort of a hunt!

Principal Rose Tête de Cuvée, Biarrada, Portugal, (\$25.99), is one more example that Portuguese wine is more than just sweet, fortified port! It is time dry Portuguese wines get their due, and this rosé from the Bairrada region should help that cause. Made from the first-press juice of Pinot Noir grapes pressed in a Coquard Champagne press, this is not your typical cherry-hued rosé: the color is a pale salmon-beige and the food-friendly palate has a savory, saline streak. We are confident you will agree that this is one of the best rosé wines to buy right now. Great as an aperitif or with a wide variety of grilled foods.

Rounding things out, I'd like to recommend a wine from the Chinon region of the Loire Valley. In a sea of whites, this town produces reds of notable quality, primarily from Cabernet Franc. *Couly-Dutheil Chinon Rosé*, (\$19.99), is a savory and unique rose, reflecting its strong red heritage. As I said, Chinon is known for its red wines made from Cabernet Franc, of which Couly-Dutheil



also makes classic examples—but this rosé is a standout. All the qualities of Cab Franc—raspberries, herbs—with a hint of tannin and a strong minerality make this a unique and food-friendly rose.

I think these wines will take the heat away with a pleasant combination of style and structure-enjoy!

Ganiatsos, the Transportation Department's public information manager. With the help of the passes, students will be afforded the opportunity to visit museums, parks, historic sites, and other points of interest around Boston to further their educations beyond the classroom, she said. "Having an MBTA pass will ensure that transportation to and from these venues will not be an obstacle for Boston's young people," said Ganiatsos.

City leaders have expressed concern about how students relying on the MBTA will get to school this fall. "I think this is a great

option for our kids. It just needs to work for them," said Boston City Councilor at-large Annissa Essaibi-George. This year, Boston Public Schools announced it would be providing free T passes to 10,000 more kids in the district, adding to the 20,000 who already utilize the service. But if delays persist, tardiness could become an issue. "My own boys take the T to school and tardiness is a huge problem at many of our schools," Essaibi-George said. "Kids are traveling a great distance to get to and from school every day, and we need to make sure we have systems in place that support that effort."

In response, however, the MBTA has said it is focused on repairing and improving their lines. "That's exactly why the MBTA is in the midst of an aggressive \$8 billion capital investment program. Each and every week, work crews are making significant improvements to transit infrastructure such as tracks, signals and power systems," said MBTA spokesman Joe Pesaturo. Teachers and students have said the access to free transit is crucial to their everyday lives, allowing them to get to school, work and extracurricular activities.

"The fact that the T isn't up to

snuff is not a problem with giving kids passes, it's a problem with how the T is funded by the state," said Russell Weiss-Irwin, a teacher with Boston Public Schools told NBC Boston.

Despite the issues, teachers and city leaders remain optimistic about the upcoming year. They expect many of the 10,000 students who just received free passes to have a minimal impact, as some already take the T and pay for it or utilize other sources of transportation. Councilor Essaibi-George says she's hopeful that September and the beginning of the school year is a positive one for BPS kids.

murals, hand painted furniture, refinishing, and more.



ntonio Brown has really stolen the NFL preseason spotlight. Between his frostbitten feet and his desire to keep using his old — and now illegal — helmet, Brown has created a circus at Oakland Raiders training camp. And we are taking the bait, all over the country.

Brown's issues aren't just a Raiders issue. We all want to know what's happening with him. And of course we do. Because we get to watch it all play out every Tuesday night on HBO, in the annual behind-the-scenes NFL series "Hard Knocks."

Consider this a free advertisement for HBO. Tuesday nights at 10 p.m. ET, you can watch Brown and his agent Drew Rosenhaus act like absolute clowns. They'll have you guessing what's next. Will Brown show up? Are his feet OK? Did he find a helmet he'll actually consider wearing? And what does head coach Jon Gruden think about this?

All the drama of Brown's current situation makes for perfect reality TV. It's the NFL's version of "The Real World" mixed with "Survivor" mixed with "Keeping up with the Kardashians."

It's absolute garbage, but we can't stop watching.

Brown's little circus is exactly what HBO needed for this season of "Hard Knocks: Training Camp with the Oakland Raiders." Because let's face it, with this being the 14th season of the series, perhaps we've seen it all.

HBO needs to somehow keep it fresh, keep it different. In other words, HBO needs drama.

Well, they have received just that in Brown's first training camp with Oakland.

Brown, 31, is one of the NFL's elite wide receivers. He forced his way out of Pittsburgh after spending the first nine years of his career as a Steeler. The Raiders acquired Brown in a trade back in March, sending a third-round pick and a fifth-round pick to Pittsburgh in return. Brown also signed a new contract with Oakland, agreeing to a three-year, \$54 million deal, with \$30 million guaranteed.

That's \$30 million more guaranteed money than he had in his previous contract with the Steelers, which still had three years left on it before the trade. With no guaranteed money left in Pittsburgh, Brown forced his way out, to a place that would rip up that deal and give him something guaranteed, which Oakland did.

Now that he's a Raider, and now that he has his guaranteed money, everything's good, right? Wrong. At least, that's the perception from the outside. Because, from the outside, all we see is Brown still recovering from frostbite on the bot-

toms of his feet caused by a cryotherapy chamber, and he's refusing to wear a new helmet, which is an NFL rule that the new helmets are now in full effect in 2019.

As we've seen on "Hard Knocks," Brown has left training camp multiple times already, because of what he and his agent are calling a disagreement with the league's new helmet rules.

Brown wants to wear his old helmet. This news isn't just on "Hard Knocks." It's also being reported by the national media. Those national-media reports are then being shown on "Hard Knocks" to build up the drama. And the circus becomes one big cluster-bleep of ridiculous nonsense.

But again, this is what HBO wants. And it's not just what HBO wants. It's what HBO needs.

Which might actually bring us to the main cause of Brown's "problems." I put "problems" in quotations because perhaps they're not really problems at all. That's why you see Gruden continue to embrace it all.

Do you think Bill Belichick would still have Brown on the Patriots if he missed multiple practices because he didn't want to wear a certain helmet? Nah. Brown would've been cut by the Pats two weeks ago, and Belichick would've never looked back.

Then again, Belichick will probably

never agree to let the HBO cameras in for a series of "Hard Knocks: Training Camp with the New England Patriots."

So what am I saying here? I'm saying that Brown is giving HBO the perfect recipe for a reality TV series that could easily go stale, considering it covers the same exact thing every August, just with a different team. By now, we understand what goes on behind-the-scenes at camp. The only way to keep it interesting is to mix in unique personalities every year.

So I posted a poll on my Twitter account: "How much is HBO paying Anto-

"How much is HBO paying Antonio Brown (under the table) for extra #HardKnocks entertainment?"

The options I gave were \$500K, \$1 million, \$3 million, or \$5 million-plus.

And "\$1 million" was the most popular answer, getting 33 percent of the vote, with "\$5 million" getting 27 percent, "\$500K" getting 21 percent, and "\$3 million" getting 19 percent.

My point is that Brown isn't just working for the Oakland Raiders. He's now also working for HBO. That's just my opinion. But it's the only thing that makes sense.

Good for him.

GORDON REINSTATED BY NFL, PLACED ON NON-FOOTBALL INJURY LIST

ast Friday, NFL support him to Commissioner Roger possible. But edged, ultimate reinstated New England Patriots wide receiver Josh Gordon, on a conditional basis.

Gordon was suspended indefinitely in December for once again violating the league's substance-abuse policy. Upon this reinstatement, Gordon is once again allowed to participate in team activities, including practice. However, he will not be allowed to play in the Patriots' third preseason game against the Carolina Panthers, due to insufficient conditioning and practice time.

In a statement over the weekend, Goodell said, "We are all rooting for Josh to succeed, both personally and professionally. Everyone shares in that hope and will continue to support him to every extent possible. But as Josh acknowledged, ultimately his success is up to him."

Patriots coach Bill Belichick also released a statement on Gordon's reinstatement, saying, "For the past eight months, Josh's situation has been entirely a league matter. When Josh returns to our program, we will evaluate the entire situation and do what we feel is best for Josh and the team."

Gordon has been placed on the Patriots' non-football injury list, which is similar to the preseason PUP list in that he can be removed from this list at any time before Aug. 31. If Gordon remains on that list after Aug. 31, then he must miss the first six weeks of the regular season.

SALE SHUT DOWN FOR REGULAR SEASON AFTER ELBOW INJECTION

B oston Red Sox ace Chris Sale has been shut down from throwing and will be re-evaluated in six weeks, according to a statement from president of baseball operations Dave Dombrowski on Monday.

That re-evaluation will be done by Dr. James Andrews, who Sale flew down to Florida to see after being placed on the 10-day injured list over the weekend with left elbow inflammation. The good news is that Sale does not need Tommy John surgery, not yet at least. Instead, Dr. Andrews treat-

ed Sale's elbow with an injection.

Dombrowski's statement read, "Sale was evaluated by Dr. James Andrews [Monday] morning in Pensacola, Florida. Dr. Andrews confirmed that Sale has inflammation in his left elbow and treated it with a platelet-rich plasma injection. Dr. Andrews also recommended a period of shutdown from throwing. Sale will be re-evaluated in six weeks by Dr. Andrews."

Barring a miraculous month of September to sneak into the American League Wild Card game, it would seem that Sale's 2019 season is over. The Red Sox play their final game of the regular season on Sept. 29.

EDELMAN, THOMAS REMOVED FROM PUP LIST

Just days after news of Josh Gordon's reinstatement, the New England Patriots got some more good news, as two more wide receivers returned to the practice field.

Julian Edelman and Demaryius Thomas were both taken off the preseason "physically unable to perform" (PUP) list earlier this week. Edelman returned to practice on Monday, while Thomas was back on the field with the team on Tuesday.

Edelman had been out for all of training camp with a broken left thumb. Thomas had been recovering from a second torn Achilles that he suffered last season.

The Patriots play their third preseason game this Thursday night at home against the Carolina Panthers. Their fourth preseason game is next Thursday, Aug. 29 at home against the New York Giants.
