



bors; particularly parents, lament about how the absence of discipline in some public schools is leading to problems which can sometimes lead to violence. # Down the road: A 'tax-like' carbon pricing plan for motorists

This is a big deal, for sooner or later this or a similar plan will likely become law one day. From Andy Metzger at CommonWealth magazine: "Officials from Massachusetts and Maryland on Tuesday laid out in broad strokes their plans for a forthcoming program across the East Coast to reduce harmful tailpipe emissions and fund greener transportation alternatives by pricing the carbon contained in gas and diesel fuels. The proposal would mimic a gasoline tax from the perspective of consumers, but it is distinct from a traditional tax in a few ways,

as a Baker administration official noted on Tuesday." Tanner Stening at MassLive has more on the very tentative Transportation Climate Initiative plan.

## Hey, look: The 6.25% sales tax on all online purchases also took effect yesterday

Speaking of tax (or "tax-like") moves: The new family-leave payroll tax took effect yesterday, as numerous media outlets have already reported. But Tim Jones at MassLive also reports that, as of yesterday, all online purchases are now subject to the state's 6.25 percent sales tax. Meanwhile, the Globe's Jon Chesto

reports that the "accelerated sales tax collection" issue isn't going away on Beacon Hill, thanks to those pushing a new technology they say will allow retailers to pay sales taxes on the same day purchases are made.

## Rock 'em sock 'em politics: Zuckerberg vs Warren

First it was Wall Street plutocrats bellyaching about the prospect of Elizabeth Warren becoming president. Now Facebook's Mark Zuckerberg is bellyaching about Warren becoming president – and he's vowing to fight any antitrust move by Warren if she ever ends up in the White House. Warren,

who loves it when her political enemies rear their heads, is gleefully firing back. The NYT has the details. Btw: Aha! The Washington Post discovers that Warren doesn't have a plan for something, i.e. K-12 education.

# SENATOR COLLINS CALLS FOR 24/7 ACCESS TO LIFE-SAVING SECTION 35 COURT PROCESS

Legislation Would Remove Barriers to Addiction Intervention



tate Senator Nick Collins testified last week on a piece of legislation, S.866, An Act Relative to Saving Lives, designed to save lives by amending Section 35 to allow for those suffering from addiction to be committed to a public health facility by a justice of the court even though the court may be closed for business.

As it stands, individuals who are suffering from a substance use disorder who present a likelihood of serious harm can be involuntarily committed for treatment for up to 90 days, pending a petition from a police officer, physician, spouse, blood relative, guardian, or court official, and a court hearing. However, that process is only available when the court is open for business, eight hours a day, five days a week. That means that for 75% of the hours in a week, this life saving intervention is not available.

"As the opioid abuse epidemic continues to affect individuals and families from all corners of the State, it is imperative that we are exploring all options to save lives and get people on the road to recovery" said State Senator Nick Collins. "Addiction does not care what time of day it is, or what day of the week it is. Our intervention options and treatment services should never be closed for business. It is a matter of life and death."

This language of this bill was previously passed in the Massachusetts State Senate by a vote of 33-4 as part of a 2018 debate on substance abuse. The Joint Committee on the Judiciary will now consider the issue.

# REP. BIELE SUPPORTS BILL EXPANDING COVERAGE FOR TREATMENT AND RECOVERY SERVICES



Recently, State Representative David Biele supported legislation before the Joint Committee on Mental Health and Substance Use and Re-

covery that would expand insurance coverage for treatment and recovery services.

The bill, H.1732, An Act providing access to full spectrum of addiction treatment services, would require insurance companies to cover at least thirty days of treatment, including a full range of recovery services.

Under the bill, coverage would include detoxification services. The bill would also require coverage for clinical stabilization services for post-detoxification treatment, as well as transitional support services, such as structured residential treatment programs.

"Recovery works when individuals have access to the full range of treatment services, from detoxification services to structured recovery programs," said Rep. Biele. "Unfortunately, inadequate insurance coverage can be an obstacle to meaningful recovery. This bill would begin to address that situation by requiring minimum insurance coverage of the full array of recovery services for individuals and families."

The bill had a public hearing at the State House and is now being evaluated by the Joint Committee.

## Councilors Campbell, Flynn To Hold Hearing On Domestic Violence And Sexual Assault



Boston City Council President Andrea Campbell & Councilor Ed Flynn have scheduled a hearing on domestic violence and sexual assault in the City of Boston. The hearing will take place on Monday, October 28th at 5:30pm at Northeastern University, during the final week of National Domestic Violence



Awareness Month. The Councilors called attention to data compiled by Jane Doe Inc., the Massachusetts Department of Public Health, and the 2010 National Intimate Partner Survey that indicated Massachusetts is on par with national averages.

The hearing will look to discuss ways to provide support for victims, solutions for increasing

reporting opportunities for all, such as our immigrant and LGBTQ communities, as well as other ways to educate the public about the prevalence of this abhorrent behavior in an effort to reduce domestic violence and sexual assault in the City of Boston.

Council President Campbell said, "October is National Domestic Violence Awareness Month, and so this is an opportune time to bring together our health commission, law enforcement, survivors of domestic violence and sexual assault, as well as organizations that work with them to discuss what more the City of Boston could do to address these issues. We want to learn about what others are doing across the country to make these incidents easier to report, and how we can make it easier for survivors to access support and services in the City of Boston. We are proud to be holding this hearing in partnership with the Northeastern University School of Law's Domestic Violence Institute, which provides support and legal assistance to survivors and organizations addressing domestic violence and sexual assault."

Councilor Flynn said, "Council President Campbell and I look to have this conversation to ensure we are doing all we can to try to increase awareness, support victims, offer reporting opportunities for all our communities, and hopefully find ways to reduce domestic violence and sexual assault in the City of Boston. I would like to continue the work of my mother, Kathy Flynn, who sought to support victims of domestic violence during her time as First Lady of Boston."

Margo Lindauer, Director of the Domestic Violence Institute said, "I am thrilled to work in partnership with President Campbell and Councilor Flynn to bring awareness to the prevalence and challenges survivors face as they seek justice, and to join with Northeastern's Center for Health Policy and Law to bring this conversation to Northeastern Law School. This is a great example of our institutions working in partnership with local government to move an issue forward, and I hope this is just the beginning of a longer conversation with many different stakeholders and survivors in our city."

# BOSTON'S HOUSING PLAN HAS CROSSED THE 30,000 UNIT MARK



Administration's commitment to creating more housing at all income levels to meet the needs of a growing city, Mayor Martin J. Walsh announced that Boston has surpassed 30,000 units permitted under the administration's housing plan, Housing a Changing City: Boston 2030. This includes more than 6,000 income-restricted units, or 20 percent of the total new housing, which is set aside for residents who have qualifying incomes.

This is a significant milestone reached in the work to create 69,000 new units of housing by the year 2030, as called for in the City's housing plan. In addition, the administration announced that rental listing prices are stabilizing across the board, based on analysis over the last 18 months.

"Boston's working families are the backbone of our city, and helped build Boston into the diverse, welcoming city we are today," said Mayor Walsh. "In Boston, we're growing faster than any time in the last 50 years, and it's important that our housing production keeps pace to support

our middle class. My priority is to ensure everyone can stay in the neighborhoods they love, and continue to call Boston home. I'm proud of the progress we've made and the milestones we've reached, which reflects a lot of hard work and strong partnerships in the housing community. We'll continue to work together with our partners to add affordable housing, and make Boston a place for all."

Boston continues to lead in creating affordable housing, with one in five units of Boston's total housing stock and one in four of its rental housing stock made up of deed-restricted affordable units. Of those deed-restricted units, nearly half are affordable to families making less than 60 percent of Area Median Income (AMI), or a household income of approximately \$57,000 for two people, or \$64,000 for a family of three.

Out of 21 municipalities, from 2011 to 2018, 62 percent of all units permitted were in Boston. For comparison, in that same time period, the City of Cambridge permitted one unit for every 7 units that Boston permitted. Another 22 percent of the permitted units were from five neighboring municipalities: Cambridge, Watertown, Everett, Chelsea and Somerville. Five cities, plus Boston, accounted for 84 percent of all units permitted during those seven years.

"For Greater Boston employers to continue to be able to attract and retain a talented workforce, it is critical that we support the creation of affordable and accessible housing options," said James E. Rooney, President and CEO of the Greater Boston Chamber of Commerce. "I applaud the Walsh Administration for the significant progress that has been made to create a range of new housing opportunities and to maintain Boston's competitive edge. The Chamber and our members look forward to continued partnership with the administration and leaders throughout the region to achieve Mayor Walsh's ambitious housing goals."

Of Boston's total 30,442 permitted

units, more than half were for projects outside of Boston's downtown core. Recent permits data show that 81 percent of the permits pulled so far in 2019 are for projects in Boston's neighborhoods outside the downtown core. One in four of the total 30,442 permitted units represent homeownership opportunities, with a little more than half of those being one bedroom or smaller, and the other half being two-bedroom units or larger. When completed, the 30,442 new units are expected to accommodate more than 60,534 residents.

The City of Boston continues to focus on building transit-oriented housing units. Of the permitted units, nearly two out of three are highly transit accessible and within ¼ mile or a five minute walk to major transit, and three out of four units are within ½ mile or a 10 minute walk from a T stop or commuter rail.

In addition, Boston's strategy of increasing our overall supply of housing units is beginning to show a stabilizing effect on the housing market. Year over year rental listing data from 2017 and 2018 in Boston shows rents increasing by 2.7 percent in older housing stock, and 3.3 percent in all housing, including newly built stock.

Boston has been trending away from large year-over-year increases in rent costs for several quarters as development catches up with demand, creating more rental opportunities across the City. This trend is continuing in 2019: a year over year comparison of the first two quarters in 2018 and 2019 show rent prices incrementally increasing by 1.7 percent in older housing stock, with a 1.5 percent increase in all housing stock.

To accomplish the goals set out in our housing plan, the City of Boston has secured funding to build affordable housing by utilizing a range of tools, including leveraging market-rate development, collecting Linkage and Inclusionary Development Policy (IDP) payments from real estate developers, supporting passage of the Community Preservation Act (CPA) to generate approximately \$20 million per year, and

successfully applying for funding rounds to acquire additional financial support. The City has invested more than \$164 million in funding to create the subsidized housing units in cooperation with the state and other housing entities. To find suitable space for new development, the City has also made three million square feet of real estate available.

Included in the 69,000 new units called for in the city's housing plan,15,820 will be incomerestricted units, elevating Boston's total income-restricted inventory to 70,000, which maintains Boston's current one in five ratio of deed-restricted affordable housing to all housing units in Boston. In addition, the plan sets a goal to preserve 85 percent of Boston's most at-risk privately-owned affordable units, and purchase 1,000 units of rental housing stock from the speculative market for perpetuity.



hile Australia is a vast continent, the wine-producing regions represent only a few small areas in the country's southern half. For those who aren't familiar with a region called the Margaret River, you're in for a treat; for those who are, it's always a good time to catch up on what's

The region itself is small but surprisingly diverse in terms of microclimates; their variety is responsible for the range of wine types produced and the consistent quality of all of

current and exceptional.

them. Situated on the Indian Ocean in Western Australia, the nightly ocean mist has the same effect on grapes in this area that the Pacific has on California and Chilean grapes.

Leeuwin Estates, 2016 Prelude Vineyards Cabernet Sauvignon, (\$31.99), is an example of what makes the Cabs from this region so outstanding. Big and rounded, this Cab has beautiful aromas of dark cherries, leather, vanilla and blackcurrant. The wine is soft, with a long finish that goes really well with steaks, lamb and game birds. The Prelude Vineyards label focuses on the benchmark varietals of the region and represent the first release of Cabernet Sauvignon from Leeuwin Estate each vintage. They are site expressive wines that display the purity and clarity of fruit with a style that is readily expressive for earlier release.

Lenton Brae Vineyards was established in 1982 and is a small family owned and operated Margaret River wine producer. While they excel in the Margaret River specialities of blended Semillon Sauvignon Blanc and Chardonnay, their best wines

by far are their Cabs and Cab/Merlot blends. Their 2017 Lenton Brae Cabernet Merlot, (\$34.99), displays fruit cake and spice - like floral notes of Petit Verdot. On the palate, the structure and tannin of Cabernet Sauvignon compliments the mid palate sweetness and fleshy mouthfeel of the Merlot grape. Dark fruit, cedar and tobacco, floral perfume. It's medium-bodied, kind of light, but dense too, with savoury tobacco and cool blue and black fruit, something of a briary taste and feel, well packed tannin, and a fine long finish. Such sophistication at a very fair price. Recommended, especially for the claret fans out there.

The Voyager Estate is a longstanding favorite winery among tourists, wine lovers, and local residents. The winery has a tasting cellar that features their award winning Margaret River varietals of Cabernet Sauvignon and Chardonnay, daily free wine tasting for those willing to stand at a counter, a private wine tasting room for a small fee, a kitchen garden, and an abundance of red and white roses that accent each row of vines. Their *Voyager Estate 2016 Shiraz, Margaret River, (\$32.99)*, reminded me more of an elegant Cotes du Rhone than a Shiraz. It's a vibrant wine with great complexity and purity of fruit, yet still retaining the finesse and elegance which are the hallmarks of the Voyager Estate style. It displays floral aromatics with vibrant blackberry and mulberry notes and hints of earth and spice, the wine is medium bodied, finishing with a nice savoury line.

The other wine from this estate that you really have to try is the 2018 Chenin Blanc, (\$21.99). It displays flavours of vibrant tropical fruits with underlying citrus and nuances of red apples. Whilst lightbodied, some weight and a creamy, textural element are derived from a small portion of barrel fermentation. The wine finishes with a perfect balance of sweetness and acidity. I'm really partial to this varietal any time of the year and I think you will be, too. Try it with mildly spiced Asian dishes or fresh seafood dishes; this Chenin Blanc is also well-paired with vegetarian dishes.

# I Was Just Thinking...

uring the past three years there have been more leaks emanating from our intelligence community about President Donald Trump than from broken faucets in abandoned tenement buildings. It's a disgrace our president can't have confidential calls with other foreign leaders without the details being made public by so-called patriots who think they're doing the right thing for America. In October of 1962, the world was on the brink of nuclear Armageddon when the United States confronted the former Soviet Union (USSR) and established a naval blockade on October 22, 1962, to prevent further Soviet missiles from reaching Fidel Castro's Cuba. When the offensive missiles and Ilyushin II-28 light bombers had been withdrawn from Cuba, the US blockade was formally ended on November 21, 1962.

As a result of this, and necessitating timely, clear and direct lines of communication between Moscow and Washington, the Moscow-Washington hotline was established which resulted in a series of subsequent agreements that reduced US-Soviet tension for several years.

The whole Soviet-American Cold War gambit in which both sides were culpable of many misdeeds on the world stage is obviously much more complicated and lengthy to discuss in this piece. But could you imagine if any of these Cubanmissile crisis talks had been released to the American public and press or to hardline Soviet government officials at that time? The hardliners in the Soviet Union weren't pleased with Khrushchev's decision to pull out of Cuba and if the talks were leaked it's more than likely they would have removed him from power (which they did in 1964) at that precise moment in time. And

if they did remove Khrushchev at that time (because of any leaks hypothetically speaking) nuclear war may have ensued catastrophically changing the course of history.

Our president who is the commander-in-chief of this nation must be able to talk with foreign leaders without worrying about his foreign-policy conversations being leaked by political adversaries. Although (they attempt to) justify these leaks as a matter of national security, it's not true. In simple terms they just don't like Trump, actually can't stand him one bit.

they were at least a year away from any renovations and that a community engagement process will be conducted that will include a design and planning review committee that those in attendance hoped would include residents and patrons. Design Labs is the contract architect and its main objectives will include preserving the façade, bringing the facility up to code relative to access for persons with disabilities, sprinkler system, state of the art mechanicals and surveillance and monitoring for public safety. The question remained as to whether there would be a complete shutdown of the facility for its full renovation or be phased in in sections.


The renovations would be a full gutting of the interior space with new showers, locker room and training rooms. The restoration would preserve its iconic construction as built in the James Michael Curley era in whose name it is memorialized. Some even consider it historic, although, according to Mr. Brophy, that kind of designation process would take a lot of time and may not even result in a designation.


Elected and other officials included Congressman Stephen Lynch, who is an active user of the gym facilities, City Councilors Mike Flaherty and Ed Flynn and BCYF Commissioner William Morales. Andrea Flaherty, the Center's Executive Director, was also on hand.

Ms. Flaherty assured folks that it would continue to be a Senior-Friendly Center and that the vision will ensure that the family beach and kids play areas would be greatly improved. Popular programs and traditional services and aspects of the center such as the solarium, handball courts, steam and sauna, boxing and separate areas for men and women are expected to be in the mix. Patrons from around the City are frequent users and on weekends the beach goers find it a convenient amenity and they may be targeted for membership recruitment.

Concern was also expressed about any increase in the cost of membership when completed. Folks don't want this jewel of the Parks System to be another costly fee for residents who pay high taxes already.

Brophy assured the attendees that this was the first of many meetings planned over the next year. Of all of the projects underway in South Boston, this one has a host of promising community benefits to be looking forward to.



A former state representative, Mr. Brett has been an outspoken advocate for people with intellectual disabilities over the course of his career. Most recently, he was reappointed to

the National Council on Disability by Speaker Nancy Pelosi and serves as the Chairman of the Governor's commission on Intellectual Disability. He previously served on the President's Commission for People with Intellectual Disabilities under Presidents Bill Clinton, George W. Bush, and Barack Obama.

Mr. Brett has served as the President & CEO of the New England Council, a non-partisan business organization representing businesses throughout the six New England states, since 1996. Prior to joining the Council, he served in the Massachusetts House of Representatives for over 15 years. Throughout his career, Mr. Brett has been a tireless advocate for people with

intellectual disabilities. In 2018 he was awarded the Michael and Kitty Dukakis Lifetime Achievement Award from the Massachusetts Association for Mental Health. In 2014 he was inducted into the Special Olympics Massachusetts Hall of Fame. The Disability Law Center bestowed upon him the Edward M. Kennedy Leadership Award. In 2013, the University of Massachusetts Boston established the James T. Brett Chair in Disability and Workforce Development, the nation's only endowed chair in disability and workforce development. Bay Cove Human Services of Boston named a new community home for adults with disabilities "Brett House" in his honor.

## **RED SOX LOOKING TO CUT** PAYROLL IN 2020, BETTS' **FUTURE IN OUESTION**

here will be a new World Series champion this year. The reigning champion Boston Red Sox are on the outside looking in at the 2019 MLB Postseason. And now, an interesting, yet somewhat cloudy offseason looms.

Not only will the Red Sox be looking to replace recently-fired post in our budgeting, as we build president of baseball operations Dave Dombrowski, but they'll also be giving that new general manager a complicated laundry list.

First thing on ownership's agenda is shedding salary to get under the \$208 million luxury tax threshold. That much has been said over the past week by principal owner John Henry, chairman Tom Werner, and president and CEO Sam Kennedy.

If the Red Sox go over the luxury tax threshold for a third consecutive season in 2020, their tax rate would increase to 50 percent, and they would also face hefty surcharges.

"We need to be under the CBT [Competitive Balance Tax]," said Henry last Friday at Fenway. "That was something we've known for more than a year now."

Knowing that, Henry still allowed Dombrowski to give \$68 million to Nathan Eovaldi in December, \$145 million to Chris Sale in March, and \$120 million to Xander Bogaerts in April. All while also knowing that Mookie Betts will be entering the final year of his contract in 2020.

In a press conference at Fenway Park earlier this week, Kennedy stressed that getting under the luxury tax threshold was a "goal" but not necessarily a "mandate."

"The CBT is always a guideour financial plans for the following season," said Kennedy. "We use CBT as one guidepost. It's something we consider.

"John and Tom have shown a willingness — I believe in the past 17 years, we've been over that CBT threshold 10 times," added Kennedy. "And we will continue to demonstrate a willingness to go over. That said, John made it clear that there is a goal to try and get under the CBT in 2020. But he also said -Tom followed up and clarifiedthat is a goal, but not a mandate."

As for Betts' future in Boston, the Red Sox are on the record saying they want him to stay. But considering the enormous contract that the reigning American

League MVP will be looking for after next season, the team's plan to shed salary this offseason certainly does not coincide with a plan to sign Betts to a big-money deal.

Betts turns 27 this month. He's arbitration eligible one last time this winter, and is projected to make at least \$25 million next season. If the Red Sox can't shed payroll in other spots, then 2020 could be Betts' final season in Boston. Or, perhaps the Red Sox could trade Betts this winter if they don't think there's any chance of giving him the type of money he wants.

It remains to be seen what will happen next. But now that we know what the Red Sox' financial strategy will be, it seems the rumors surrounding Betts' future have only just begun.

## PATRIOTS ADD WATSON. LOOK TO REDISCOVER OFFENSE IN D.C.

atriots tight end Ben Watson is eligible to return to the team this week, after serving a fourgame PED suspension to begin the season.

The Patriots waived offensive lineman Caleb Benenoch earlier this week, presumably to open up a roster spot for Watson. They also released injured wide receiver Cameron Meredith, who was on the "physically unable to perform" list.

Watson's presence will be welcomed, as the Patriots offense is coming off an ugly performance in a 16-10 win over the Bills in Buffalo on Sunday. The only Patriots touchdown in the win came on a Brandon Bolden four-yard run. Tom Brady finished the game 18-of-39 for just 150 yards and an interception.

Watson, 38, signed with the Patriots in May. He had two touchdowns and made 35 catches in 16 games with the New Orleans Saints last season. Watson was originally drafted by the Patriots in the first round of the 2004 NFL Draft (32 overall) and spent six seasons in New England. Since, he has played for the Cleveland Browns, Baltimore Ravens, and the Saints.

"Fortunately, Ben has a lot of experience in our system and has been with us all through the spring and training camp," said Bill Belichick in a conference call on Tuesday. "So hopefully he'll be able to recall what he did and the things that are new."

The Patriots are a 15-point favorite in Washington on Sunday at 1 p.m. Washington is 0-4 and is coming off a loss to the New York Giants in Week 4. In the first three weeks of the season, Washington allowed at least 30 points in all three games, which were losses to Philadelphia, Dallas, and Chicago.
