


At Large Councilor Michael Flaherty Re-Elected; Ed Flynn Elected Unopposed



ith almost 67,000 votes cast on Election Day, and the Boston daily newspapers touting the emergence of women of color and the changing demographics of Boston, Councilor Michael Flaherty was reelected as City Councilor at Large. As expected, Michelle Wu topped the ticket with Flaherty finishing third, 800 votes behind Annissa Essaibi-George.

Julia Mejia, of Latin descent, per the city's unofficial results, was the fourth-highest vote-getter with 22,464 - just 10 votes more than fellow challenger Alejandra St. Guillen in fifth. St. Guillen initially conceded but quickly called for a recount after midnight as the final tally came in. Mejia had declared victory hours earlier, jubilantly telling a happy crowd of supporters in Jamaica Plain, "We set out to change the game to make sure the people who were most impacted were front and center in this conversation." But after St. Guillen's announcement, Mejia said she still believed she won, adding, "I'm still confident." The winner between the two will be the first Latina to serve on the council. Either way, that means incumbent Garrison is out following a year in office, a position she took as the first runnerup in the 2017 election following Ayanna Pressley's departure for Congress. Garrison finished second to last, her 16,161 votes also behind challenger Erin Murphy's 16,843 and only ahead of newcomer David Halbert's 13,201.

In District 2, Ed Flynn cruised with no opposition. In the contested District Council races in Hyde Park, Back Bay and Allston-Brighton, three seats were open due to the fact that district councilors Tim McCarthy, Josh Zakim and Mark Ciommo each chose not to seek re-election. CONTINUED ON page 10



Election results: The changing of the guard in Boston

It was an historic election night in Boston, with progressive, female and minority candidates taking charge of the city council. As Benjamin Swasey and Simón Ríos report at WBUR: "With Tuesday's results, seven of the 13 councilors will be people of color. Boston is a majority-minority city. Eight of the 13 will be women." The latter marks the first female-majority council in Boston history.

The Globe's Milton Valencia reports that the race for the fourth at-large council seat has been tentatively and very narrowly won by political newcomer Julia Mejia – but Alejandra St. Guillen is calling for a recount. Here are all the city election results, via the Globe. In other council coverage, from the Herald's Sean Philip Cotter and Erin Tiernan: "Michelle Wu again was the city's top vote-getter and Althea Garrison is out as Boston's voters elected the most diverse and female city council in its history." In Fall River, it's a new day: Coogan cruises to victory over embattled Correia

In the end, it wasn't close. School board member Paul Coogan will be Fall River's next mayor after scoring a crushing victory over indicted incumbent Jasiel Correia, who stepped back from the race last month amid all his legal woes. Jo C. Goode at the Herald-News reports Coogan took home nearly 80 percent of the vote.

Rep. Shauna O'Connell to become first female mayor of Taunton

She made history, with a dash of controversy along the way. State Rep. Shauna O'Connell will be Taunton's first female mayor after handily defeating City Councilor Estele Borges in a race that started with what some claimed was behind-thescenes machinations from the governor's office to sneak O'Connell into the job. Judge overturns Baker's ban on medical-marijuana vaping products

Senator Collins Secures \$4.5M For Boston Roads *Massachusetts State Senate Allocates \$60M for Local Roads and Bridges*



he Massachusetts State Senate recently passed an annual Supplemental Budget, including a provision earmarking \$60 million to reimburse cities and towns for roadway repairs and infrastructure improvements. State Senator Nick Collins estimates that Boston stands to receive about \$4.5 million of the investment into transportation infrastructure.

The allocation will go to fund the Chapter 90 formula, which the State uses to help municipalities pay for roadway improvements. Salt and sand from a heavy winter, combined with typical factors of erosion, often leave potholes and dangerous conditions come springtime. Drivers, pedestrians, public transit riders, and bicyclists alike feel the impacts of these conditions, and these funds are designed to allow cities and towns the flexibility to make critical repairs.

"This funding helps our cities and towns promote safety and reliability on their roads and infrastructure" said State Senator Nick Collins. "I am proud to stand with my colleagues in the Senate and demonstrate our ongoing commitment to providing support to our partners in city government."

BOSTON'S TUITION-FREE COMMUNITY COLLEGE PROGRAM EXPANDED

ayor Martin J. Walsh announced Massasoit Community College, one of the largest community colleges in the state, is the fifth college to join the City of Boston's Tuition-Free Community College Plan. The **Tuition-Free Community College** program (TFCC) was launched by Mayor Walsh in 2016 and pays for up to three years of college for Boston's income-eligible students who have earned their high school credential. Massasoit joins Bunker Hill Community College, Roxbury Community College, MassBay Community College and Benjamin Franklin Institute of Technology as participants in the program.

"I launched our Tuition-Free Community College Plan as a tool to help Boston residents afford and complete college," said Mayor Walsh. "Since then, we have kept pushing toward that goal by growing the program-expanding student choice, academic opportunities and access to institutions committed to student success. Massasoit Community College will be a valuable partner in our work to build career pathways for Boston residents."

Through the TFCC program, Massasoit will provide participants with more options in both locations and programs of study. Massasoit

operates campuses in Middleborough, Brockton and Canton, which is within 10 miles of Hyde Park and Mattapan. The addition of Massasoit also makes new associate degree programs available to TFCC program students in Diesel Technology, Heating, Ventilation, & Air Conditioning (HVAC), Veterinary Technology and Architectural Technology.

These fields lead to careers that pay well above Boston's living wage. For example, diesel mechanics and HVAC technicians in the Greater Boston area earn salaries of approximately \$60,000 on average, at an average wage of \$29/hour, compared to the current living wage of approximately \$15/hour. The HVAC degree program at Massasoit creates a post-secondary pathway for students from Roxbury's Madison Park Technical Vocational High School who are enrolled in the school's new HVAC program.

"Dozens of students from the Boston area choose to study at Massasoit each year, and with the help of Mayor Walsh, his Office of Workforce Development, and the **Tuition-Free Community College** Plan, we're delighted to give even more students the opportunity to earn a degree from our institution," said Massasoit President Dr. Gena Glickman. "Our College is a tight-knit community of learners, faculty, and staff. Students who choose to study here have the opportunity to enroll in unique degree programs, challenge themselves academically through the Commonwealth Honors Program, and get involved through a number of student organizations and activities."

The number of students who apply and are accepted to the TFCC program has increased every year since 2016. Among the 489 students who have been accepted to the program, the mean household income is less than \$25,000 per year. Despite these

And he hauls out of the dustbin of history the long cast of characters who have so distinguished Massachusetts in the past. economic challenges, participating students have achieved a higher college retention rate (78%) from their first year to their second than that of community college students nationwide (63%).

"Thanks to the TFCC program, I didn't have to stress about paying for school," said Naweed Hassan, a TFCC participant who graduated from Bunker Hill Community College and has gone on to study at UMass Boston. "As a result, this helped me to stay more focused on my academics and make sure I got the most out of my education."

Run by the Mayor's Office of Workforce Development (OWD), TFCC is funded by the Neighborhood Jobs Trust which ensures Boston residents directly benefit from development by collecting linkage fees from large-scale commercial projects in the City. Students enrolling in TFCC must be Boston residents who have graduated from a high school in Boston, graduated from high school as a METCO student or earned their HiSET or GED. The students must also be eligible for a Pell Grant as de-



termined by the U.S. Department of Education and meet U.S. Department of Housing and Urban Development guidelines for having a low to moderate household income.

TFCC participants can extend their education to a four-year college through Boston Bridge, a collaboration of the TFCC program and the state's Commonwealth Commitment program. Boston Bridge enables the program's community college students to transfer to a Massachusetts state university or UMass campus to complete their bachelor's degree free of tuition or mandatory fees.

can't tell you the number of times I have had people say to me. "Oh, you grew up in Southie? You poor kid." I may have been poor, and I certainly was a kid, but don't cry for me, Argentina. There is no place else on earth where I would have preferred to have grown up than good old South Boston. Those people from Wellesley and Uxbridge and Lincoln may have had money, but they could never touch my memories. When I was ten years old my father and every other longshoreman on the docks would take a long, very long lunch when Southie was playing at White Stadium. He would pick me up at Monsignor Patterson's, and we would ride over, giddy with anticipation, at seeing Joe Crowley latest creation. If you were ever going to rob a bank in Southie, you would have been wise to pick a day when Southie was playing BC High.

There seemed to be a blue flu going around that day. Mail wasn't delivered. Fire Houses were barely surviving on a skeleton crew. Everyone was at White Stadium. For me, the first time I saw Domenic Gentile run, I was hooked, Nobody from Wellesly had a Domenic Gentile or a Frannie Coughlin or a Bobby Nichols or a Joe Greene. They were my pros, and White Stadium was my Gillette Stadium. I lived for those days. Later, when I got a little older friends like Pat Flaherty, my brother Eddie, Wally Quigg, Chrissy Alyward, would put



on the Southie jersey, and the tradition would continue. You can have your money, and I'll take my memories.


That is what growing up in Southie was. I was 13 years old and in the stands at the Boston Arena when Teddy Cunniff scored 13 goals in one game. That is something you can never take away from Teddy or me. Five years later, an upstart goaltender name Paul Wilson stood on his head against Marblehead, the best hockey team in the state with the leading scorer in the sate, Toot Cahoon. The Globe predicted, that morning, that Marblehead would win 13-0. Paul Wilson kicked out at least 60 shots, and Marblehead scored in the last minute of regulation to win by one goal. We sat in those stands, going crazy at every save that Willie made. The final score will show that Marblehead won that game, but both teams know they didn't.

Same in 1974 when Southie's hockey team made their first trip to the Garden, and once again the Boston Globe, and

I quote, "Good for Southie for making it this far but they do not deserve to even skate on the same ice as Arlington. Mighty Arlington. Hall of Fame coach, usually playing and winning in the Garden every year, were undoubtedly formidable, but not some Gods, as the Globe inferred. But for a period and a half it looked like the Globe knew what they were talking about as Arlington, accustomed to the bright lights, big stage, and 13,000 fans made Southie look inferior, for awhile. Arlington went up 5-1 in the second period, and Southie's supporters began to leave. Don't lie. You know you did, and I have names. Kevin Coughlin scored, and the floodgates opened. Mark Bartosiak in the Southie net was pulling a Paul Wilson. Once Southie went ahead we knew, Arlinton and the Globe knew that Arlington's reign was over. That is what being from South-

ie is. Or being one of 10,000 fans down the Stadium on a Fall Sunday afternoon cheering for our Chippies. I played second base for Gillette in Little League. My third baseman was a quiet kid named Michael Mc-Donough. Michael McDonough and Cliffy Swain, as incredible as this seems, both became the number one racquetball player in the world at different times. Think about that for a minute. Two kids from Southie. the best in the WORLD at two different times. You can have your money and your cars, I'll take McDonough and Swain and Domenic and Ray Flynn and Karen Boen.

I hope you can come to Florian Hall on the 23rd to see these men and women who made Southie so special and raise scholarship money for more Southie kids, and I haven't even got into the Southie pro hockey players. The Globe, you're not invited.



This wine is consistently on several "Top 100" lists every year and the key word here is, "consistently". Over the last seven seasons, despite some weather challenges, this wine has always scored in the mid-90s; it's just high quality and highly dependable. Bring out the best in your grilled New York strips or Sunday Roast beef with this beauty. You deserve it!

Maroon Winery Coombsville Cabernet Sauvignon Reserve, Napa, Black Label,

2014,(\$24.99), This Reserve Cabernet Sauvignon showcases a fruitforward core of black cherry pie and cassis that is balanced by an earthy, tobacco leaf finish, while French oak aging contributes notes of cocoa and sweet vanilla spice. Pick up a few bottles and impress your guests with this limited production 'Black Label' Cab paired alongside three bean chili, Korean barbecue ribs, or my favorite, a juicy lamb burger with bearnaise sauce and sauteed mushrooms-really delicious!

Further South, from Mendoza, Argentina, we have *Catena Alta Cabernet Sauvignon, 2016,* (\$38.99). This wine shows a dark ruby color with violet tones. On the nose, it offers intense aromas of ripe raspberries, and cassis with notes of pepper and clove. On the palate, it is full-bodied and rich



and displays layers of black currant and black raspberry. The vines that make this wine are located high in the foothills of the Andes mountains and the are hand-picked and sorted, then aged in 40% new French Oak barrels for 16 months before bottling. This one goes especially well with Veal Chop or Roasted Boar, Italian style.

Ch. Larrivet Haut-Brion, 2015, Pessac-Leognan, Bordeaux, France, (\$38.99), is a blend of Bordeaux area wines and Robert Parker says," The 2015 Larrivet Haut-Brion offers up fragrant notes of crushed raspberries, Bing cherries and red plums with hints of baking spices, black tea and potpourri plus a touch of crushed rocks. Medium-bodied and vibrantly fruited in the mouth with impressive energy and tension, it has a soft, silky frame and finishes on a lingering perfumed note.". High praise from Parker for a humble, under \$50.00 a bottle Bordeaux Red. This wine is really tasty with game bird dishes-Quail, Cornish Hen or Duck roasted in a blackcurrant reduction. Fantastic!

Boston Police Department & MBTA Transit Police Department Among more than 120 participating in 'Home Base No Shave' Campaign benefitting Home Base, a Red Sox Foundation and Massachusetts General Hospital Program

Campaign raises mental health awareness and raises funds to support Home Base's clinical and support services for Veterans and Military Families impacted by the invisible wounds of war, nationally



BOSTON, MA (November 2019) – As we make our way into November, don't be surprised if your local first responders look like they haven't shaved in weeks. For the privilege of growing out their facial hair, officers from the Boston Police Department and MBTA Transit Police Department are paying up and participating in the Home Base No Shave campaign in support of Home Base, a Red Sox Foundation and Massachusetts General Hospital Program.

Traditionally, police departments have a grooming policy where officers must remain clean-shaven. However, for the entire month of November, police officers have pledged \$100 to forego the traditional grooming policy and grow beards, mustaches and goatees – all in support of Home Base and their mission to provide no-cost clinical care to Veterans and Military Families impacted by the invisible wounds — such as post-traumatic stress and traumatic brain injury.

The movement is spearheaded by MBTA Transit Police and Boston Gang Unit Detective Kurt Power, a U.S. Army Veteran and Purple Heart recipient who sought care for his own invisible wounds at Home Base. "The only wish I have is that we give the gift of hope, hope to all the veterans that don't believe reintegration is possible. Hope to the approximately 20 veterans a day that may give up tomorrow," Power says. "If I can convince just one person who needs help to listen to me and put their trust in the treatment at Home Base, this will all be worth it."

This month, first responders at Boston Police Department and MBTA Transit Police Department will go beyond the badge to not only help raise money for a program that is changing the lives of Veterans and their Families, but to evoke conversation, raise awareness and break the stigma associated with getting care. "I think the biggest part about tion of support by communities from across New England and the country," said Home Base Executive Director Brigadier General (USA ret.) Jack Hammond. "It goes well beyond 'thank you for your service' – it's something tangible people are doing to show them that they care. Ricardo Arroyo — whose brother and father are former city councilors — easily carried the district with 5,325 votes compared to former McCarthy aide and favorite Maria Esdale Farrell, who took 4,398. Kenzie Bok, a former city hall staffer who recently headed policy and planning at the Boston Housing Authority, took Zakim's Back Bay and Beacon Hill seat with 3,659 votes to former Mass-GOP chairperson Jennifer Nassour's 1,539. Liz Breadon won Ciommo's Allston-Brighton seat over Craig Cashman, who conceded and went to congratulate his opponent at her party. Breadon received 3,883 votes to Cashman's 2,724.

The underlying storyline being promoted by the dailies and others is that, as a result of City Councilor Ayanna Pressley upsetting US Representative Mike Capuano, a number of progressiveoriented candidates had run in the primary, and most of them were women. The secondary agenda of the dailies is that of promoting a mayoral contest in 2021 by providing Councilor Michelle Wu with seemingly unfettered and often redundant attention to her many public policy promotions, which effectively had resulted in her finishing first in this general election, thus fueling speculation that she might run for mayor.

Activists on various policy matters like housing, climate change, social justice and health care competed for the 13 seats on the council. They have undoubtedly gotten that attention of Mayor Martin J. Walsh who is being pushed further to left side of the spectrum. It appears that Walsh will have his work cut out for him in dealing with the 2020 City Council. The candidates collectively said they wanted to push the city to tackle big-picture policy issues such as housing, transportation, and the environment. The question by more moderate voters has been, "who, at the city level, will pay attention to the issues that affect daily living, now that global issues are in vogue?"



DETROIT LIONS (+2.5) over Chicago Bears

-Both the 3-4-1 Lions and the 3-5 Bears are coming off a loss in Week 9. However, the Bears have lost four straight, and their offense looks atrocious. The only thing that gives Chicago some hope is its defense, which allows just 18 points per game. Detroit's defense allows 27 points per game, so if there ever was a week for Mitch Trubisky and the Bears' offense to build some confidence, this would be it. At the very least, Chicago's offense can't get any worse than it was last week, after gaining a total of nine yards in the first half of Sunday's loss to Philly. You read that right. Nine yards. On the other side, the Lions have shown some fight this year, so I expect them to bring it on Sunday at 1 p.m. in Chicago. The Bears might be a more popular pick here at home, but I saw what I saw last week, and Chicago stinks. I'm taking the underdog Lions to win the game.

GREEN BAY PACKERS (-5) over Carolina Panthers

-The 7-2 Packers had a four-game win streak snapped by the Chargers in Week 9. It was an awful showing by Green Bay's offense. Aaron Rodgers threw for only 161 yards in the loss. I expect a strong bounceback game from Rodgers back in Lambeau, as the 5-3 Panthers head to Green Bay Sunday at 4:25. Carolina is coming off a win over Tennessee, and just placed Cam Newton on injured reserve, which ends his season. So it's officially "The Kyle Allen Show" the rest of the way. If the playoffs began today, the Panthers would be on the outside looking in. Their only real shot is a Wild Card, because New Orleans is going to win the NFC South. As for the Packers, they're currently the No. 3 seed, but a first-round bye is still very possible. They'll have to beat Carolina though to keep up with the 7-1 Saints and the 8-0 San Francisco 49ers. Give me the Packers to beat the Panthers at Lambeau by a touchdown.

INDIANAPOLIS COLTS (-10) over Miami Dolphins

-All eyes will be on the status of Colts quarterback Jacoby Brissett, who suffered an MCL strain in Sunday's loss to the Steelers. Brissett will most likely be a gametime decision, according to early reports. If he plays — and that's what I'm betting on here — then I expect the 5-3 Colts to cover against the 1-7 Dolphins. It might be if Brissett misses the game. But again, I'm betting on Brissett to play because it's a must-win game for Indy, who right now holds the No. 6 seed in the AFC playoff picture. For all the big wins the Colts have had this season, they can't afford to lose to Miami at home, Sunday at 4:05. And they won't. Let's roll the dice on Brissett to play and the Colts should win by two touchdowns. MINNESOTA VIKINGS (+3) over **Dallas Cowboys**

-This one is Sunday Night Football on NBC. I know the 5-3 Cowboys are coming off back-to-back wins, but they've let me down too many times this season. I have no problem betting against Dallas, even if they're at home in this game. The 6-3 Vikings are coming off a tough loss to the Patrick Mahomes-less Chiefs, but perhaps that will be a wake-up call. Minnesota has the weapons to go into Dallas and win. And they will. So I'll take the points.

LOCK OF THE WEEK: LOS ANGELES RAMS (-3.5) over

Pittsburgh Steelers

-The 5-3 Rams are coming off the bye and head to Pittsburgh Sunday at 4:25. Before that bye, the Rams won two straight. Knowing it'll be a tough task to win the NFC West, it's going to be Wild Card or bust for the defending NFC champion Rams. If the playoffs began after Week 9, LA would miss the cut. There's a lot of football to be played though, and the Rams definitely have a realistic shot at that Wild Card. But they have to beat the 4-4 Steelers. Pittsburgh has won three straight, and is coming off a win over the Colts. The Steelers might put up a fight in this one because they are still alive in the AFC playoff race. MARTINEZ TO STAY WITH RED SOX IN 2020

D. Martinez had until this past Monday night to decide whether or not he would opt out of his contract with the Red Sox. That deadline has come and gone, and Martinez has chosen to stay in Boston for the 2020 season.

Martinez, 32, is entering the third year of his five-year, \$110 million contract with the Red Sox. He will also have the ability to opt out next offseason.

His decision to stay was perhaps the first shoe to drop in the team's offseason plans, as ownership remains committed to shedding salary for the purpose of getting underneath the \$208 million luxury tax threshold for next season. In 2019, the Red Sox' payroll was around \$240 million. Martinez is owed \$23.8 million in 2020.

Boston will see at least \$57 million come off the books in 2020, thanks to the departing



salaries of Rick Porcello (\$20.6 million in 2019), Pablo Sandoval (\$18.5 million), Mitch Moreland (\$6.5 million), Steve Pearce (\$6.3 million), and Eduardo Nunez (\$5 million). Had Martinez opted out, it would've left the Red Sox with enough money to make Mookie Betts a significant contract offer this winter.

Betts is entering the final year of his contract. He is once again arbitration eligible after avoiding arbitration last year by agreeing to a one-year, \$20 million deal. But new Red Sox Chief Baseball Officer Chaim Bloom might be in a position where he needs to

make a decision on Betts' future this winter, by either trying to lock him with a blockbuster contract extension, or by trading him.

TOOKIE

Martinez' \$23.8 million salary might force the Red Sox to trade Betts this offseason. Or they could try and trade Martinez, or someone like David Price, who has three years and \$96 million left on his current deal.

Either way, Martinez' decision to not opt out undoubtedly makes it more difficult — for now — for the Red Sox to keep Betts around long term, if they continue to commit to getting under the luxury tax threshold.

BETTS WINS FOURTH CONSECUTIVE GOLD GLOVE

oston Red Sox right fielder Mookie Betts received his fourth consecutive Gold Glove award over the weekend.

Betts, 27, joins Zack Greinke and Nolan Arenado as the only MLB players to win a Gold Glove in each of the last four seasons. Betts is now one of just five Red Sox players to win the award

four or more times, joining Dustin Pedroia, Dwight Evans, Carl Yastrzemski, and Fred Lynn. Betts and Evans are the only Red Sox players to win a Gold Glove in four consecutive seasons. Betts is the only player in Red Sox history to win four Gold Glove awards at the age of 27 or younger.

In 132 games in 2019, Betts recorded 10 assists and was charged with just two errors. In the last

four seasons, Betts' 37 outfield assists ranks second in the American League behind teammate and Red Sox center fielder Jackie Bradley Jr., who has 38 outfield assists in that four-year span.

Since the Gold Glove award's inception in 1957, 23 different Red Sox players have combined to win 49 Gold Glove awards, including 15 over the last 15 seasons.
