### STATUS OF VAPING BAN AND DEALING WITH THE UNKNOWN



n September, Governor Charlie Baker banned the sale of all vaping products in Massachusetts, after a series of mysterious vaping-related lung illnesses and some deaths across the country and

in the state. The ban is scheduled to last until Jan. 25, 2020.

Last week, Superior Court Judge Douglas Wilkins ruled that the Cannabis Control Commission (CCC), not the Department of Public Health or the Governor, has the sole authority to regulate the sale of marijuana vaping products for patients and gave the agency a week to either adopt its own emergency regulations to keep the ban in place or take some other action, judging the ban is "likely invalid" for medical marijuana patients. So, it's up to the CCC to decide if the products will remain off the market.

Judge Wilkins' ruling focused specifically on medical marijuana because a group of patients intervened in a challenge to the state ban. Patients testified in court that the ban "would force medical marijuana patients to turn to the illicit market, switch to opiates or travel to other states," cannabis industry Attorney

#### Beware! The Package Thieves are Back for the Holiday Season

he coming of the holidays is supposed to be a joyous time. Some would say it is 'the most wonderful time of year'. Most people consider it a time to celebrate Thanksgiving, Christmas and Hanukkah. But with all the good tidings, religious observances and festivities there, unfortunately in some locations, also come those, whose goal it is to steal from others.

Over the past week, South Boston Today has been contacted by three different local families who informed us that delivered packages have been taken from their doorsteps. Looking into this further, it seems that the number is far more than three and it appears to be happening in many parts of the neighborhood. Yes, it can happen anytime of the year, but the holidays are when the number of thefts increases because of the massive number of items being delivered to homes in the area.

Here are some suggestions to help thwart this activity early in the season. Many people now have security cameras and 'RING' doorbells and monitors. If you have not yet activated yours, you might want to do it now. If you see suspicious activity on your block, report it to police immediately, it's what the police are asking us all to do. Look out for your neighbor's homes and ask them to do the same for you. The thieves often hit during weekday afternoons, when they know most people are at work and there is less chance of getting caught and it's when most of the packages are delivered. The important thing is that the word be spread right away to everyone to be aware that this activity has spiked once again. If we all work together starting now, we can help stop it before it gets out of hand and with any luck, catch some of the culprits and discourage the rest of them.



#### Rep. Biele, MA House Pass Legislation to Support and Honor Veterans

Increases access to mental health services at public colleges and universities, recognizes the historical contributions of Revolutionary War hero

BOSTON - Last week, State Representative David Biele joined his colleagues in the Massachusetts House of Representatives in passing legislation to improve mental health care for student veterans and to honor the military service contributions of a female American Revolutionary War soldier.

One bill establishes a continuing education program to train public higher education counselors on the symptoms of conditions like post-traumatic stress disorder (PTSD) and available resources for treatment for veterans attending state colleges and universities. The legislation aims to provide the necessary training for both clinical and non-clinical



counselors working to support the unique needs of the more than 2,500 veteran students attending the state's 29 public higher education institutions. The second bill establishes a 15-member commission to design a memorial in honor of Deborah Sampson, who disguised herself as a man in order to serve in the Continental Army during the American Revolution.

"I was proud to join my colleagues in supporting legislation that increases services for veterans and honors their contributions to our country," said Rep. Biele. "This legislation will support veterans transitioning to civilian life by training counselors at colleges and universities to recognize and support veterans who may be suffering from the invisible wounds of war. This legislation also recognizes the contributions of Deborah Sampson and her inspiring story of service and bravery during the founding of our country."

In 1782, Sampson used the name Robert Shurtleff to join the elite Fourth Massachusetts Infantry Regiment led by Captain George Webb at West Point. Over the following year and a half, she participated in dangerous scouting missions, led a raid that brought about the capture of 15 Tory men, and stormed a British fort during the Siege of Yorktown.

Over the course of her service,

Sampson sustained injuries including a forehead gash from a sword and a gunshot wound to the thigh. For the latter, she removed the bullet herself to avoid detection as a woman. When she later fell seriously ill and was hospitalized, her identity was discovered. On October 23, 1783, she received an honorable discharge and was the only woman to receive a full military pension for her service in the Continental Army. John Hancock and Paul Revere assisted her in obtaining her military pension, and General John Patterson selected her as his aide de camp due to her bravery and leadership. Sampson is the official state heroine of Massachusetts.

The two bills build on the House's long-standing support for veterans with Massachusetts' benefits and services often ranked as No. 1 in the nation. Most recently the Legislature passed the BRAVE Act as well as legislation to assist veterans with funeral and burial expenses and property taxes.

The bills will now go to the Senate.

# Flynn Hearing on Pedestrian Crossing Signals & Traffic Calming Nov. 18th

Boston City Councilor Ed Flynn will hold a hearing to discuss the City of Boston's pedestrian crossing signals and traffic calming measures



that would improve safety for all to help achieve Vision Zero - the goal of no serious or fatal crashes in the City of Boston. The hearing will be held Monday, November 18th, 1pm in the Iannella Chamber at Boston City Hall with the Committee on Planning, Transportation and Development. The hearing will focus on ways to improve pedestrian crossing signals and traffic calming infrastructure improvements, slower speeds, and enforcement.

Residents have called attention to pedestrian signals that allow for crossing the street at the same time that vehicles have a signal to turn at an intersection, which could potentially be unsafe for pedestrians crossing a busy intersection.

Residents have also called for infrastructure improvements to our built environment - such as speed humps, raised crosswalks, curb extensions, road diets and rapid flash beacons - that would aid in traffic calming. As the city and our neighborhoods become

more densely populated due to development, this increase in vehicular and pedestrian foot traffic continue to change our traffic patterns, and a discussion on measures to enhance pedestrian and traffic safety is warranted.

"Pedestrian safety is a top priority for me, and must be a top priority for the City of Boston," said Councilor Flynn. "I look forward to having this discussion with the Boston Transportation Dept, Boston Police Dept, relevant agencies and concerned residents about how we can continue to work on infrastructure improvements, slower speeds and enforcement."

#### SEN. COLLINS ENSURES ACCOUNTABILITY MEASURES FOR COLLEGES, UNIVIERSITIES

Massachusetts State Senate Passes Bill to Establish New Reporting Guidelines

he Massachusetts State Senate unanimously voted to establish new requirements for higher education institutions. The goal of State Senator Nick Collins and his colleagues in the Senate is to support the financial stability of students and their families. These steps have been

taken in response to recent closures of small colleges in the Commonwealth which came a surprise to students and families, causing financial hardship and disrupting their education.

The legislation includes important accountability measures such as the development of student-focused contingency plans if the public college or university is expected to close. There is also a new requirement for the development of a training program for school board of trustee members, in the attempt

to achieve better management. The training will occur every four years.

The new requirement of financial reports is designed to lead to better assessment and clarity. The assessments will be created by the Board of Higher Education (BHE) to ensure financial honesty and accountability. "With this new legislation higher education institutions, their students, and the families of students will all have increased predictability, financial security, and be on a better footing for success," said State Senator Nick Collins. "It's



incredibly important to support students and their families as they work to advance their education, and I am proud to have voted for this bill."



#### MAYOR WALSH, LAWRENCE MAYOR RIVERA ADVOCATE FOR BETTER PROTECTIONS AGAINST NATURAL GAS LEAKS

ayor Martin J. Walsh and Lawrence Mayor Dan Rivera offered testimony before the Joint Committee on Telecommunications, Utilities, and Energy in support of legislation that would impose a fine on natural gas providers for the total volume of all grade 3 gas leaks, incentivizing the utility companies to update their infrastructure and providing revenue for climate-ready municipal projects. The legislation, "An Act to Modernize our Natural Gas Infrastructure," is sponsored by Representative Ed Coppinger and Senator Mike Rush.

"Last year we watched in horror and in sympathy, as Lawrence and the Merrimack Valley were struck by natural gas explosions that destroyed homes and displaced thousands of families," said Mayor Walsh. "For municipal leaders across the Commonwealth, and for all of our residents as well, these events brought into sharp focus the threat posed to our communities' safety when natural gas infrastructure is neglected or mishandled. As elected officials, it is incumbent upon us to do everything we can to keep our residents safe, and that's why I'm proud to support this statewide legislation to hold gas providers accountable for the infrastructure they operate."

"This legislation is important because any leak is a level one leak," said Lawrence Mayor Dan Rivera. "For an industry that has a hard time focusing and fixing level one breaks and has shown to be incapable of emergency situations, this legislation holds their feet to the fire on all leaks. I thank Mayor Walsh for his leadership on this matter."

In 2017, utility companies re-



ported 27,731 gas leaks in Massachusetts. By the end of that year, 15,829 had been repaired. Through this legislation, Mayors Walsh and Rivera are calling for the Commonwealth of Massachusetts to hold gas providers accountable for the infrastructure they operate, and the impacts they

have on residents. The bill is part of Mayor Walsh's legislative package, which builds upon Boston's work to ensure equity, opportunity and resilience for all residents by strengthening current systems and creating new tools to adapt, mitigate and invest in local transportation and the environment.

Will Luzier said. In his ruling, Judge Wilkins accepted this argument.

The cannabis industry welcomed the ruling and was quoted on WBUR News stating, "I'm actually quite excited that the judge ruled to put the decision in the hands of the Cannabis Control Commission, as they are the regulatory body for both medical and adult-use cannabis in the Commonwealth," said Dr. Marion McNabb, CEO of Cannabis Community Care and Research Network, a marijuana research and advocacy group.

Wilkins' ruling doesn't apply to marijuana vapes for recreational customers or nicotine vapes. But his reasoning suggests that the CCC may also have exclusive authority over recreational marijuana, including the vaping products. State lawmakers clearly gave the CCC oversight of medical marijuana, Wilkins wrote.

As the Governor's ban on the sale of vaping products was lifted at noontime Tuesday, November 12, for medical marijuana patients,

the CCC stepped in and ordered a quarantine of all marijuana vaping products, except those that vaporize flower for medical patients. The indefinite quarantine of all "marijuana products and devices that rely on vaporization or aerosolization, including, but not limited to, vape pens, vape cartridges, aerosol products, and inhalers" will keep oil-based vaping cartridges off the shelves of marijuana stores, even for medical marijuana patients.

In statements released by the Commission, CCC Executive Director Shawn Collins ordered the quarantine "based on his determination that these products pose an immediate or serious threat to the public health, safety or welfare and the quarantine is necessary." The order also states that Collins "has determined that additional testing of certain products for vitamin E acetate and other substances of concern and the development of additional regulatory and policy safeguards is also necessary to protect the public health, safety and welfare." The quarantine, which is to remain in effect until the CCC amends or rescinds it, comes on the heels of the U.S. Centers for Disease Control announcing that its investigation into the nationwide rash of vaping-related lung illnesses has found "direct evidence of vitamin E acetate at the primary site of injury within the lungs."

The CCC said its current testing regulations and protocols "do not require testing for vitamin E acetate," which is thought to be added to some oil-based vaping cartridges as a filling agent. "Based on current manufacturing processes, it is possible that legal marijuana products sold in the state could contain vitamin E acetate or other potential ingredients of concern," the CCC said in a statement. It added that it is in talks with its testing labs "to understand their capability of testing for ingredients such as vitamin E acetate."


The CCC added a requirement in its most recent round of regulation rewriting that all vaporizer

cartridges, marijuana extracts and concentrates sold in Massachusetts come with a more detailed list of the chemicals and ingredients they contain. The specific requirement is that marijuana product labeling also list "the amount of any specific additives infused or incorporated during the manufacturing process, including, but not limited to, thickening agents and specific terpenes, expressed in absolute terms and as a percentage of volume." Up until that point, the CCC's rules for the marijuana industry had only required the ingredient list to include information about the cannabinoid profile of the marijuana and its THC content.

During the quarantine, all licensed marijuana businesses are required to quarantine vaping products in the state's mandated seed-to-sale tracking system and the CCC suggested that its upcoming round of regulatory revisions "will be open to public comment and focus on the requirements for extracts, concentrates, and any accessories or devices used for vaporizing marijuana."

# Councilor Flynn to Hold Hearing on TNCs (Uber/Lyft) Nov. 19th





Recognizing the integral role that TNCs now play in our overall



transportation system, as well as the convenience they provide, the hearing will focus on concerns from residents regarding this evolving industry and measures to address traffic and congestion, public safety due to the lack of designated pick up & drop off areas, the environment, and consumer protection.

Residents have highlighted concerns regarding public safety and Vision Zero due to reports of speeding vehicles, as well as the lack of designated pick up & drop off areas in the city, which has resulted in double parking or vehicles pulling over in the middle of the street and posing safety risks for all on the road. This additional traffic also creates environmental concerns as the additional vehicles affect our air quality, increase carbon emissions, and run contrary to the goal of promoting sustainable transportation methods such as public transportation. Residents have also called attention to consumer protection as prices jump significantly during sporting or city events.

The hearing will also discuss ways to leverage the demand to TNCs to improve our transportation infrastructure, as well as regulations other cities have enacted on TNCs. For example, New York City places a cap on the number of TNCs in the city for one year, and establishment of a minimum wage for drivers. Other municipalities have imposed fees on TNC rides, and cities like San Francisco have piloted geofencing at appropriate areas of the city to limit pickups, reduce congestion, and discourage double parking.

"TNCs now play a key role in our overall transportation network and they provide convenient transportation for many residents and visitors to the City of Boston. However, data shows that they also belong in our discussions about traffic and sustainability," said Councilor Ed Flynn. "Residents have also expressed safety concerns about designated pick up/drop off areas and geofencing in appropriate locations. I look forward to having a robust discussion about the ways that the city can work with TNCs and use data to make our streets safer and less congested for everyone."

"Creating and sustaining reliable, equitable transportation continues to be a challenge we face as a city. With Boston's growing population, there is an increased use of TNC's, such as Uber and Lyft, impacting the City's roads and bridges," said Councilor Matt O'Malley. "In this hearing, I'm looking forward to discussing ways in which TNC's have impacted congestion, safety and sustainability in the City of Boston. With this emerging gig economy, we also need to ensure that there is revenue generated to invest in improving our local roads and public transit."

# The Wine Guy

### Baby, It's Cold Outside

hat with the snow on Tuesday, temperatures plunging into single digits with the wind chill, and the T being even later than usual, I think it's safe to assume that Winter is officially here. It's also a good time to take a look at what will warm you up, wine-wise. Port, or fortified wine, has been around for about 400 years or so and like many other wine discoveries, it happened by accident. Back in the late 1600s, two brothers who sold their wine from Oporto to accounts in England were trying to find a way to preserve it for the long journey. They eventually came up with the idea of adding grape brandy to the barrel and it became very popular. Eventually, the brandy was added during fermentation and aged over time, which is still the way it's done today and not just in Portugal.

So, let's take a look at what



will take the chill off this winter season. Briefly, there are two major types of port wine; Ruby Port is less aged than Tawny Port, typically a few years and it keeps its dark color. Tawney Ports are older and develop an amber color, as well as a drier character than Ruby. Like Single Malt Scotch, some Ports are aged up to 30 years, but the majority are aged between 2 and 10 years.

Dow's 10 Year-old Tawny Port, NV, (\$21.99), gets 90 points from the Wine Spectator, who describe it as," Amber golden in colour, soft and rich on the palate with a fine and mellow fruit flavour blending in with the almond overtones of prolonged cask aging. A very fine Port to be savored in a reasonable sized glass so that the aromas and colour can

be appreciated." This one, like most Ports, is usually had as a dessert wine and most people enjoy it in a snifter. Also, like most ports, this wine is most often served with stronger cheese, lie Stilton or aged Cheddar. I like it with a whole wheat crackers, a piece of Cheddar and pepperoni and a dollop of yellow mustard.

While it's not one of the larger Port producers, the Pinhao family has been making great Port wines since 1715. Their Quinta do Noval 10-Year-Old Tawny Port, NV, (\$34.99) is made the same way today as it was then and no wonder. This one shows outstanding intensity of color, complexity, concentration, and depth of flavor. Tinta Roriz, Touriga Franca and Tinta Barroca predominate among the traditional grape varieties. 50% of the grapes come from the estate and 50% from traditional suppliers of "A" category grapes. The grapes are hand-pressed, (almost unheard of today) and aged in old French oak barrels. In addition to desserts, this one could be had with a nice Duck Confit.

Another 90-Point selection from Wine Spectator is FON-SECA BIN 27 Ruby Port, NV, (\$14.99). The Spectator says, "This sweet wine shows fresh, rich blackberry and cassis aromas. On the palate, it has a well-knit structure, with a

velvety, luscious mouthfeel and smooth tannins." Not surprisingly, this one, like all Ruby Ports, is served with sweeter deserts, like Puddings, Tarts and Cakes. You should know that the shelf life of most Ruby Ports isn't very long once they've been opened; I've heard that during the Holidays, some people enjoy it in Eggnog.

Last, but far from least, I want to mention a Port from Ramos Pinto. The Ramos Pinto 10 Year Tawny, Ervamoira, NV, (\$41.99) is consistently one of the best Portugal has to offer. This tawny is a blend with an average age of 10 years. We are now entering the complex world of an aged tawny. Its brick-red, even golden shades transport us to the Orient of spices, piquant and exotic aromas, with all its mysteries. This is where the magical path towards the 20 Years and the 30 Years begins.

Delicious as an aperitif or after dinner with chocolate, not-too-sweet desserts, milk or cream based desserts, and cheeses. It pairs especially well with dried fruits or nut cakes and tortes. You should also know that this firm's wines are among the best in the country and if you see any of them in your local shop, don't hesitate to pick one up.



#### **BOSTON'S OFFICIAL TREE ARRIVES NOVEMBER 19**

he annual gift of an evergreen Christmas tree from Nova Scotia will arrive by police escort at Boston Common at approximately 11 a.m. on Tuesday, November 19. This year commemorates 102 years of friendship between Nova Scotia and the people of Boston after our city provided emergency assistance when Halifax, Nova Scotia's capital, was devastated by a maritime munitions explosion in the harbor in 1917.

Boston's official 2019 Christmas tree is a 45-foot white spruce tree donated by Desmond Waithe and Corina Saunders of Chance Harbour, Pictou County, Nova Scotia. The tree will be celebrated at a public cutting ceremony at 10:30 a.m. on Wednesday, November 13. The official send-off ceremony will be on Friday, November 15, at Halifax City Hall, with a stop at St. Stephen's Elementary School located in the north end of the city, an area severely damaged by the Halifax Explosion. On Saturday, November 16, the tree will be in Halifax's annual Parade of Lights and from there it

will begin its journey to Boston. Nova Scotia will also send an additional four smaller trees for donation to local charities.


"Our welcoming ceremony for the tree from Nova Scotia celebrates the lasting friendship between the people of Boston and the people of Halifax," said Mayor Martin J. Walsh. "Every year, thousands of residents and visitors enjoy this beautiful tree, and I thank Desmond and Corina and the people of Halifax for making Boston's holiday season so special."

#### Interactive Instruction at St. Peter Academy

Sayre's classroom is one of several instructional areas now equipped with these modern-day chalkboards; the touch-screens connect to laptops and other devices to help differentiate instruction with text, images, audio, and videos each day. Aside from increasing opportunities to engage all kinds of learners, teachers relay that the interactive display boards have created a more impactful and fun educational experience for their students. Sayre, who received a Bachelors and Masters degree from the University of Portland, notes how it's not only the interactive display boards, but the small class sizes at St. Peters, that help to differentiate instruction. "I can better support students who may be struggling in reading

or mathematics than I would in a traditionally larger classroom. The number of students, in addition to building upon their natural curiosity with the latest technology, help me to do that every day."



s we get closer to the in-season deadline for retired NFL players to file for reinstatement, "Gronk Watch" remains in full effect in New England.

Even if a Rob Gronkowski return this year is unlikely, as long as the possibility still exists, it will be a hot topic of conversation in the NFL rumor mill. And that possibility only exists for two more weeks.

Gronkowski has until before the Patriots' Week 13 game in Houston on Sunday, Dec. 1 to request reinstatement. So, interestingly enough, this past weekend, NFL Network's Ian Rapoport reported that Patriots owner Robert Kraft told Gronkowski that he wants him back in a Patriots uniform for the playoffs.

According to Rapoport, sources told him that, while Gronkowski was at Gillette Stadium cleaning out his locker after he announced his retirement, "Kraft told Gronkowski that he wants him to return for November, December, and a playoff run."

Kraft himself told the NFL Network last month that he was still hopeful for a Gronkowski return, while revealing that Gronkowski had yet to officially file his retirement papers.

It remains to be seen whether or not the Patriots' hopes can turn into a reality over the next two weeks. But there's no doubt that, if he wanted to play again, the Patriots would welcome Gronkowski back for one more playoff run.

# PATRIOTS RETURN FROM BYE WEEK WITH TOUGH FOUR-GAME STRETCH

If the playoffs began after Week 10, the 8-1 New England Patriots would be the No. 1 seed in the AFC, and the road to Super Bowl LIV would go through Gillette Stadium.

Now that the Week 10 bye has come and gone, the Pats return to action in Week 11, where they'll take on the 5-4 Eagles in Philadelphia, Sunday at 4:25 p.m. It will mark the first game of New England's toughest four-game stretch of the season.

After Sunday's game in Philadelphia, the Patriots will host the 5-4 Dallas Cowboys in Week 12, then they'll travel to Houston to take on the 6-3 Texans in Week 13, followed by hosting the 6-4 Kansas City Chiefs in Week 14.

Much like the Patriots' schedule moving forward, Baltimore doesn't have an easy road in the second half either. The Ravens' remaining opponents are Houston, LA Rams, San Francisco, Buffalo, New York Jets, Cleveland, and Pittsburgh.

The Patriots close out their regular-season schedule with games against Cincinnati in Week 15, Buffalo in Week 16, and Miami in Week 17.
