

## SEN. COLLINS, REP. BIELE SUPPORT PASSAGE OF DISTRACTED DRIVING LEGISLATION



ecently, State Senator Nick Collins and State Representative David Biele joined their colleagues in the Massachusetts State Legislature to pass legislation to ban drivers from using hand-held electronic devices in vehicles unless they are in hands-free mode. The bill defines hands-free mode as one that engages in voice communication with and receiving audio without touching, holding or otherwise manually manipulating a mobile electronic device. Law enforcement officials will issue warnings to drivers for first offenses of the new law until March 31, 2020.

"This piece of legislation will save lives and protect everyone who uses our roads and sidewalks," said Senator Collins. "Many accidents in-



As other states take aggressive action on housing, Massachusetts can't even pass one measly housing-reform bill

The Globe's Tim Logan reports that other states – such as New York, Washington and Oregon – have recently passed aggressive action to address the housing crunch in their respective domains. In Massachusetts? Lawmakers can't even pass Gov. Charlie Baker's rather modest proposal to ease restrictions on new housing construction in towns and cities.

Well, at least one municipality is stepping up to the plate, for a change. From MassLive: "Newton City Council approves largest housing project in city's history; Plans include 800 apartments and 14 buildings."

### Boston's Zoning Board of Appeal: Impervious to even the smallest change?

Speaking of seemingly intractable problems, Boston's Zoning Board of Appeal, currently at the center of a bribery scandal, might seem ripe for major reform. But ... but no reform proposals have emerged yet, and the board seems destined to keep on rubber-stamping those zoning variances until ordered otherwise. ### Hero Square to be Dedicated to Martin F. **McDonough** This Saturday

here are Hero Squares located all over South Boston. In fact, there are more than 1200 Hero Squares across the entire City of Boston to honor the many local veterans who have served this country so well. For those who may not be familiar with what a Hero Square actually is; perhaps you are new to the city, they are located on city blocks or 'squares' and highlighted by beautifully engraved plaques attached to street sign polls.

Appearing on each of these Hero Square plaques is the name of a member of the United States Armed Forces, a veteran, who had been killed in service to our country. Veteran's Services is adding a biographical history to each Hero Square so that people can read about the life and service of the individual named on the plaque.

This coming Saturday, December 7th, Mayor Martin J. Walsh and the Office of Veteran's Services will dedicate the area outside 329A W. Broadway which is the address of the Martin F. McDonough Post. It will be named for and in honor of Martin F. McDonough who was a South Bostonian. This dedication to one of our neighborhood's heroes will take place at 10:30 am on location at the



post. The public is invited to attend. Martin F. McDonough enlisted in

the Navy in 1942 and just 3 days after he enlisted, he began his active duty tour. His rank at the time he was killed in action was Seaman 2nd Class. His assignment was to the Navy Cruiser the USS Juneau which was deployed to the Pacific. The USS Juneau, with Mc-Donough on board, fought many ocean engagements against enemy ships.

On November 13, 1942, the Juneau was sunk by a torpedo. Seaman 2nd Class McDonough was lost at sea and presumed dead. There were only 10 who survived the battle and unfortunately, Martin F. McDonough was not among them. For his sacrifice he was awarded the Purple Heart. His name will be forever memorialized on the Tablets of the Missing at the Manila/ American Cemetery in the Philippines.

Martin F. McDonough is one of South Boston's many military heroes killed in action in defense of freedom. His patriotism and courage epitomizes the fighting spirit of South Boston's veterans – past and present and his memory will forever live in the heart of a proud community and a grateful nation. Saturday's dedication of the Hero Square in his honor is a noble gesture fitting for the stature of this great man. Again, it will take place this Saturday, December 7th at 10:30 am. All are invited.

# **Remembering Pearl Harbor**

eventy-eight years ago, on December 7, 1941, the Japanese Imperial Navy launched a surprise attack on American military forces when they bombed Pearl Harbor, a two-hour bombardment killing more than 2.400 American sailors and civilians, damaging 20 ships, and destroying 164 planes. President Franklin Delano Roosevelt declared the Pearl Harbor attack as a day which would live in infamy; a "dastardly deed" which would not go unpunished. Knowing his nation couldn't sustain a protracted war against such a vast industrial power, Admiral Isoroku Yamamoto was quoted, but was never verified as saying, "I fear all we have done is to awaken a sleeping giant and fill him with a terrible resolve."

Our involvement in World War II began on that dark day in Hawaii and ended four years later on the shores of Japan. On August 6, 1945, the Enola Gay dropped the atomic bomb on Hiroshima. Three days later, on August 9, the city of Nagasaki was bombed. Overall, over 210,000 people died during the two bombings while others suffered and subsequently died from radiation exposure. Under the leadership of Emperor Hirohito, the Japanese surrendered on August 14. Shortly thereafter on September 2, the surrender documents were signed on the USS Missouri. The Japanese started this war and suffered the horrific consequences for their actions. "The Japanese began the war from the air in Pearl Harbor," President



Harry Truman said. "They have been repaid many fold."

Fast forward to 2019 and the world still stands on shaky ground. Terrorism intermittently rears its ugly head as innocent men, woman, and children are murdered; the victims of Jihad, the victims of Hate. Conflict, war, and disorder are the order of the day. Iran poses a serious threat. And the rest of the Middle East, as usual, like Iran, is in turmoil. North Korea is a riddle wrapped in an enigma. China is our number one threat with a strong military, but ignored by those who feel Russia is, deluded by the perception of Russian collusion hiding in every corner of America. Europe and Great Britain's glory days are mere memories etched in history books not read. Africa, Mexico, Central America, and South America overall aren't desirable places in which to live. And at home, we are divided by partisan politics which threaten to destroy the very fabric of American life.

The Japanese attack on Pearl Harbor provides witness, to this day, that one must prepare for war to secure peace. Evil men prey on weakness but fear strength. That's why we must never forget those Americans who died on December 7, 1941. That's why Americans



have to stand tall against those who want to destroy us and our way of life. That's why we must forget our differences when it comes to matters of national self-defense; and why we must have a strong military to protect us from harm. We must always be ready and ever vigilant. We mustn't be the aggressors but we need to be prepared to defend our nation, our people.

Sadly, that's the way the world is and we must never forget that.

Otherwise, we may suffer another Pearl Harbor.

And we surely don't want that. (With modifications this story first appeared in SBT in 2017)

volving phones and other handheld distractions are avoidable, and this bill reinforces our shared commitment to prevent tragedies and reduce risks in our communities."

"Distracted driving is a serious public safety issue and factors into too many preventable accidents," said Rep. Biele."I'm proud to vote with my colleagues to pass this final bill to prohibit handheld cell phone use while driving. Requiring drivers to keep their hands on the steering wheel and their eyes on the road, instead of on their cell phones, will make our streets safer, and I'm proud to join my colleagues in the Legislature in passing this legislation."

Additionally, this legislation improves transparency in public safety by granting expanded access to traffic stop data. It has been 15 years since the last public report on traffic stop data; under this bill the state will be required to publish and analyze the data annually.

Other provisions in the legislation:

• Allow for drivers to use mapping or navigation devices if they are affixed to the windshield, dashboard or central console or integrated into the vehicle and only involve a tap or a swipe;

• Exempt use of electronics in the case of an emergency and for first responders if they are using the devices as part of their duties;

• Penalize drivers with \$100 fine for the first offence, \$250 fine and safety course for the second offence and \$500 fine and surcharge for third and subsequent offences;

• Expand data collection of identifying characteristics when police issue a uniform citation;

• Require the Executive Office of Public Safety and Security (EOPSS) to publish data online annually as well as hold public hearings to present the findings of the annual report and analysis and field public testimony; and

• Create a public awareness campaign informing and educating drivers on the dangers of using technological devices while driving.

The bill was recently signed into law by Governor Baker and will go into effect in February 2020.

### Getting a Drone This Holiday Season? "Know the Rules" to Fly Safely regulations include the following: Flying around and above airports



oday, the Massachusetts Port Authority (Massport) kicked off an advertising campaign aimed at educating the public about the safe use of drones. The campaign encourages drone operators to be responsible: "Fly your drone safely this Holiday Season. Know the Rules." The ads will appear on print media, social media, and billboards. The campaign will run from November 27, 2019-January 10, 2020.

Drones have been among the list of popular holiday gifts. According to the Federal Aviation Administration (FAA), nearly 1.5 million drones are registered in the U.S. and a majority of them—over 1 million—are intended for recreational use. The FAA also predicts the number of drones sold in the U.S. to reach nearly 2.5 million by 2022.

"We are most concerned about the people who are unaware of the rules on drones," said Massport Chief Security Officer Hank Shaw. "With the growth and advancement of drone technologies, we recognize there are significant benefits for commercial or business purposes, recreational use, and support to our first responders. But, drones must be safely integrated into the airspace and pose a significant concern when operators do not follow the rules."

All drones over .55 lbs. must be registered with the FAA and must be marked with the registration number. Operators are required to carry proof of registration. Other regulations include the following:  $\cdot$  Flying around and above airports is prohibited without prior FAA approval. Violators will be subject to penalties.


 $\cdot$  Never fly near any aircraft, especially near airports.

 $\cdot$  Keep your drone in sight at all times and always lower than 400 feet.

Since 2016, Massport has installed "No Drone Zone" signs in several parks and other properties around Boston Logan International Airport. The locations include Piers Park, Bremen Street Park, Festa Field, and the Neptune Road Buffer in Easton Boston. Signs have also been posted at the Maritime Park and Cruiseport Harborwalk in South Boston. Massport is also working with neighboring communities to install signs in other public places.



Deverybody had too much to eat and drink and that nobody got hurt during any arguments about sports or politics at the dinner table. That said, it's winter now and that means red wine more often than not, so read on and warm up.

France's Rhone Valley contains some of the oldest vineyards in Europe; the Romans first brought organized wine production to the region over 2,000 years ago. The most prolific name in the valley today, though, is pretty new-founded in 1946 by Etienne Guigal. He started as a fruit picker, saved and sacrificed to buy his first piece of land and never looked back. Today, Maison Guigal, in its third generation, produces a portfolio of wines that are nothing short of extraordinary, both in depth and quality. Their 2014 Guigal Crozes Hermitage, (\$18.99), is a great wine to have with a holiday roast, rack of lamb or slow-cooked beef stew. This 100% Syrah offers intense aromas of blackberry, black olive and spice. It's full-bodied with penetrating intensity of flavor and has good length on the finish.

In the States, we have a region

that's similar to the Rhone Valley in a lot of respects, but it's Zinfandel, not Syrah, that's the predominant grape in the region. I'm talking Lodi in California and the Zins are big here, many from vines that are 50 years old and more. Ironstone Reserve Old Vine Zinfandel 2017, Lodi, (\$21.99), is rich and wellstructured, lingering dark fruit finish. The dark fruits and sweetness of the Reserve Zinfandel will pair perfectly with a creamy and herbaceous fettuccine pork Bolognese or a rich braised beef dish with lots of hearty vegetables. There's also a little bow to the Rhone Valley, though, as this one has 8% Syrah in the blend.

It doesn't really get very cold in any part of Australia, yet they provide some of the heartiest reds on the planet and a great example of that is Australian Shiraz. The range of body and style of this wine is really broad, but one of the best representations has got to be Penfolds, Bin 128, Coonawarra Shiraz, 2016, (\$39.99). Notes of sage and bay leaf, along with Indian spices combine with dark-berried fruits, all infused from 12 months in French oak. Have this one with Beef Wellington, New York strips or Filet Mignon with bernaise and roasted vegetables.

KWV Classic Collection Cape Tawny, (\$26.99), is a great tasting way to end a great meal. This beauty is reddish brown, almost a caramel color, with notes of sweet dates and apricots apricot notes, as well as light orange peel, milk chocolate and almond notes with an unusually long finish. Don't be in a hurry with this one; the 17.5% ABV makes it one of the strongest dessert wines in the world. It's a natural for strong cheeses with fresh fruit or Creme Brulee. *Talk To The Wine Guy at jdris8888@gmail.com*




















## I was just thinking...

ast September, liberal billionaire and former New York City Mayor, Michael Bloomberg, who recently announced his Democrat candidacy for the presidency, was interviewed on PBS. While initially discussing China's response to greenhouse gas emissions, he ended up defending the country's leadership, stating the Chinese government as being responsive to its people. And that Xi Jinping, the country's leader, was not a dictator. Not a dictator. That's right. It's not a typo.

"He's not a dictator?" PBS's

Margaret Hoover asked Bloomberg to which he replied, "No, he has a constituency to answer to...Xi Jinping is not a dictator...He has to satisfy his constituents to survive." So, as far as Bloomberg is concerned, the communist party in China listens to the public, to their beloved people. And it's not a dictatorship.

Bloomberg made these remarks during this interview after months of widespread reports concerning the violent crackdowns against Hong Kong protesters by the Chinese government. The Chinese government routinely jails dissidents and led the world in political prisoners in

2018. A 2019 international tribunal in London declared that the government was harvesting organs from prison camp detainees, some of who were still alive. Over the years, the regime has led a campaign against Christian churches which recently included the government's attempt to rewrite scripture. The government has tightened control over Tibetan Buddhism in Tibet and seeks a "strategy of forced assimilation" and suppression of Buddhist thought throughout Tibet. Over one million Uighur Muslims are in Chinese concentration camps and these people are under high tech surveillance throughout China. A 2018 report accused the government of sanctioning live organ harvesting of members of

the Falun Gong religious group. According to the United States Commission on International Religious Freedom, this group also faces government harassment, detention, intimidation, in addition to "physical violence, psychiatric abuse, sexual assault, forced drug administration, and sleep deprivation."

In 2018, Xi Jinping effectuated changes to his country's constitution allowing him to remain in office for the remainder of his life. But he's certainly not a dictator because Bloomberg told us so. Yet I'm confused and now wonder what type of government that it's supposed to be, if indeed it's not a totalitarian one, ruled by someone rightly and commonly known as a dictator.

# The 'Write Stuff' at St. Peter Academy

ason Hubert, third grade teacher at St. Peter Academy, is an advocate for instilling a love for writing in children. "As our world and way of living changes, the ability to read, write, and communicate effectively remains the same" notes Hubert. "It is important that today's students develop and strengthen these skills to be successful in their lives and careers." To differentiate his instructional methods for kids, Hubert utilizes the classroom interactive display board, a computerized version of a traditional blackboard, that allows students to actively engage in the English/Language Arts curriculum on a daily basis. One recent lesson focused on writing one-paragraph essays with a specific focus; students were encouraged to create a "hook" or interesting line to capture the reader's attention for the written piece. After reading various examples of humorous, inciteful, or inquisitive hooks on the display board, Hubert encouraged students to write their own creations that would fit paragraphs already written by them during the previous school day. One student's hook asked: "Did you know there are over 170,000 words in the English language?" whereas another student cleverly wrote: "Reading is as sweet as honey." The kids enjoyed sharing ideas and hearing what others conjured up for their hook statements, while Hubert was happy to see their writing skills getting stronger. "Students will continue to write lengthier and more detailed statements as the year progresses", Hubert says. "Throughout this process, its important that a fun approach is maintained to make the initiative relevant to and beneficial for the kids."

Hubert received his Bachelor of Science degree from North Carolina State University and his Master of Education from the University of Florida. He holds dual-state certification for instruction of Grades K-6 and prides himself on making education accessible to all students. Now in his second year at St. Peter Academy, Hubert enjoys the school's small class sizes that allow for individualized student attention. "I love my kids and I really love what I do each day. I'm very fortunate" he says.



## RED SOX TRADE LEON TO CLEVELAND

he Boston Red Sox traded catcher Sandy Leon to the Cleveland Indians on

Monday, in exchange for minorleague right-handed pitcher Adenys Bautista.

Leon, 30, has spent the last five seasons with the Red Sox. In those five seasons, Leon hit .223 with a total of 24 home runs and 118 RBI in 358 games. In 15 postseason games with the Red Sox, Leon hit .258 with a home run and three RBI.

The Red Sox receive a 21-yearold pitcher in Bautista, who made his professional debut in 2018 after signing with Cleveland out of the Dominican Republic. In 2019, Bautista made seven relief appearances in the Dominican Summer League, and seven relief appearances in the Arizona League, posting an ERA of 7.79.

During his first two professional seasons in the Dominican Summer League and Arizona League, Bautista is 1-6 with a 5.98 ERA in 27 appearances, 26 of them out of the bullpen.
