

## YOUR VOTE COUNTS, JUST ASK JULIA MEJIA



n Tuesday, Alejandra St. Guillen told supporters that she has conceded in the race for the fourth and final at-large City Council seat to Julia Mejia, after a recount gave Mejia a one-vote victory in an election where 67,000 ballots were cast. St. Guillen had been weighing whether to appeal contested ballots to the state courts but said Tuesday she will accept the outcome.

"Last night, I believed that I owed it to my supporters and the voters to fully review the results from the recount before moving forward. After weighing all the options with my team and my family, I have come to the decision to not move forward with a court challenge," she tweeted out. She added, "I am so grateful to every person who supported me over this last year in our campaign

## **EDITORIAL** Hey You Turkeys, Get Off of My Car

There is a lot of talk on South Boston's social media sites about turkeys roaming our streets and back yards. Well, that's because there are a lot of turkeys in town and we don't mean the plump and juicy variety that graced many of our Thanksgiving dinner tables last week. Nope, these are the wild turkeys that are turning up in flocks in practically every part of the neighborhood.

They seem to like to perch on fences as well as on the roof and hood of vehicles. They appar-

ently feel safe and quite at home among us and the sight of them delights a lot of residents. But a word of caution: .Look at them if it pleases you but we recommend not approaching them. Because unlike the fluffy and adorable rabbits that wouldn't harm a soul that have invaded our inner-city enclave over the past year, wild turkeys can get pretty aggressive, if they choose, and even if not provoked. Most have seen the news reports of wild turkeys in some towns actually chasing mail carriers back into their trucks and most recently, a flock of the unpredictable birds attacking the tires of a police cruiser for no apparent reason.

There was one report out of a South Shore town where school children find the need to carry hockey sticks while waiting for the school bus to come to use to fend off the winged visitors. Sometimes, this could be a necessary defense if attacked. So, our advice is to keep a safe distance and follow the recommendations of wildlife experts and do not feed them.

is the season of peace, love and good will toward all, as far as many people are concerned. But police remind us to be aware that even though most would never think of doing so, like most years, there still are those who are prowling our streets looking for delivered packages to steal. Yes, it happens in many places including South Boston and especially during the Christmas season, when there are considerably more delivered items left on door-steps by FEDEX, UPS , the US Postal Service and other delivery services.

Losing those special gifts that often cost quite a bit of money can put a damper on anyone's Christmas spirit. And it's not just the monetary worth that makes the gifts so valuable. Most often a lot of thought and love goes into selecting just the right item for the special people in our lives, which makes it even worse if they are stolen. But there are precautions we can all take to cut down the odds that we will be victims of these thefts.

Police sources have suggested a type of neighborhood watch agreement between neighbors that can foil even the most determined thieves. One plan is to select one or more neighbors to work with. Whenever someone sees a package on the door steps of a nearby neighbor, they take it into their own homes and either bring it by when the neighbor returns home or at least notify them that they have the delivered package, which can be picked up at their convenience. If each neighbor involved in the agreement does the same for each other it will greatly lower the chance that the item will be stolen.

Cameras: Security cameras are coming down in price at a rapid

rate. You can go high tech and spend a lot of money on a state-of-theart security/video system. As most know, in 2019, there are security systems like 'Ring' that will shoot live video footage to your phones whenever there is movement outside your home, and you can even communicate by audio to anyone on the premises. But you don't have to spend a lot to get good results. Stores like Walmart, Bass Pro-Shops and Cabelas sell 'Game Cameras' used by hunters that cost as little as \$25 and take excellent still pictures as well as video. Positioned at the proper angles, they can catch the image of the thieves themselves on SD cards and even the license plate numbers if the thieves are using vehicles for their getaway.

But the neighborhood watch method is probably the way to go as well and if all are in agreement, it won't cost a dime; just neighbors helping neighbors. As law enforcement sources will tell you, word spreads quickly among criminals. If they know that there are people watching out for one another in a certain area, they will go elsewhere to commit their crimes. And South Boston people have always been famous for watching out for one another.

So, we hope this word of caution will remind all to keep your eyes open for the package thieves this year. If we all work together it will ensure that this Christmas season will be Merry.

### Every vote truly counts: Mejia wins council recount by only one vote

They're pulling out the 'every vote counts' cliché – and well they should. Boston City Council At-Large Candidate Julia Mejia was declared the winner – by one vote – after a three-day recount of nearly 45,000 votes. WGBH's Isaiah Thompson, the Globe's Milton Valancia and Universal Hub have the details on the recount – which may yet be challenged in court.

## The latest scathing T report: Will anyone be held responsible?

It wasn't just a scathing report on safety 'deficiencies' at the MBTA. It was a scathing and damning indictment on the overall mismanagement of the MBTA in recent years. Think we're exaggerating? Here's a small sampling of the headlines following yesterday's release of an outside panel's report on the T – From Boston Magazine: "The MBTA's Leadership Is 'Defeated, Helpless and in Some Cases Hopeless." From MassLive: "MBTA safety report finds deficiencies 'in almost every area' of system." From CommonWealth magazine: "Panel offers scathing assessment of transit operations." From SHNS's Chris Lisinski: "Experts: MBTA Safety Woes Underscored by Trust, Fear Issues." From the Globe: "Safety 'is not the priority' at the MBTA, panel finds."

Of course, some people, like House Speaker Robert DeLeo, are now suggesting that more money is the answer to the T's problems (SHNS). Which is probably true. But do people really want to sink more money into a system that's clearly mismanaged? The Herald's Joe Battenfeld gets closest to the management matter by pointing a finger straight at Gov. Charlie Baker and Transportation Secretary Stephanie Pollack.

We do know this: The current management team – including the MBTA's fiscal control board – is simply failing. Do we really need more proof of this after this report?

## Sen. Collins, Rep. Biele Vote to Enact the Student Opportunity Act

State Senator Nick Collins and State Representative David Biele, along with their colleagues in both chambers of the Massachusetts Legislature, unanimously voted to enact the Student Opportunity Act.

This legislation, providing an unprecedented \$1.5 billion new investment in Massachusetts K-12 public education system, ensures public schools have the resources to provide high-quality education to students across the state, regardless of zip code or income level. Assuming inflation, over the sevenyear implementation timeline the bill will provide an estimated \$2.2 billion in support of public schools. The City of Boston and Boston Public Schools are projected to receive an additional \$115 million for public education under Chapter 70 over the next several years.

"I was proud to vote for this unprecedented investment in local education," said Sen. Collins. "The State has demonstrated its commitment to Boston Public Schools over the past decade, but this bill really ramps up the investments. In addition to the \$222 million in baseline education funds, and the \$202 million in unrestricted aid we allocate for City schools, it is clear that the Commonwealth is dedicated to a quality education for all students. What could possibly be more important than investing in the future of our young people?"

"We have a responsibility to invest in our youth, their education, and their future," said Rep. Biele. "This landmark legislation will help ensure that Boston Public Schools, and public schools across the state, have the necessary resources to provide high-quality education to students regardless of income level or zip code, giving our students the tools they need to succeed and thrive in the classroom and beyond."

The Student Opportunity Act provides significant support to school districts that serve high concentrations of low-income students and English learners. All school districts across the Commonwealth will benefit from updates to the existing funding formula, with increased state investments in vital education aid programs such as special education transportation and school construction and renovation.

The Student Opportunity Act fully implements the recommendations of the 2015 Foundation Budget Review Commission (FBRC) in order to support the "educational programs and services necessary to achieve the Commonwealth's educational goals" as stated in the Commission's mission. The bill provides an estimated \$1.4 billion in new Chapter 70 aid over and above inflation when fully implemented over the next seven years. The legislation modernizes the K-12 educa-



tion funding and policy by: · Increasing special education enrollment and cost assumptions to more accurately reflect district enrollment. Providing additional funding based on the share of low-income students in each school district; and • Returning the definition of lowincome to 185 percent of the Federal Poverty Level, as opposed to the 133 percent level used in recent years. • Increases funding for English learners. In addition to implementing the FBRC's recommended formula changes, the Student Opportunity Act provides an additional \$100 million in state financial support in several categories to help public schools and communities deliver a high-quality education to every student. Those fiscal supports include: · Increasing foundation rates for guidance and psychological services in recognition of the growing need for expanded social-emotional support and mental health services;

• Committing to fully funding charter school tuition reimbursement, which provides transitional aid to help districts



when students leave to attend charter schools, within a three-year timetable;
Expanding the special education circuit breaker program, which reimburses districts for extraordinary special education costs, to include transportation as well as instructional cost, to be implemented over the next four years; and

• Raising the annual cap on Massachusetts School Building Authority spending for construction and renovation of school building projects by \$200 million.

In order to track and reproduce successful school and district-level programs and policies, the legislation calls on school districts to develop and make publicly available plans for closing opportunity gaps and includes language, to ensure that plans consider input from school committees and other stakeholders. The legislation also establishes a Data Advisory Commission to help improve the use of data at the state, district, and school levels to inform strategies that strengthen teaching, learning and resource allocation.

The bill was signed into law by Governor Charlie Baker.

## Councilors Flynn & Flaherty, DND Held Informational Meeting on Senior Programs



In the meeting, staff from DND & the Boston Home Center gave

an overview of programs such as Seniors Save and the Senior Home Repair, where eligible seniors can obtain grants or 0% interest loans to replace aging heating systems, and to make emergency, moderate or minor repairs to their homes. DND representatives were able to walk residents through the application process for these programs and answer pertinent questions. Residents also received brochures and informational materials about city programs and services available to seniors and homeowners.

"Thank you to the Department of Neighborhood Development for coming out over the weekend to discuss valuable home repair programs available to our seniors," said Councilors Flynn and Flaherty in a joint statement. "The city offers a variety of programs that help our seniors stay safe and comfortable in their homes, and we will continue to work closely with our city departments to ensure that our residents are aware of the helpful assistance they provide."

## Tom Tinlin Named Board Chair of Brain Aneurysm Foundation



BRAIN ANEURYSM FOUNDATION Raising Awareness. Ending Fear."

B oston resident and brain aneurysm survivor Tom Tinlin has been named the Brain Aneurysm Foundation's (BAF) board chair. Tinlin will help to support BAF's mission and continue its work as the globally recognized leader in brain aneurysm awareness, education, support, advocacy and research funding. Tinlin started working with the foundation following his own experience with a ruptured brain aneurysm in April 2017. In just two years, Tinlin has dedicated himself to the organization and has worked tirelessly to raise awareness and research funding.

"I am thrilled to have Tom succeed me as board chair. His personal and professional experience makes him a wonderful asset to the board. He understands firsthand the importance of continuing the foundation's work nationally and across globe," said Former Board Chair, and Founder and CEO of RL Leaders and Capstone National Partners John C. Rogers.

In 2018, Tinlin received BAF's Survivor Champion Award for his work within the brain aneurysm community. This year he emceed the event helping to honor individuals, such as City of Boston Mayor Martin J. Walsh, for their efforts to raise awareness. Tinlin has also been instrumental in working with Massachusetts Governor Charlie

Baker to formally recognize September as Brain Aneurysm Awareness in his home state.

"It is my privilege to serve as board chair. As a survivor I feel I have been given a gift and this is my way of giving back," said Tinlin. "As I continue to work with BAF and the brain aneurysm community, my goal is to increase the general public's and medical professionals' understanding and education of the early warning signs that can easily be misdiagnosed. My hope is that the work that we do today will lead to early detection and successful treatment of brain aneurysms in the future."

For the first time this year, Tinlin and his family organized the first annual "18 for 18" Tinlin Family Golf Tournament, which was the largest fundraiser in the foundation's history. The tournament name represents a startling statistic; a brain aneurysm ruptures every 18 minutes. Of the 30,000 people each year that suffer a rupture, 40 percent will die, and of those who survive, 66 percent will endure permanent neurological deficits that limit their ability to resume a normal life. Despite how often a rupture occurs and how devasting the outcome, the federal government only spends .83 per person afflicted.

All the proceeds that Tinlin and his family raised supports BAF, of which \$40,000, went to the Thomas J. Tinlin Chair of Research. This year he traveled to Pasadena, CA to award Dr. Steffen-Sebastian Bolz of the University of Toronto, the grant to support his research project. "BAF is so grateful for all of the work that Tom, his family and his community have done to help elevate the level of awareness of brain aneurysms and raise critical research funds. Tom understands how important it is to have more people know what a brain aneurysm is and how to identify a potential rupture. Understanding the early warning signs and knowing the facts saves lives," said BAF Executive Director Christine Buckley.

## All-America Honors For Emmett Forde Of South Boston

Here Emmett Forde of South Boston was named to the 2019 AFCA Division III All-America first team which were announced today by the American Football Coaches Association. He is the eighth Statesman to be named an AFCA All-American and the first first-team selection since current Tampa Bay Buccaneer Ali Marpet '15 in 2014.

A starter in all 11 games this season, Forde led Hobart with 81 tackles. His 21 tackles for loss led the Liberty League and were the most by a Statesman since Tyre Coleman '15 had 28.5 in 2014. Forde is 16th in the nation in tackles for loss per game (1.9). He also shared the league lead in fumbles forced (3) and fumbles recovered (2).

The 2019 Liberty League Defensive Player of the Year and All-Liberty League pick was named the conference's defensive performer of the week three times this season. He opened the season with eight tackles and two interceptions in a win over nationallyranked Brockport. Forde posted a season-high 12 tackles and forced a fumble in the win over Montclair State. The following week, he rang up 10 tackles at Union and followed that with another 12 tackle effort in the win over Rensselaer. Forde also posted a seasonhigh 3.5 tackles for loss and forced a fumble against the Engineers. He capped the regular season with seven tackles, all solo, and a 19-yard scoop and score in the win at Rochester.

Hobart went 9-2 this season. It's the ninth time in the 126-season history of the program that the Statesmen have won at least nine games. Hobart posted a 4-2 record in Liberty League play, tying for second in the standings.

The Statesmen ranked sixth in the nation in turnovers gained with 17 interceptions (15th) and 13 fumbles recovered (11th). The Hobart defense was among the best in the nation in the red zone, as opponents scored on just 57.5 percent of their trips inside the 20 (23-40).

In 30 career games, Forde has 139 tackles, 27.5 for loss, 8.5 sacks, five pass breakups, four forced fumbles, three fumble recoveries, and two interceptions. On Hobart's career lists, he is 13th in tackles for loss, tied for 18th in fumbles forced and 22nd in sacks. Forde is the first linebacker in Hobart history to earn AFCA All-American honors.

Emmett is the son of Kay and Paul Forde, and siblings Patrick and Rose. His Mom said, "I am so proud of Emmett and his achievement! His football career started here with South Boston Pop Warner and continued at Catholic Memorial."

Boston City Council At-Large Candidate Julia Mejia has now officially secured the fourthplace spot for the Council's four at-large seats after a three-daylong recount. According to the tally, certified Monday by the city's Board of Election, Mejia won out over St. Guillen, by one vote - 22,492 to 22,491. "It feels incredibly overwhelming to win by one vote," Mejia told reporters Monday night. "It really goes to reinforce the message we've been promoting all along, that every vote matters."

The final tally was announced

**Boston Election Commissioner** Eneida Tavares by shortly after 6 p.m., and after lawyers for both candidates made final arguments over a handful of contested ballots — arguments that could have swayed the outcome of the election. The Board of Election voted to allow one ballot that had previously been rejected and not to allow another one. It was not clear which, if either, candidate those ballots favored. The St. Guillen campaign had 24 hours to decide whether it will contest the results in court, and the campaign was deciding overnight whether to take that step and candidate St. Guillen made the tough decision the next morning.

When asked Monday evening about the possibility of a recount,

Mejia said the campaign will prepare for another review of the votes. "At the end of the day, for me, it's always been about building political power in low-income communities," she said. "The more opportunities that we have to demonstrate the value of our vote, the better this story is going to be. So, if we're going to court, we're going to court."

Neither state nor city laws provide for automatic recounts, no matter how close the margin of an election. Instead, candidates must petition the city for recounts ward by ward — for each of the city's 22 wards — by submitting at least 50 resident signatures from each ward the candidate wishes recounted. Both Mejia and St. Guillen petitioned for citywide recounts after unofficial results released late on Election Night showed St. Guillen just 10 votes behind Mejia from winning the Council's fourth atlarge seat. Later vote tallies showed Mejia ahead by just five votes, and then eight votes by last count at the time the recount began.

Despite weeks of uncertainty over who would take the Council seat, one outcome became clear on Election Night: The Council would see its first Latina member with either candidate.

The recount marked the first citywide recount since 2001, when City Council At-Large Candidate Felix D. Arroyo emerged as the fifth-place vote-getter ahead of opponent Robert Consalvo by just over 60 votes after initially trailing Consalvo by 33 votes.

## Martin J. McDonough Hero Square Dedication

ast Saturday, the latest "Hero Square" was dedicated in memory of another South Boston war hero. Family members, friends of the family, elected officials, representatives from Veterans Services and a crowd of proud and supportive South Bostonians turned out to witness the name of Martin J. McDonough take its place among the more than 1200 other war heroes who names appear on their own 'Hero Squares all over the City of Boston.

The Martin J. McDonough Hero Square is now located in front of 329A West Broadway in South Boston, directly in front of the Martin J. McDonough veteran's post which is also named in his honor.

Martin J. McDonough enlisted in the United States navy in 1942 and was soon assigned to active duty. He was then assigned to the USS Juneau, which was a navy cruiser. The Juneau, which was deployed to the Pacific, fought many battles with McDonough on board. On November 12, 1942, the Juneau was hit by an enemy torpedo and sunk. McDonough was listed as missing at sea and presumed dead.

More than 70 years have passed but South Boston never forgets its veterans, past and present, and that was confirmed once again by the turnout last Saturday. Mayor Martin Walsh, State representative David Biele and City Councilor Ed Flynn all were in attendance to pay tribute and speak well of the fallen hero. John Allison, from Veteran's Affairs was also there as were members of Martin J. McDonough's family; among them 2 of his nephews Joey and Johnny McDonough and Paul McDonough, a cousin. Kevin Conroy, a former US Marine was there to play a beautiful rendition of 'Amazing Grace' on

the bag pipes that really helped set the tone for this very special event. Also, honoring the gathering with their presence was Colonel Anthony Hinson and the South Boston High School Jr. ROTC. They looked sharp and very professional as they always do in their uniforms.

Susan McDonough, who is commander of the McDonough post (no relation to Martin J.) was the MC of the dedication and did an excellent job putting it together, was presented a plaque that was given to the post to commemorate the occasion and the memory of Martin J. Mc-Donough himself.

The dedication of the hero square was followed by a luncheon at the post and gave those in attendance a chance to socialize, share stories and memories and to get even better acquainted with the value of South Boston's veteran's posts and the wonderful work these organizations do in the neighborhood on behalf of South Boston's many veterans and their families.

The dedication of the Martin J. McDonough Hero Square last Saturday was another reminder of the tremendous respect the South Boston Community has always had and to this day, still has for all of its veterans. This is a neighborhood that holds its veterans in high esteem for the sacrifices they have made on our nation's behalf.

hether you're hosting a Holiday party, Christmas Eve or Christmas Day dinner, it's always a good idea to have some backup.

So, here are a couple of good wines to start with and a nice

backup to finish with.

Morgan Highland Chardonnay 2017, Chardonnay, Santa Lucia Highlands, Monterey, Califor*nia*, \$22.99), is a wine with pronounced notes of pears, melons and mountain flowers. Perhaps the most highly regarded appellation within Monterey County, Santa Lucia Highlands AVA benefits from a combination of warm morning sunshine and brisk afternoon breezes, allowing grapes to ripen slowly and fully. The result is concentrated, flavorful wines that retain their natural acidity. Wineries here do not shy away from innovation and place a high priority on sustainable viticultural practices. Great for Turkey or ham.

2018 Kim Crawford New Zealand Pinot Noir (\$19.00).With peppercorns, brambly berries, pomegranates, and mineral, this is a Pinot that really drinks much better than the price would suggest. While we all pretty much know this vineyard's Sauvignon Blanc, its Pinot Noir, like many from New Zealand, is rich, plush and structured, with striking notes of cherries, dark fruits and minerals. Pour this one with Turkey, Ham or even a holiday roast.

Now, some "backups"- dependable, less expensive wine that's great to finish a meal with.

### **NFL INVESTIGATING PATRIOTS' INVOLVEMENT IN FILMING OF BENGALS' SIDELINE**

he New England Patriots are once again being investigated for spying on an opponent. This time, that opponent is the Cincinnati Bengals.

Last Sunday, a videographer from Kraft Sports Productions was caught filming the field from the press box, which included the Bengals' sideline, in their Week 14 game against the Browns in Cleveland. According to reports - and also according to the Patriots — the reason a Kraft Sports film crew was in Cleveland for the Bengals vs Browns game was to capture video for their web series, "Do Your Job," which highlighted the work of a Patriots advanced scout.

The advanced scout was doing his job and scouting the Bengals, as the Patriots play in Cincinnati this Sunday at 1 p.m. But when the videographer turned the camera's attention to the field, members of the Bengals' organization and the NFL stepped in and confiscated the video card.

On Monday night, the Patriots released a statement that acknowledged the production crew "inappropriately filmed the field from the press box," but also said there's no connection between that "independent" production crew and the football team.

"The production crew is independent of our football operation. While aware that one of the scouts was being profiled for a "Do Your Job" episode, our football staff had no other involvement whatsoever in the planning, filming or creative decisions made during the production of these features. We accept full responsibility for the actions of our production crew at the Browns-Bengals game."

#### STATEMENT FROM THE NEW ENGLAND PATRIOTS

For the past year, the New England Patriots content team has produced a series of behind the scenes features on various departments within the organization. The seven previous "Do Your Job" episodes are archived on patriots.com. On Sunday, Dec. 8, the content team sent a three-person video crew to the Bengals-Browns game at FirstEnergy Stadium in order to capture one part of a longer feature on the Patriots scouting department, in this case a Patriots pro personnel scout while he was working in the press box.

While we sought and were granted credentialed access from the Cleveland Browns for the video crew, our failure to inform the Bengals and the League was an unintended oversight. In addition to filming the scout, the production crew without specific knowledge of League rules - inappropriately filmed the field from the press box. The sole purpose of the filming was to provide an illustration of an advance scout at work on the road. There was no intention of using the footage for any other purpose. We understand and acknowledge that our video crew, which included independent contractors who shot the video, unknowingly violated a league policy by filming the field and sideline from the press box. When questioned, the crew immediately turned over all footage to the league and cooperated fully.
