





Assisted Suicide Laws May Harm People with Disabilities

ompassionate medical care and end of life considerations are some of the most complex and difficult issues facing families, and society in general. It is a reality that may only intensify against a backdrop of an aging population. In the United States, the number of older individuals outpaces younger generations. By 2030, one in five Americans will be 65 years old, and the population of those 65 and older is projected to nearly double by 2050 (Census).

Longevity is one trend that drives us to evaluate how we provide care



for aging adults, people with chronic illnesses or disabilities. End of life issues are particularly challenging, especially when society seeks answers in public policy. Assisted suicide is part of a constellation of end-of-life issues. While some advocate for its legalization as a personal decision, there can be unintended consequences.

In the 115th Congress (2017-2018), a Sense of Congress Resolution (H.Con.Res.80) garnered bipartisan support and expressed awareness that assisted suicide can put vulnerable people at risk of harm. The Nation Council on Dis-

ability is a long-time opponent of assisted suicide laws. In fact, the NCD issued its first report on this issue in 1997, and another in 2005. They concluded that the interests of the few people who would benefit from assisted suicide were "heavily outweighed by the probability that any law, procedures, and standards that can be imposed to regulate physician assisted suicide will be misapplied to unnecessarily end the lives of people with disabilities."

The NCD called on Congress to establish a comprehensive, fully-funded system of assistive living services for people with disabilities. Today, their position remains unchanged. The NCD's recently-released update of that research reinforced their conclusions. Nine states and the District of Columbia have legalized assisted suicide, Over the years, restrictions have been loosened. In some cases, there are insufficient measures to investigate mistakes or abuse.

The NCD also reported inequities in suicide prevention efforts. Often, people with disabilities are not referred for mental health treatment when seeking assisted suicide, while people without disabilities do receive these referrals.

The report found that regulatory safeguards are ineffective. Some considerations:

- A misdiagnosis of a terminal disease can cause a frightened patient to choose to end their life

- People with the disability of depression may be more vulnerable

- Many people with disabilities have been conditioned by society to see asking for help as undignified or burdensome, or that having a disability inherently lowers quality of life

The report recommends steps to be taken at the federal and state levels to ensure that people with disabilities have a system of assisted services and supports, and that they are informed about these supports by medical providers. In addition, providers should receive training on working with people with disabilities.

Here are some steps that Congress could take now:

- Pass another resolution similar to H.Con.Res.80.

- Amend the Social Security Act to remove Medicaid's statutory bias toward institutional long-term care rather than long-term services and supports (LTSS) provided for people living in the community.

A voice for people with disabilities People with disabilities should not

consider ending their lives because of a lack of supportive services or because they are working with medical providers who are not required to help patients find alternatives. When policy makers debate legislation around end of life issues, it is critical that the needs of people with disabilities are on the table. As guidelines and guardrails are set, and standards established for education and training, people with disabilities need to be part of the equation. They deserve the same level of care, information, services and support as anyone who does not have a disability.

(The National Council on Disability recently submitted its report, "Assisted Suicide Laws and Their Danger to People with Disabilities," to the White House.)

SEN. COLLINS, REP. BIELE LEGISLATION TO HONOR AMERICAN REVOLUTION ADVANCES IN LEGISLATURE

Biele sponsored a bill to honor the American Revolution. The legislation, entitled An Act establishing a commission on the 250th anniversary of the American Revolution, was filed in both the Massachusetts Senate and the Massachusetts House of Representatives.

As written, the bill would establish a special commission tasked with promoting the celebration of the upcoming 250th anniversary of the American Revolution. The legislation charges the Commission with identifying historically significant events in Massachusetts that led to the American Revolution, while holding commemorative celebrations across the Commonwealth to recognize the state's role, as well as individual and regional contributions, to the founding of the United States of America.

"As we approach the 250th anniversary of major events in the American Revolution, we have a unique opportunity to celebrate our shared history and drive economic activity across the city and state," said **Senator Collins.** "From education, to preservation, to cultural



tourism and commemorative events, Massachusetts will continue to be a national voice in celebrating our common values as Americans.

"Massachusetts played an important role in the American Revolution and the founding of our nation," **said Rep. Biele.** "This legislation will honor those many contributions with commemorative celebrations in cities and towns across the Com-



monwealth, reminding us of our important history, educating our youth about our shared American values, and driving economic opportunities for culture, travel and tourism."

This bill received a public hearing earlier this legislation session, and received a favorable report and recommendation from the Joint Committee on State Administration and Regulatory Oversight.

Councilor At Large Michelle Wu. At the meeting, residents discussed the latest filing by the development team, led by Redgate and Hilco, for approval of a Planned Development Area (PDA). A Planned Development Area (PDA) is an overlay zoning district that establishes special zoning controls for large or complex projects. The Development Plan may provide for uses, dimensions, or parking that deviate from the general zoning for the district. Approval of a PDA requires the submission of a development plan. Development plan submission triggers a 45 day public comment period and requires the approval of both the City of Boston BPDA and the City of Boston Zoning Commission. If approved by the BPDA and the City of Boston Zoning Commission, the PDA would create zoning for approximately 1.78 million square feet of space, hotel space, and over 630 residential units. The PDA is one approval the project needs to move forward.

Councilor Flynn kicked off the meeting, stressing the importance of transportation and pedestrian safety, and stressed that the development team needs to satisfy the community and residents. Councilor Flynn stated he wants to see more.

Residents expressed their outrage, and asked the development team for a public

apology, for the comment made by Hilco Executive Vice President Andrew Chused: "Sorry, I wasn't born in a bathtub in South Boston." Ralph Cox and the development team refused to acknowledge the insulting and derogatory remark and would not apologize for the comment. He characterized the comment as being made in a private conversation between individuals, which is incorrect. Mr. Chused did not attend Monday's meeting and has not attended any public meetings regarding the Edison since the spewing of the comment. As one resident said, he's on the no fly zone in South Boston.

Several Impact Advisory Group (IAG) members informed the neighborhood that the group boycotted the IAG meeting prior to the community meeting with the BPDA and development team. The IAG members stated they had not received information on transportation or mitigation from the development team, despite the fact they made a request for information months ago. Their concerns and requests for information are not being met.

Rep. Biele commented that there was no consensus on this proposal and commented that the project currently lacked sufficient long-term commitments on transportation. Rep. Biele also stated that if the project is to include housing, the proposal must include more than the proposed 16% affordable units, pointing out that the developer has 15 acres to work with and other developments in South Boston have larger percentages of affordable housing with smaller parcels.

Sen. Collins clarified that the final decision on the proposal would be made by a vote of the BPDA Board. Sen. Collins stated his sentiments on public transportation and the proposal's lack of affordable housing. Sen. Collins also commented that the proposal lacks sufficient green space, pointing out that a proposal in South Boston on a smaller parcel has a larger percentage of green space and open space than what is proposed on the 15 acres of the former Edison. Sen. Collins also responded to the development team's proposal of taking care of Medal of Honor Park for ten years. The Senator asked what happens after ten years?

Members of the Boston Building Trades and Local 26 hotel workers were in attendance and spoke in favor of the project, including several heated exchanges between residents and union members. A Planned Labor Agreement was signed months ago, which guarantees the Unions that no matter what is built on Edison land, it will be union jobs with union wages. Not quite sure why the building trade unions are fighting their brothers and sisters in the ILA. Members of the International Longshoremen Association (ILA) were in attendance and spoke against the current proposal, citing concerns on the highly profitable Conley Terminal from housing and overdevelopment.

It appears not much has changed since the last community meeting. Will the City of Boston approve the PDA and push the project forward despite the concerns of the South Boston community and IAG? Will the extreme height, density, lack of green space, safety, traffic, public health concerns and it goes on, be addressed to the satisfaction of our elected officials and the community? Will Massport stand with the South Boston community and the ILA to protect the Conley Terminal and refuse to lift the deed restriction if the City decides moves forward?

The public comment period is still open on the proposal until January 24, 2020. Skywriting 'Success' in Second Grade

or Katie Karalexis, instruction needs to be highly interactive. The second grade teacher takes pride in creating a classroom culture that is not only warm and welcoming, but fun and engaging. Currently in her first year at St. Peter Academy, Karalexis employs a variety of strategies and initiatives that spark student interest and accommodate a variety of learning styles. In a recent phonics and writing lesson, the educator was observed using "skywriting" techniques that help children tackle irregular spelling patterns. After writing and saying the word "know" on the white board, she asked students to print the word for themselves. Once everyone was finished, the class was instructed to "take a picture of it" in their minds.

She then called upon a volunteer to state the word, spell the word, and say the word again. At this point, the students were asked to close their eyes and state the word, spell the word by drawing it in the air, and say the word again - still with their eyes closed. The class then repeated the "skywriting" process with their eyes open. "I find that this approach, using visual, kinesthetic, and auditory methods, really helps the kids" she says. "It appeals to every kind of learner - whether they prefer seeing things, hearing things, or writing things out."

Karalexis received a Master of Education degree from Lesley University and a Bachelor of Arts degree in Psychology from the University of Massachusetts - Amherst. When asked about her teacher, second grader Fiona Condon quickly stated, "She makes learning fun. We're always doing something interesting!" This comment came before a trip to meet Julio César Román at Microplant Studio on Broadway in South Boston to discuss plants, a current Science class topic. The visit complements a variety of hands-on projects and experiments that will be taking place over the next month. "I'm really excited" Karalexis says. "We've been getting a lot accomplished and the kids are making great progress academically."

Market icro Plant Studio—a creative new take on the traditional flower, plant and gift shop that opened two years ago in South Boston—is celebrating its two year anniversary and customer appreciation day on January 24, 2020, at 8 p.m. The Studio is located at 365 West Broadway near the corner of E Street and is conveniently accessible via the MBTA red line Broadway station and No. 9 bus.

Councilor Flynn Re-Files Four Hearing Orders *Focused on Eviction & Housing Stability, Public Safety, Quality of Life*

t a Boston City Council meeting, Councilor Ed Flynn has re-filed four hearing orders on issues related to housing stability, public safety, and quality of life issues. The hearing orders include:

Hearing to discuss ways to support tenants facing eviction and displacement: following property transfers, many long time tenants are getting evicted with limited notice and it can be very difficult for them to find new homes in a short period of time. Councilor Flynn hopes to have a conversation on providing longer eviction notice periods for tenants, so that tenants who have lived in properties for five years or more should be provided one year's notice to vacate following property transfers, along with information regarding resources available to assist with searching for new housing;

while seniors, the disabled, and lowincome residents should be afforded two years notice.

Hearing on issues related to stray voltage: for the last two years, following tragic incidents where pets were either harmed or passed away, Councilor Flynn convened working sessions with city officials, members of Boston's Street Lighting Division & the Department of Public Works, Eversource, and MSPCA to discuss efforts to address the potential dangers of stray voltage to residents and pets. Councilor Flynn plans to continue building on the city's progress last year regarding infrastructure improvements, coordination with stakeholders, and educational information.

Hearing to discuss safety of construction sites: most recently, a construction worker was struck and killed by equipment while setting up "First Night" celebrations in Boston late December. There was an incident where a woman was seriously injured by falling debris from a construction site in the North End in July of 2019. The hearing will discuss existing safety procedures and precautions at construction sites and ways that the city can ensure the protection and wellbeing of our workers and residents.

Hearing to discuss after hours construction and development issues: in the midst of a development boom, many neighbors have reported construction happening beyond permitted hours, which affects the quality of life for residents. The hearing aims to discuss the process for off hours construction and other relevant development issues, such as rodent control, as well as enforcement and accountability for violations.


"The hearing orders that I'm re-filing this week reflect the critical issues



of housing stability, public safety, and the quality of life for our residents," said Councilor Flynn. "From stray voltage to protections for our tenants, to making sure that construction companies abide by the rules and keeping construction sites safe, I believe that these are all important issues that warrant our attention. I look forward to these discussions at the Council in the months ahead."

The **Wine** Guy

Tuscany Tonight

Just like here, the weather in Tuscany is cold and raw. Some snow has fallen there this winter; actually, more than we've had so far this year. The days are partly sunny but the wind rolling through the hills and the short daylight cause families to retreat to the warmth of their kitchens; meals are hot and hearty-stews, braised lamb and Mushroom Fricassee with some hearty Toscana Rosso and homemade bread will be cooked tonight.

My friend, Elise Bauer, suggested the following recipe for the lamb: • Prep time: 15 minutes

• 2 Brown the lamb shanks: Heat the oil in a Dutch oven or an ovenproof, thick-bottomed, pot with a tight fitting cover on medium high heat on the stovetop. Working in batches if necessary, brown the lamb shanks in the pot on all sides. Remove shanks to a dish.

3 Sauté the onion, carrot, celery: Add onion, carrot and celery and sauté for 5 minutes, stirring often.
4 Add potatoes, then garlic, lamb, herbs, sherry, raisins: Add potatoes and cook another 2 minutes. Add the garlic, lamb shanks, and herbs (except for the mint). If using, add the sherry and raisins; bring the sherry to a boil and cook for 2 minutes.
5 Add stock, bring to simmer, put in oven: Add the stock and bring to a simmer. Remove from heat, cover the pot and bake in the oven for 1 1/2 or 2 hours or until shanks are tender.
6 Strip meat from bones: Remove the shanks, strip the meat from the bones and return the meat to the pan.

Try any (or all) of the following wines with this dish:

2016 Tommasi Poggio al Tufo Rompicollo, Maremma, Tuscany, Italy, (\$16.99). This is a beautiful blend of Sangiovese and Cabernet, full-bodied with dark berry notes, earthy tones and a surprisingly long, pleasant finish. This family has been making wine for generations; when Italy was first unified in the 1870s, this family was one of the first to receive a Royal Warrant from the then-ruling House of Savoy.

2016 Antinori Le Mortelle Botrosecco, Maremma, Toscana, (\$28.99). This estate is one of the family's five Tuscan properties and they've been making wines here for well over 100 years. This wine is made from a blend of Cabernet Sauvignon and Cabernet Franc, an intriguing, decisive wine with great balance that's a unique expression of the Maremma territory. Earthy notes of limestone, blackcurrant and plumbs give this one some real structure. You'll find several layers of chocolate, peppermint and a hint of tabac. Tremendous wine, especially on a cold winter's night.

Frescobaldi, Tenuta Perano Chianti Classico, 2016, (\$26.99). The Marchesi de' Frescobaldi is one of Italy's oldest wineries, with a history dating to the 1300s. The family has included medieval knights, bankers, lawyers and patrons of the arts. The Marchesi de' Frescobaldi is one of the most significant wine producers in Italy, with nine estates – and roughly 2,500 acres—in Tuscany. The Wine Spectator gave it 92points and called it,"a beautiful expression of ripe black cherry, black currant and violet notes, accented by graphite, tobacco and tar hints. Shows muscle, with some grip on the finish." It's at its peak from now through 2030.



RED SOX OUST Cora After MLB Investigation

he Boston Red Sox and manager Alex Cora "mutually agreed to part ways" on Tuesday night, just a day after Major League Baseball laid the hammer down on the Houston Astros for their use of technology to steal signs during their World Championship season in 2017.

Cora was the bench coach for that 2017 Astros team, and was also being investigated for bringing a similar sign-stealing scheme to the Red Sox when he became manager in 2018.

On Monday, Astros manager A.J. Hinch and general manager Jeff Luhnow were suspended for the entire 2020 season, and then were both fired by Astros owner Jim Crane. The Astros organization lost its first and second round draft picks in 2020 and 2021, and was fined \$5 million.

Before any punishment came down on the Red Sox, the team announced in a statement on Tuesday night that both sides believed it was best to call a divorce.

"Today we met to discuss the Commissioner's report related to the Houston Astros investigation," said a statement on behalf of Principal Owner John Henry, Chairman Tom Werner, CEO Sam Kennedy, and Alex Cora. "Given the findings and the Commissioner's ruling, we collectively decided that it would not be possible for Alex to effectively lead the club going forward and we mutually agreed to part ways."

Henry, Werner, and Kennedy said, "This is a sad day for us. Alex is a special person and a beloved member



of the Red Sox. We are grateful for his impact on our franchise. We will miss his passion, his energy and his significant contributions to the communities of New England and Puerto Rico."

Cora said, "We agreed today that parting ways was the best thing for the organization. I do not want to be a distraction to the Red Sox as they move forward. My two years as manager were the best years of my life. It was an honor to manage these teams and help bring a World Series Championship back to Boston. I will forever be indebted to the organization and the fans who supported me as a player, a manager and in my efforts to help Puerto Rico. This is a special place. There is nothing like it in all of baseball, and I will miss it dearly."

MLB Commissioner Rob Manfred's nine-page statement that explained the findings of the investigation into the Astros concluded that Cora was "involved in developing" Houston's sign-stealing scheme in 2017 in which they used a live center-field camera feed and the replay review room to decode and transmit the opposing team's signs.

Cora's punishment was expected to be just as harsh, if not worse, than that of Hinch and Luhnow.

EDELMAN ARRESTED IN BEVERLY HILLS

Edelman was released on a citation and is scheduled to appear in court on April 13.

Prior to the arrest, Edelman was shown on instagram to be hanging out with former Celtics star Paul Pierce and former Patriots wide receiver Danny Amendola.

Edelman, 33, will reportedly have offseason surgery on both his left knee and his left shoulder. He also played most of the season with partially torn rib cartilage.
