

U.S. health officials are expanding their checks of international travelers for signs of coronavirus. A source told WBZ-TV that coronavirus screenings will start at Boston's Logan Airport "soon."

The airport has so far not been screening passengers for coronavirus, because there are no direct flights from Boston to the hardest-hit areas. Nonetheless, direct flights from China cannot

Illegal Gun, Drugs off our Streets: Kudos to Law Enforcement

If you follow news in the neighborhood as well as read the official reports released by the BPD, you are aware that last Saturday, January 25th, the Boston Police from our own C-6 unit, in cooperation with the FBI, made an arrest of a 15 year old male suspect in possession of a loaded illegal handgun and some dangerous illegal drugs. It happened in the area of 91 O'Callaghan Way.

Law enforcement should be commended for their efforts that brought excellent results in the ongoing battle to keep South Boston's streets safe. Yet unofficial reports tell this newspaper that this one arrest of the above mentioned suspect could be just the tip of the iceberg and that armed adult drug dealers, believed to be organized, could be pulling the strings of young offenders and are constantly working to recruit more teens to do their dirty work for them. This is something all parents should be aware of and on the lookout for.

Activity like this is certainly not happening just in South Boston. In point of fact, it happens in every major city and so many suburban locations as well. But something



that our neighborhood has going for it while so many others unfortunately do not, is the willingness of residents to cooperate with police with the goal of ridding our town of the scourge of drug dealers and possible gang style activity. And this is why we continue to stress the importance of making those calls to police, anonymously if you prefer, when you have knowledge of, or even suspect criminal activity is taking place in your area.

It is cooperation with law enforcement that has helped put dangerous people in jail in the past here in Southie, it was cooperation that played some role in last Saturday's arrest and it will be that same type of cooperation that will continue to help keep residents safe in the future. Once again: Please, if you see something, say something.

Re: Recent comments from Redgate and Hilco Redevelopment Partnership

Dear Mr. Cox and Mr. Bialecki:

Like many residents of South Boston, we were upset to read about comments attributed to Redgate and Hilco Redevelopment Partnership's executive team following a recent public meeting on your proposal to redevelop the former Boston Edison Power Plant at 776 Summer Street. Commenting that your proposed redevelopment would bring "quality people" into the South Boston community, and responding to questions from residents with the reply "sorry...I wasn't born in a bathtub in South Boston," are derogatory, pejorative and insulting to our community, our neighbors and the constituents we represent.

We were especially disappointed that your team characterized these comments as part of a private conversation, which is never an excuse for divisive and disparaging language, and refused to apologize to the community at last week's public meeting, despite requests from elected officials in December and again from residents at the meeting.

These demeaning comments and this outrageous behavior are unacceptable and have no place in our public discourse. The South Boston community, and its residents, deserve a public apology from your team. We look forward to your response.



MAYOR WALSH RECOMMENDS 40 PROJECTS, OVER \$24 MILLION FOR COMMUNITY PRESERVATION ACT (CPA) FUNDING

The projects will be submitted to the Boston City Council for approval with an anticipated vote in the coming weeks

ayor Martin J. Walsh and the City's Community Preservation Committee (CPC) yesterday recommended 40 projects, totaling more than \$24 million, for inclusion in the next round for the Community Preservation Act (CPA) funding. The CPC held a public meeting yesterday to vote on the Mayor's recommended slate of projects for funding. The projects will be submitted to the Boston City Council for approval with an anticipated vote from the Council in the coming weeks.

"We're in the middle of a housing crisis that requires bold and creative solutions," said Mayor Walsh. "I'm proud that through this new round of funding, we are dedicating the majority of this funding round to affordable housing projects. All of these proposals will support our community in countless ways. We look forward to continuing to use this revenue to build on our work related to affordable housing, historic preservation and open space."

With this funding round, the City of Boston will have awarded over \$67 million to support projects in every neighborhood since residents voted to adopt the Community Preservation Act in 2016. After a thorough review process of the applications received, the following projects are being recommended for funding:

CITYWIDE

- \$4,000,000 for the Acquisition Opportunity Program to prevent displacement by purchasing existing private market rental units and making them permanently affordable, both protecting current tenants and safeguarding the City's affordable housing stock
- \$4,000,000 for the ONE+Boston program to help income-eligible first-time homebuyers receive downpayment assistance and a permanent

reduction in the interest rate of a 30year fixed-rate mortgage for Bostonians buying within city limits

CHARLESTOWN

- \$400,000 to the John F. Kennedy Family Services Center to restore the slate roof and prevent water damage to the historic school building that provides child care, after school, and senior services
- \$20,000 to the USS Constitution Museum to protect its collections by relocating the

CHINATOWN

- \$1,000,000 to the Parcel P-12C development on 290 Tremont Street that will provide 58 rental units, including 11 units set aside for formerly homeless individuals and families. The units will be part of a larger proposed mixed-use affordable housing project on a Boston Planning & Development Agency (BPDA) owned parking lot
- \$500,000 to the Asian Community Development Corporation to purchase a vacant lot near the Chinatown Gate and Rose Kennedy Greenway for transformation into a neighborhood garden and gathering space

DORCHESTER

- \$800,000 to Norwell Street Park to build a new park on four parcels of open space adjacent to Talbot Avenue Station on the Fairmount Line
- \$250,000 to the Franklin Field Seniors Garden to build a new community garden for residents of Franklin Field and surrounds
- \$400,000 to restore the steeple of the Second Church in Dorchester, one of the oldest wooden churches left in Boston, built in 1806 and home to a Paul Revere bell
- \$730,000 to the Dr. William W. Henderson Inclusion School for a new, fully accessible playground and school yard on its lower campus
- \$150,000 to the Magnolia Street Garden to develop a per-

manent community garden and neighborhood plaza after serving as an informal gardening space for several years

• \$20,000 to First Parish Dorchester, built in 1897, to remove and restore the Palladian window and complete the window restoration on the only Colonial-Revival clapboard meetinghouse in Boston

EAST BOSTON

• \$400,000 to purchase the Donald McKay House, a Greek Revival style house built in 1844 by Donald McKay, the country's premier clipper ship designer, to preserve as a community asset

ROXBURY

- \$150,000 to the Egleston Peace Park to renovate this heavily used community space for arts, passive use, and neighborhood events
- \$250,000 to Oasis @ Bartlett to create a new arts park for the community and for the residents of Bartlett Yard, a new affordable housing community near Nubian Square
- \$40,000 to the Shirley-Eustis House to restore the wood shingle roof of the 1806 Carriage House to enhance its functionality as an accessible space for education, programs, and community use at the Georgian house museum
- \$400,000 to the Nubian Gallery to restore the neo-Classical facade of the former Hamill Gallery on a surviving 19th-century commercial block in the Dudley Station Historic District
- \$250,000 to the Dr. Marie E. Zakrzewska Building to continue restoration of the historic windows, so that the Dimock Center can create a residential recovery program in the space for men with substance use disorder
- \$400,000 to the Eliot Congregational Church, built in 1873, to restore the facade and roof in preparation for reuse of the underutilized spaces as affordable housing and a



commercial kitchen

- \$1,500,000 to the Fountain Hill development, creating 26 affordable homeownership opportunities in the Tommy's Rock neighborhood
- \$750,000 to 2147 Washington Street in Nubian Square to contribute to the fund to build eight new affordable homeownership units for first-time homebuyers
- \$1,000,000 to the Madison Park Community Development Corporation to contribute to the fund to build 15 new affordable units for first-time homebuyers at 75-81 Dudley Street. The units are part of a 20unit, 100 percent affordable project recently approved by the BPDA at this location

SOUTH BOSTON

- \$150,000 to Barnard Place to create a small park with planting beds, benches, and a bocce court
- \$75,000 to the Kearsarge Memorial in Marine Park to replace the crumbling base and missing interpretive plaque, and restore the 1898 anchor honoring naval veterans of the USS Kearsarge, a class of battleships including one active ship in service today

ABOUT THE COMMUNITY PRESERVATION ACT (CPA)

After Boston voters adopted the CPA in November 2016, the City created a Community Preservation Fund. This fund is capitalized primarily by a one percent property taxbased surcharge on residential and business property tax bills that began in July 2017. The City uses this revenue to fund initiatives consistent with statewide CPA guidelines: affordable housing, historic preservation, and open space and public recreation. The funding of any project requires a recommendation from the Community Preservation Committee and appropriation by the City. For more information, please visit the Community Preservation webpage.

REP. BIELE VOTES IN SUPPORT OF LEGISLATION TO EXPAND ACCESS TO SCHOOL BREAKFAST AND NUTRITION

Recently, Representative David Biele joined his colleagues in the House of Representatives in unanimously passing legislation to ensure Massachusetts' students have access to breakfast after the beginning of the instructional day, while supporting the health and education of the Commonwealth's most vulnerable students.

The legislation, entitled An Act Regarding Breakfast After the Bell, requires public schools where 60 percent or more of the students are eligible for free or reduced-price lunch to offer its students breakfast options after classes begin. The legislation will increase access to healthy breakfast for 150,000 low-income students in the Commonwealth and provides

schools the flexibility to use the model that best suits its students, such as: breakfast in the classroom, grab and go breakfast, or second chance breakfast in the cafeteria.

"The evidence shows that students perform better at school when they've eaten a nutritious breakfast, unfortunately one in eight students in Massachusetts struggle with food insecurity and start the day hungry," said Rep. Biele. "This legislation will ensure that every student has access to breakfast so that they are well-fed and ready to learn, leading to better outcomes in the classroom with increased attentiveness and participation, and better overall health in our students."

This legislation builds on the House's ongoing efforts to prioritize

programs that support the health, wellbeing and academic success of the Commonwealth's most vulnerable children. Providing breakfast to students has been shown to improve concentration, increase school attendance and decrease tardiness and visits to the school nurse. It also serves to destignatize traditional school breakfast programming by supporting an all-inclusive schoolwide option.

The bill also directs DESE to issue guidance or regulations in order to implement programming, allowing for consultation with nonprofit organizations with experience regarding the opportunity gap, hunger and food security issues, and best practices for improving student access to school breakfast.



Similar legislation recently passed the Massachusetts Senate and next steps will involve reconciling differences in the two pieces of legislation.

House Speaker DeLeo Congratulates Tommy Lyons

Named Board Chairman for Chelsea Soldiers Home

here are some people who are well known for all the great work they do on behalf of others. And when it comes to working for the good cause of assisting our nation's veterans, one of the names that always stands out is of course Thomas 'Tommy' Lyons. The Speaker of the Massachusetts House, Robert DeLeo, has now congratulated him for yet the latest honor bestowed on this good man.

Tom Lyons is now the Board Chairman of the Chelsea Soldiers Home. If you've ever travelled along Massachusetts Route 1 north-bound, you've seen the Chelsea Soldiers Home on the right-hand side, positioned majestically on the hillside. It will now have the expertise and professionalism of Tom Lyons to help oversee and assist with the excellent job the facility does on behalf of the veterans who reside there.

Tom Lyons is a well known and well liked native of South Boston, a Marine Corps veteran of the Vietnam War and has provided decades of distinguished service to veterans and veterans' causes. He is a founding member of the committee that created the South Boston Vietnam Veterans Memorial and the founder and presi-

dent of the Boston Semper Fidelis Society, which every November hosts the nation's largest annual Marine Corps Birthday luncheon from which proceeds benefit veterans and their families through various programs and scholarships.

In 2014, he was honored by the Marine Corps Scholarship Foundation for his many years of work on behalf of veterans their families. The Tommy Lyons Scholarship was created in his name for the child of a Marine Corps or Navy Corpsmen veteran.

Lyons is a former Vice President of External Affairs at MassHousing. He spent 10 years as Boston's Deputy Commissioner for Veterans and seven years as Executive Director of the New England Center for Veterans before joining MassHousing. He was chairman of the committees for the Congressional Medal of Honor Society's annual conventions in Boston in 2001, 2006 and 2015.

In 2012, Lyons was appointed as Chairman of the Massachusetts Veteran and War Memorial Commission. The five-member commission, created by the Legislature through the Acts of 2012, is charged with evaluating and making recommendations "on an equitable method for



awarding funding for the upkeep, maintenance or repair of veteran or war memorials within the Commonwealth." In 2011, Lyons was appointed to a national advisory committee on homeless veterans by former U.S. Secretary of Veterans Affairs Eric K. Shinseki. By any standard, this is an impressive resume of public service.

Maura S. Doyle, Clerk of the Supreme Judicial Court, Named 2020 SBCA General Chairwoman

lerk of the Supreme Judicial Court, Maura S. Doyle will serve as General Chairwoman of this year's Evacuation Day activities, which will begin with the Jimmy Flaherty Kick-Off Breakfast on Saturday, Feb. 29 at 10 a.m at the Seapoint Restaurant, where the presentation of the Henry Knox Unsung Hero awards will be presented.

The Breakfast will be followed by a host of community events which include The Senior Salute, 11 a.m. - 1 p.m. (Sponsored by Mayor Walsh and the SBCA) on March 7 at St. Peter's Lower Church Hall, and the 140th Annual Evacuation Day Banquet on Friday, March 13 at the South Boston Convention Center. Please note that with the St. Patrick's/Evacuation Day Parade being held on Sunday, March 15, the Memorial Mass will be at 9 a.m. followed by the Historical Exercises at The Dorchester Heights Monument on Tuesday, March 17.

On Oct. 7, 1996, the Justices of the Supreme Judicial Court announced their unanimous decision to appoint



Maura S. Doyle as Clerk of the Supreme Judicial Court for the County of Suffolk. On Oct. 21, 1996, Mrs. Doyle was sworn in and became the first woman to hold this position since its inception in 1693. And on Nov. 3, 1998, she became the first woman elected to Suffolk county-wide office.

As Clerk, Maura Doyle is responsible for the management of the court's single justice caseload, which is comprised of petitions seeking relief of lower court rulings under the SJC's superintendency power and various rules of court; bail reviews; appeals from State registration boards and agencies; and all matters concerning the admission of attorneys to the Massachusetts Bar, as well as, attorney discipline.

In addition to managing the Court's single justice caseload, Mrs. Doyle has been credited with instituting numerous management initiatives to improve the operation of the Clerk's office, increasing the public's access to court records and modernizing the storage and retrieval of County Court records.

Mrs. Doyle received a Bachelor of Science degree in Criminal Justice, cum laude, from Northeastern University in 1977 and a Juris Doctor from Suffolk University School of Law in 1981. She has been a member of the bar since 1981. Before joining the SJC's Clerk's office in 1992 as an Assistant Clerk, she was a civil litigator in the state and federal courts for 11 years and served as an adjunct professor at Suffolk University Law School.

Mrs. Doyle is a guest lecturer at bar association meetings across the state, MCLE and CPCS training sessions and law school forums. She is currently a member of the SJC's Standing Advisory Committee on Civil and Appellate Rules, the SJC's Information Technology Steering Committee for the Appellate Courts, and the SJC's Standing Advisory Committee on Professionalism. She is currently a member of the Board of Directors and Vice President of The Catholic Lawyers Guild of the Archdiocese of Boston, a member of the National Conference of Appellate Court Clerks, and a member of the Board of Harbor Health Services, Inc.

In 1998, she was inducted into the YWCA's Boston Academy of Women Achievers for her demonstrated leadership and accomplishment in her work and community. In May of 1999, Mrs. Doyle was named as the recipient of The McDermott Award for her outstanding alumni contribution by Suffolk University Law School's Student Bar Association. On June 2, 2000, she was presented with the 2000 Alumni Achievement Award at Pope John XXIII High School's Commencement ceremony.

This award is presented annually at the graduation ceremony to an individual who demonstrates outstanding achievement in a professional, religious or civic field of endeavor.

Mrs. Doyle lives in Dorchester with her husband, Attorney Frank Doyle. They have three grown children.

"The executive board and I look forward to working with Maura, to ensure once again the success of this unique community celebration, the commemoration of the British evacuation of Boston in 1776," said South Boston Citizens' Association President Tom McGrath. "Everyone is aware of her commitment and genuine devotion to South Boston Community. She has been an active participant in the South Boston Citizens Association from the early days of past Presidents Tommy Butler and Bernie O'Donnell. She has been assisting the Executive Board with all the behind the scenes work that helps put on these events for the past 25 years. Her dedication to the South Boston Citizens' Association and the neighborhood of South Boston are greatly appreciated. We are honored to list her as a member, and even prouder to name her this year's General Chairwoman. She may even tell a joke or two."

While the citizens of South Boston see the three weeks of celebration with each year's Evacuation Day, there are another 12-15 weeks of preparation to put it all together.

"Maura works side by side with other dedicated SBCA members in those hectic weeks, licking stamps, making phone calls and doing whatever it takes," said McGrath.

unequivocally affirm that those travelers from the Wuhan area have not traveled through other parts of China to travel here.

China has confirmed more than 4,500 people with the new illness, which can cause pneumonia, and more than 100 deaths. So far, there are five confirmed patients in the U.S., and no sign that they have spread the illness to anyone around them. They had all traveled to the center of the outbreak.

Two people in New Hampshire are undergoing tests for corona-

virus after they recently traveled to Wuhan and developed respiratory symptoms. Health officials stressed Tuesday that the risk to Americans so far is very low. For "the individual American, this should not be an impact on their day-to-day life," Health and Human Services Secretary Alex Azar told reporters.

While reports from China suggest that people there may have spread the illness before showing symptoms, there is no evidence of that in the U.S., stressed Dr. Robert Redfield, director of the

Centers for Disease Control and Prevention. And while some other viruses are known to occasionally spread before symptoms are obvious — such as the flu — health officials say that's far less of a concern than the obviously contagious patients.

The CDC already has been checking arrivals at five U.S. airports that once had direct flights from the hardest-hit section of China. While China has instituted broad travel bans, people who had been in other parts of China still may be arriving via other countries.

The CDC is now beefing up screening at 15 more "quarantine stations" around the country, airports and other places where health workers regularly check arriving travelers for signs of illness. But travelers may not be sick right then, CDC's Dr. Nancy Messonnier said. The screenings also are an opportunity to educate travelers that if they develop symptoms such as fever or a cough — after returning from the outbreak zone, they should contact their doctor, she said. That's exactly what the first two U.S. patients did.

SENATOR COLLINS VOTES TO ADVANCE BUS IMPROVEMENT LEGISLATION

All MBTA Buses to be Zero-Emissions by 2040

ast week, the Senate Committee on Ways and Means advanced a series of bills aimed at addressing climate change and reducing emissions. Included in the package was S.2476, An Act to Accelerate the Transition of Cars, Trucks, and Buses to Carbon-Free Power.

This legislation directs the MBTA to limit purchases and leases of buses in its fleet to zero-emissions vehicles by 2030. That means more effective vehicles that do not contribute to environmental pollution in our communities, and ultimately improves our air quality,

asthma rates, and quality of life. The bill calls for a fully emissions-free bus fleet by 2040.

"Reducing emissions and improving air quality in our communities is a top priority," said Senator Nick Collins, who voted for the measure. "Children, seniors, and persons with asthma and other respiratory conditions are impacted every days by growing vehicle emissions in the city, and this legislation is a big step forward to reducing that, and protecting our environment."

The legislation also requires all state vehicles to be zero-emissions starting in 2024, and studies the feasibility of require public municipal



vehicles to do the same. The full Senate plans to take up this bill, and several other climate bills as part of a Next-Generation Climate debate on Thursday, January 30.

Councilor Flynn Files New Hearing Orders

Focused on Traffic, Public Safety, Census Outreach, and Disability Rights

ouncilor Flynn is filing four new matters at this week's Boston City Council meeting, including three hearing orders and one resolution. These matters reflect some of the important issues facing the city, including:

Hearing to discuss establishing a traffic master plan for South Boston: In partnership with Councilor Michael Flaherty, the Councilors call for a hearing on the establishment of a traffic master plan for South Boston to assess the neighborhood's short-term and longterm transportation needs and capacity. South Boston is in the midst of a development boom with large developments on all major corridors, and the added density and people will greatly impact traffic and transportation in South Boston. A South Boston traffic master plan will help the city and residents better understand the potential impact of upcoming developments on traffic and congestion for the neighborhood.

Hearing to discuss security at high-rise garages in the City of Boston: Over a period of seven months, there were three inci-

dents involving five deaths at the Renaissance Park Garage, all of them suspected suicides. Another person tried to jump from a six-story garage in Brighton earlier this month. These tragic incidents have called attention to the security at high rise garages in the city, as well as suicide prevention resources for those in distress. In partnership with Councilor Kim Janey, the hearing order calls for a discussion on how the city should work with parking garage operators to prevent tragedies like those that occurred at the Renaissance Garage from happening again, as well as ensuring access to mental health resources and counseling.

Promote a complete and accurate count of the 2020 Census in the City of Boston: The 2020 Census will be critical in determining how federal funds are distributed in our community, including benefits for SNAP, Medicare, Section 8, Head Start, and many other federal programs. Boston is ranked as the ninth hardest to count in the list of 100 largest cities, and the city must do what it can to ensure hard to count communities



like immigrants, non-English speakers, students, and renters are included in the census count. The census will also determine the number of congressional seats in our state, as well as the boundaries of local, state, and federal legislative districts. With Councilor Michelle Wu as the co-sponsor, the hearing will discuss ways and resources needed to ensure a complete and accurate count of the 2020 Census in Boston.

Resolution recognizing National Braille Literacy Month

in the City of Boston: January is designated as National Braille Literacy Month to promote and raise awareness of the importance of the Braille code to the blind and visually impaired community. Braille literacy is an important way for those with visual disabilities to attain independence and employment, yet in recent years, Braille literacy has fallen among the blind and those with visual disabilities as a result of increased reliance on audio and text-to-speech technology. This resolution affirms the City Council's support for the blind and visually impaired community and recognizes and honors January as Braille Literacy Month in the City of Boston.

"The matters that I filed this week at the City Council reflect some of my top priorities, such as quality of life issues like transportation and public safety, as well as ensuring an accurate count of the 2020 Census, and bringing awareness to disability rights," said Councilor Flynn. "I want to thank Councilors Flaherty, Janey, and Wu on partnering with me on these hearing orders, and look forward to our continued work on these issues."





or the first time in a long time, this year's Super Bowl hasn't been the most important story in sports, leading up to the big game.

Our attention has instead been turned to the tragic death of Kobe Bryant and his 13-year-old daughter Gianna. The shocking news of their helicopter crash on Sunday has put many people in a state of shock. You don't even have to be a sports fan to feel this one.

Here is my pick for Super Bowl LIV:

SAN FRANCISCO 49ERS (+1) over Kansas City Chiefs

Defense wins championships. And right now, I couldn't possibly put my money against this 49ers defense. Not even with Patrick Mahomes on the other end.

Look, let's get something out of the way here. I'm extremely disappointed that the New England Patriots are not in this game. The Pats have played in four of the last five Super Bowls, including the last three, so I'm not going to lie, it's tough to get into this one.

Am I rooting for San Francisco quarterback Jimmy Garoppolo because he used to be a Patriot? Not at all. In fact, if I had no money on the line, I'd probably be rooting against Garoppolo, knowing that if he wins a Super Bowl in his first full (non-injured) season with the 49ers, that'll just open the floodgates to more Patriots criticism about how Bill Belichick should've never traded him, blah, blah, blah.

Me, personally, I've moved on from Garoppolo. I'm all in on the rest of the Tom Brady era in New England, assuming Brady stays, which I do think he will. But I just wanted to address the elephant in the room with Garoppolo. I'm only rooting for him on Sunday because I'm betting his 49ers to win the game.

And I'm only betting the 49ers to win the game because of their defense.

San Francisco has allowed just 15 points per game in the playoffs, which ranks No. 1 among the 12 teams that were in the playoffs. Meanwhile Kansas City allows 28 points per game. The 49ers have also created five turnovers in their two playoff games, while the Chiefs have only created one.

But a couple turnovers could help him out with either some great field position against a questionable Chiefs defense, or maybe even just points off those turnovers.

Again, I just can't pick against this San Francisco defense. Which means I'm taking the 49ers to win Super Bowl LIV.

The sports world was rocked on Sunday by the news of Kobe Bryant's tragic death in a helicopter crash in California.

Also killed was Orange Coast College baseball coach John Altobelli, the father of Boston Red Sox scout J.J. Altobelli. J.J. Altobelli's younger sister, Alyssa, and stepmother, Keri, also died in the crash.

Red Sox Chief Baseball Officer Chaim Bloom released the following statement:

"The Red Sox are devastated by the news of [Sunday]'s tragic helicopter crash in Southern California. We are heartbroken for the victims and their families, including John Altobelli, father of Red Sox scout J.J. Altobelli, John's wife Keri, and their daughter Alyssa. John touched so many lives in his 27 years coaching at Orange Coast College, and we join the entire baseball community in mourning him."

REPORTS: RED SOX TALKING TO THREE **TEAMS ABOUT MOOKIE BETTS**

ccording to multiple reports, the Boston Red Sox are currently engaged in trade talks with three teams for outfielder Mookie Betts. Those three teams are the Los Angeles Dodgers, San Diego Padres, and Arizona Diamondbacks.

The Boston Globe's Alex Speier

reported earlier in the week that the Red sox are discussing the options of acquiring a "combination of big leaguers and prospects." Speier indicates that there's no guarantee Betts will get moved before the start of the regular season, but also says the team's willingness to consider trading Betts "appears serious."

Betts, 27, will be an unrestricted free agent after the upcoming 2020 season. The expectation is that Betts will be seeking a long-term contract of at least \$300 million. According to reports, Betts rejected an eight-year, \$200 million offer from the Red Sox after the 2017 season.

The Red Sox have publicly expressed their desire to cut payroll this winter in order to get below the league's luxury tax threshold.

Trade rumors involving Betts' name also come at a time in which the organization is still searching for a new manager. Alex Cora was fired two weeks ago, and the Red Sox have yet to replace him as of Wednesday afternoon.

Pitchers and catchers report to spring training in less than two weeks, on Tuesday, Feb. 11. Positional players report on Sunday, Feb. 16.

The Red Sox' first spring training game is Saturday, Feb. 22 against the Tampa Bay Rays.
