

MAYOR WALSH NAMES KATHRYN R. BURTON AS CHIEF OF STAFF

ayor Martin J. Walsh announced that he has appointed Kathryn R. Burton as his Chief of Staff, effective March 9. "Kathryn brings a wealth of public policy experience to the City of Boston, and I am proud to appoint her as my Chief of Staff," said Mayor Walsh. "From her wide ranging background across sectors, it is clear that she is someone who is smart and driven, and who has a keen sensibility of the opportunities and challenges we face as a city. Her commitment to common sense solutions will be a valuable asset as we work together to carry out our wide-ranging and progressive agenda of bold initiatives to move Boston forward."

As laid out in the Mayor's State of



the City address delivered in January, "together we've made Boston the safest, healthiest, most dynamic, productive and inclusive it's ever been... We are number one in the country for subsidized, affordable housing. We are number one for access to open space. We are ranked number one most energy efficient, climate-friendly city in the United States of America... It's an exciting time for Boston, but there's a lot of work still to be done."

As Chief of Staff for Mayor Walsh, Burton will focus on accelerating the implementation of the Mayor's priorities, ensuring the effectiveness of city services, and supporting over 18,000 employees in doing their jobs at the City of Boston. Burton previously served as Chief of Staff for then-Massachusetts Treasurer Steven Grossman.

"I am honored and humbled by this appointment, and I thank Mayor Walsh for the opportunity to serve the city I love and call home," said Burton. "I look forward to helping Mayor Walsh achieve his ambitious goals for the city and being part of the team that is leading the charge in making Boston a better place for all."

Burton is currently Director of Operations for New Boston Ventures, a role she has held for the last four years. During her tenure with Treasurer Grossman, the Treasury oversaw a \$9.6 million operating budget, managed the Commonwealth's deposits, and issued approximately \$3 billion in bonds per year, as well as overseeing the Massachusetts Lottery and state pension funds. She also previously served as a senior official at the Barbara Lee Family Foundation and the Barbara Lee Political Office, which has been a leading force in supporting and electing women in politics.

As part of her work in the community, Burton currently serves on the Boston Children's Museum's Board

of Overseers and the Beacon Hill Nursery School Board of Directors. She is a past Vice-Chair of the Rose F. Kennedy Greenway Conservancy Board of Directors, where she was part of the negotiation of a landmark multi-party funding agreement signed in 2017 that solidified State support and brought new funding from the City and adjacent property owners via the Greenway Business Improvement District. During her tenure, the Greenway received national acclaim for its public art, including more Americans for the Arts awards than any other nonprofit in the country.

Burton is a member of the Gesgapegiag Mi'kmaq tribe in Quebec, Canada and will be the first Indigenous person in a Cabinet-level position at City Hall. Leroy Denny, Chief of Eskasoni Mi'kmaw First Nation in Cape Breton, Nova Scotia, said, "In our community, people earn the highest esteem from serving others. We know that Kathryn will work hard for the mayor and the people of Boston and we honor her service." Burton holds an undergraduate degree from the University of King's College in Halifax, Nova Scotia and a graduate degree from Dartmouth College. She resides in the North End with her husband, Chad Jackson and two boys Miles and Graydon.

South Boston Youth Partner With The Improbable Players

Verybody knows somebody whose life has been adversely affected by alcohol and other drug abuse. Improbable Players present performances and drama workshops that feature actors who are all in long-term recovery and who get audiences thinking and talking about the issues.

During the month of February, youth from the SB Community Health Center's Youth Ambassadors program, the SB Neighborhood House Girls and Guys group and the SB Boys and Girls Club Keystone Leaders participated in a series of substance misuse prevention drama workshops facilitated by the Improbable Players that culminated with a professional performance of the play "I'd Never Do That", held at the SB Boys and Girls Club auditorium.

The workshops explored many topics associated with alcohol and other drug abuse such as peer pressure, the impact of addiction on families and factors that

contribute to addiction. The youth were empowered as peer educators as they learned facts about substance use disorder and recovery. In keeping with the improvisational theater aspect of the workshops, the teens created skits depicting scenes focused on addiction and discussed strategies and solutions for dealing with the problem.

In the final performance, "I'd Never Do That", the actors delved into the negative effects of addiction on families and the hope for recovery. The evening ended with teens joining the actors on stage to declare what they hate about addiction in their community.

Partnerships such as this are part of the ongoing effort to educate youth about the dangers of substance misuse and connect them with supportive services in the South Boston community. These efforts are generously funded by the P & G Gillette Great Starts grant and the Boston Police Positive Youth Development Fund Initiative.



The Wine Guy Down A Lazy River

It would seem that Spring is making a strong effort to not only get here, but to stay. The same thing is happening in other places, too; Europe, despite the Coronavirus issue, is reporting warmer weather across the board. Has anyone heard about virus-related issues in Germany? Probably not, since some of the warmest temperatures on the Continent have been

reported from there.

Two good things about warm early Spring temperatures: they help dissipate the force of things like the virus and they give wine grapes a substantial head start; it appears that's the case this season for the Mosel region. This region of Europe has been a natural trading hub since Roman times and wines from places like Bernkastel and Ruwertal were prized across the Roman Empire for their crispness, fruity overtones and supple acidity- traits that still define them today.

Long before Krupp steel for the war efforts of Germany in the first half of the last century were forged in the Saar, Riesling put the region on the map. With that background, let's go down this river and look at a few of its many stand-out wines.

DR HEIDEMANNS BERNKAS-TEL KABINETT, 2017, (\$19.99), is an excellent place to start as it's the embodiment of everything that's great about Mosel wine. Notes of pears, apricots and mountain flowers give way to an off-dry wine with beautiful acidity, moderate ABV and good structure. This wine and others from its category are really versatile food wines-fruits, cheeses, seafood and white meats all taste better when paired with this wine type.

Without question, the finest Riesling in all of Germany is produced in the vineyards of Joh. Jos. Prum and it's been so for over 100 years. The management of everything, from the composition of the soils to the grade of yeast used in fermentation, is carefully consistent with every vintage. If you have a special occasion, try a bottle of Graacher Himmelreich, preferably the 2016; if you have that bottle and don't have an occasion, invent one.

Ulrich Langguth Piesporter Michelsberg Guntslay, Spatlese, (\$29.99) Piesport, Mosel-Saar-Ruwer, Germany- 100% Riesling from the Piesporter Gunterslay vineyard on the slate composed slopes. A perfectly elegant late harvest wine of great volume and depth, this wine is a great accompaniment to spicier foods, especially Chinese



or Indian. You should also pour it with stronger cheeses, like Stilton or Bleucheese.

2016 Dr. Loosen Urziger Wurzgarten Riesling Spatlese, (\$29.99), Ripe, rich tangerine, apricot and peach flavors jump right out of this light-bodied yet powerfully fruity spätlese. You should taste the savory acidity right away, along with a long and surprisingly deep finish. Try this one with Sicilian Chicken or Bratwurst and sauerkraut-fantastic!





"The Heights"

Our former editor and native son, the late Brian Mahoney, was all things South Boston – its history and its celebrations, especially the combined Saint Patrick's and Evacuation Day. In his memory, we are pleased to re-print his popular historical series.

The second of a 3-part series on the History of Evacuation Day

he British conducted their last and most destructive raid into South Boston (Dorchester Neck) on February 13, 1776, burning houses and property of the Blake, Wiswell and Foster families among others. This time however, the Americans responded with 300 mounted troops, causing the British to flee in their longboats. It was this raid which seems to have been the final straw. Washington had been advocating for a frontal assault across the ice from Cambridge and Roxbury. His military council disagreed and after his final council of war on February 26, Washington wrote, "I am preparing to take a position on Dorchester Heights to see if the enemy will come out to meet me." He had reversed course and decided the Americans would fight from fortified positions and force the British to make the frontal assault.

On the morning of March 2, the Americans opened a three-day bombardment of the British in Boston. Under an advance protective screen of 800 infantry, 2,000 artillery men began their stealthy advance into South Boston. With muffled horses' hooves and wagon wheels, this column began to snake its way up the "Turnpike" (Dorchester Street). Reaching the area of today's "Telegraph Street", nine cannons for three artillery batteries were muscled up to the peak of the "Twin Hill."


The column continued up the "Turnpike" until it reached today's Perkins Square area. There, a sloping hill began to rise, extending west toward the West Broad-

way parking lot and north toward Dorchester Street and Emerson Street. This hill was known as "Leek's Hill" and was designated for 7 cannons. Emerson Street, the second of South Boston's original remaining streets, was called the "way to the Castle" and extended all the way to the east shore (Farragut Road). The column moved on this road to roughly "M" & East Fourth Street. At this point, six cannons were dragged up to "Bush Tree Hill" where their muzzles towered menacingly over the British warships at anchor. The last leg of the eastern march ended at Dorchester Point where a single three-gun battery was placed.

Back at "Leek's Hill", 700 men and 10 cannons skirted the western base and followed "Pulaski Ave." to West Third Street. This third and final road was known as the "Way to the Nook." This road reached, straight as an arrow, to the 125 foot high "Nook Hill" located at today's "B" & West Third Street. This hill was closest to British positions and warship anchorage so presented the most danger to the British. At the same time, its nearness made it the most exposed to British fire. It was decided by the Americans to fortify this hill last.

The cannon's movement and the actual construction of their fortifications was a master stroke itself. Besides wrapping hooves and wheels in rags to muffle sounds, the Americans took a number of pre-emptive measures that led directly to victory.

The crossing into the "Neck" would have been under the eyes and guns of the British, particularly the "Green" artillery position located on a rise at today's Berkeley and Washington Streets intersection. The American created a "Blind" or a wall that would cover



their movements by twisting and weaving hay. This was called "Screwed Straw". Washington, for weeks, had his troops out in the "Wilderness" of Dorchester collecting thin tree branches and kindling. This was used to build "Fascine" or walls around cannon positions; usually by digging a trench and combing dirt and branches to make those protective walls. The frozen ground plus the need for secrecy made digging impossible. The solution was called, "chandelier". These were simply 10 by 4 foot skeletal wooden tubs. Light, mobile, easily moved into position around the cannons, filled with the "Fascines" and immediately turned into sturdy defensive walls.

During the next three days, the men labored to erect defenses while the non-stop bombardment of Boston provided cover their actions. A bombardment so fierce that famed jurist, Oliver Wendell Holmes, later wrote and spoke of it in a childhood memory. As a Boston schoolboy in the 1850's, Homes recalled passing everyday by a house which still has "cannonball embedded in its chimney since that barrage".

Over the centuries, Americans have been stirred to the defense of their country, in part by words identifying their cause. "Remember 911" is most recent. Before that it was "Remember Pearl Harbor". Earlier, "Remember the Maine". Still earlier, "Remember the Alamo". It was on the "Heights" that call to battle was first used as General Washington walked among the troops exhorting them to "Remember the Men of March the Fifth". Speaking of course, of the "Boston Massacre" six years earlier.

Upon awakening on March 5, 1776, General Howe first noticed the silenced cannons. Next, across the harbor, was the astonishing sight of the "Heights" bristling with troops and cannon from four positions. He then made his famous statement, "These men have done more work in a night than mine could do in a month." Undeterred, Howe immediately drew up plans to attack across the harbor and dislodge the Americans from the Heights. All day, Boston was the scene of increasing alarm as British troops hustled about preparing for battle. Longboats were brought from the warships to ferry the troops for the assault and tied up at "Long Wharf". By late afternoon, 2,400 troops were lined up at the foot of "Long Wharf", today's Purchase Street.

There were so many battles over the decades and she was there for them all.

Jane DuWors was active in politics as well. Along with being a candidate for public office herself, she would lend her expertise to candidates and elected officials she believed in. She was a close confidante of the late Boston City Coun-





cilor James M. 'Jim' Kelly as well as several other officials whom she felt would be beneficial to the people of South Boston if elected.

In addition to her tireless work on

behalf of her community, there was another side to Jane DuWors that this town knew well. She was kind, gentle, compassionate and caring of others. She was a wonderful mother to her sons Billy, John, Jim and Jody and a sweet and doting grandmother to her grandchildren as well. If friends or neighbors were in need of assistance, Jane would not hesitate to offer a helping hand. She could be counted on to be by their sides to help get them through their problems. She was that kind of a person, but never did it for recognition. She did it out of love and genuine and sincere concern.

It is said that whenever a true son or daughter of South Boston passes on, there is an emptiness that is felt throughout the neighborhood. And that is certainly the case with the loss of Jane DuWors. Jane will be mourned and missed by many but with all the good deeds she did during her entire life on behalf so many, there is no doubt that she will be rewarded in Heaven.



And instead of just moving on and starting over with a new team — under the same \$217 million contract the Red Sox gave him, by the way — Price just couldn't let it go when asked about escaping the media in Boston.

"It's such a big difference from Boston to here," Price told Nightengale. "Really, it's night and day."

Nightengale goes on to describe Price's amazement of how few LA media members wanted to talk to him after he threw to hitters for the first time since wrist surgery in September.

"That was a big day for me, a very big day," Price told Nightengale. "I came in, got undressed, showered, came back to my locker, and stood there for 10 or 15 minutes. There were maybe two or three [reporters] hanging out, talking to other guys, and nobody came over to talk to me about my day. I couldn't believe it."

My first reaction to that is, "Wow, sounds like nobody in the media was doing their job that day." My second reaction to that is, "Shut up."

This guy was so hurt by the media in Boston that he was bracing himself for — get this — actual questions about his recovery from surgery while being a guy who gets paid over \$30 million to throw a baseball every fifth night. But now he's realizing that maybe he doesn't have to answer as many questions in LA, or maybe now he won't be criticized as much as he was while he was in Boston.

Finally, Price is happy!

Poor guy. It must've been horrible making \$30 million a year while in Boston. It's tough earning an average of \$2.5 million per month. Imagine making \$1 million every time you had to go to work? That must be absolutely terrible! How could anyone understand that type of struggle? Talk about a total grind!

Please.

Price is still looking for sympathy for how "bad" he had it in Boston. Well, he won't be getting that sym-

pathy from me. And he shouldn't get it from you either.

Credit where it's due. Price should've been the World Series MVP in 2018. He got the Postseason monkey off his back and helped the Red Sox win a championship. He should be praised for that.

But nobody wants to hear him continue to complain about how the media treated him in Boston. He looked foolish when he complained about it while he was here. He looked even worse when he confronted Hall of Famer Dennis Eckersley about it on the Red Sox plane. And he looks awful while still talking about it to a national baseball columnist as he prepares for a new chapter with a new club.

Next time Price picks up the world's smallest violin and tries to complain about his "grind" in Boston, somebody close to him should whisper in his ear:

"Nobody cares."

SALE HAS MRI ON ELBOW, RULED OUT FOR OPENING DAY

Well, this isn't good news for the Boston Red Sox.

Chris Sale was sent for an MRI on his left elbow, Tuesday, just a day after throwing 15 pitches off the mound in a batting-practice session in Fort Myers. It marked the first time Sale faced a batter since August.

Red Sox pitching coach Dave Bush said Sale "looked pretty good" after the short outing. Everyone involved considered it a positive step, until Sale felt soreness in his throwing elbow the next day.

As a result, Sale had an MRI, which the team sent to Dr. James Andrews for further evaluation. And according to reporters in Fort Myers, Red Sox manager Ron Roenicke expressed concern with the situation.

This all comes a week after Roenicke announced that Sale — the Red Sox' ace — would begin the regular season on the injured list. The reason, Roenicke said, was because Sale missed the first few weeks of spring training workouts with pneumonia.

Some questioned if there was more to it than an illness. And this week, we found out that's the case.

Sale signed a five-year, \$145 million contract extension before last season. The first year of that new extension, which pays him an average annual salary of \$29 million, begins this season.

NEW ENGLAND CONSIDERED A POTENTIAL LANDING SPOT FOR DALTON

o what happens if Tom Brady actually decides to leave the Patriots and play somewhere else? Where does Bill Belichick go from there? One option would be to make Jarrett Stidham the starting quarterback, in just his second NFL season, after being drafted by the Pats in the fourth round of the 2019 Draft.

Another option would be to make a trade.

According to a report by NFL Network's Ian Rapoport, the Patriots are one of three potential suitors for Cincinnati Bengals quarterback Andy Dalton this offseason, if Brady chooses to sign somewhere else.

Dalton, 32, is entering the final year of his deal with the Bengals, and will make \$17.5 million next season. As Cincinnati is eyeing a quarterback with the No. 1 overall pick in this year's Draft, Dalton is expected to be traded this offseason, according to Rapoport.

Rapoport said the other two teams interested in a Dalton trade are the Chicago Bears and the Indianapolis Colts.

While it's still very possible that Brady returns to the Patriots, this report is an indication that Belichick is at least already putting together his backup plan.
