oston Mayor Michelle Wu has set a target date for the clearing of a homeless encampment in the troubled area often called "Mass and Cass." "We cannot continue to turn a blind eye to systems that have failed," Wu said. The location near the intersection of Massachusetts Avenue and Melnea Cass Bou-

#### It's Christmas Shopping Time For Package Thieves Too. Stay Alert!

**♦** hough there are fewer reports of package thieves in the area this Christmas season than there were last year, at least so far, they are still around and hard at work. With more residents receiving truck to door deliveries of Christmas gifts and other items ordered, the temptation to help themselves to the property of others is just too strong for those who would rather steal things than work for what they want. And although more and more people in the neighborhood than ever before have security cameras monitoring their homes, some of the culprits couldn't care less. In the era of hoodies and Covid face masks,

its more difficult to identify people who may be up to no good. But this week's editorial isn't meant to discuss the reasons the crooks resort to robbing from the door steps of people at work or out shopping, its to suggest some precautions you might want to consider to guard against this annual crime surge.

We mentioned cameras. They aren't fool proof in stopping the package thieves but they couldn't hurt. The more eyes on the streets; be they human or electronic, the better to deter the bad guys AND girls. Security cameras are now wireless, not all of them are expensive and most can be activated, monitored and oper-

ated by a smart phone when whether you are at home or out if you have Wi-Fi. If you are on good terms with your nearby neighbors, and happily, most people are in South Boston, why not work out a system whereby you look out for their deliveries when they are away from the house and they'll do it for you. Keep in touch with police. In Southie, we have a great squad of police officers based at C-6 who are dedicated to keeping our community safe. They are responsive and they are professional and always willing to help. They always encourage residents to report any suspicious activity in the area. You won't bother



them by calling them, it's their job and they don't mind doing it.

Stealing packages from door steps isn't just happening in certain parts of South Boston; it can happen and is happening in several sections. The best policy is vigilance. That saying "if you see something, say something" applies in this situation. The biggest deterrent to the thieves are watchful neighbors. If they know a neighborhood is alert and ready for them, they will almost always go elsewhere to commit their crimes. Don't let the package thieves ruin your Christmas spirit.

# Half Price Hot Dogs On The Menu Sullivan's At Castle Island Open Until December 31st




The above comments should give

# Window Into The State House

Window Into The State House provides our readers a synopsis of important issues of interest, past and current, that are being proposed, debated or acted upon by the Massachusetts Legislature. Many issues that are not related to local city government services are acted upon and have a direct impact on daily life. They are tax policy, transportation infrastructure, judicial appointments, social services and health, as well as higher education We will excerpt reports from the gavel-to-gavel coverage of House and Senate sessions by news sources focused on this important aspect of our lives. These sources include a look ahead at the coming week in state government and summaries and analyses of the past week, re-caps of a range of state government activity, as well as links to other news.

#### Fenway Park's return to the vaccination circuit

The home of the Red Sox will open for booster shots in January, Boston Globe's Travis Andersen and John R. Ellement report. This isn't the first time the state has turned to the ballpark for vaccinations -- last winter it was one of seven used for initial vaccinations. The idea here, officials in the administration said, is to increase access to boosters as cases trend upwards. State House News Service's Matt Murphy reports that Gov. Charlie Baker also asked all cities and towns to consider setting up local vaccination clinics.

A renewed call for mask mandates has swelled over the past few weeks, including from the head of the Massachusetts Medical Society. Baker said on Monday that he has no plans to reinstitute a mask mandate but maybe he will be swayed after three young adults over the age of 18 in Boston were found to have contracted

omicron. As we enter the depths of winter, all eyes will be on elected and public health officials to see how they address omicron and rising case rates, starting with a legislative oversight hearing this morning at 10 a.m.

#### Case in point: Hub hospitals show disparities in health care costs

The Wall Street Journal has found the perfect case study to demonstrate how patients with the same health issues and insurance can pay wildly different prices for the same care — and it's right here in Boston. The paper reports that a single emergency room visit would cost a hypothetical patient \$946 at Mass. General Hospital and \$577 at Boston Medical Center, which is located just three miles away.

#### Elugardo on why she decided to run for Senate

Why did Rep. Nika Elugardo decide to jump into the race for the Second Suffolk Senate seat? Dorchester Reporter's Gintautas Dumcius spoke to the Jamaica Plain Democrat about her choice to run for Senate and what opportunities she is looking forward to should she win. More from Dumcius: "With her strong relationships with her Beacon Hill colleagues, and with billions of federal dollars flowing from Washington, and the Legislature shedding a reputation for handling one or two big bills per session, Elugardo sees an opportunity to widen her gaze, she told the Reporter in an interview."

"Senator Karen" and "angry Mom." Those are the characterizations Elon Musk used to describe Sen. Elizabeth Warren after she said the top executive at Tesla should pay more in taxes. Boston Herald's Erin Tiernan reports that Warren took aim at Musk, saying "let's change the rigged tax code so The Person of the Year will actually pay taxes and stop freeloading off everyone else."

levard is an epicenter of the city's struggle with homelessness and the opioid crisis.

Wu said Wednesday the city's goal will be to move people off the streets and into housing by Jan. 12. She said residents of the encampment will be connected with services and housing before the tents are removed. Wu temporarily halted cleanup of the sprawling camp last month on her first day in office. Earlier this month, she expressed interest in finding enough alternative housing options to clear the encampments before the worst of winter weather arrives.

Residents at the site will be offered medical services, substance abuse help and any other assistance they need, Wu said. The city will use a mix of temporary housing sites and shelters to house individuals. "With these actions, our goal is to bring residents out of the cold and into supportive housing, to change the status quo in this area and citywide," she said in a statement.

Wu had previously described deep engagement between the city, nonprofits, public health organizations and those living in the encampment. The mayor said she does not expect much pushback to helping people out of the camp.

Right now, according to the Boston Public Health Commission's latest survey, there are 77 tents in the quarter-mile area known as Mass. & Cass. Located in those tents are 143 occupants with about one-third are women. 64 percent are people of color and more than half don't have a health care provider. More than three-quarters don't have a mental health care provider and most are looking for low-threshold housing.

"The vast majority, 94%-plus of residents at Mass. Avenue and Melnea Cass Boulevard have said if there was a sup-

portive, low-threshold housing option available, they would be more than happy, eager to move into the situation," Wu said. The Mayor's team has identified several areas where they plan to open locations for low threshold housing for all the people in the tents, including 40 beds available right now at the EnVision Hotel in Jamaica Plain. Plans are in the works for low threshold supportive housing beds at the Roundhouse Hotel, at Shattuck Hospital Campus and at some of the city's shelters.

"If people don't leave the tents by Jan. 12th, will they be arrested?" 5 Investigates' Karen Anderson said. "We are working daily and multiple times a day to pursue and really vigorously engage in outreach with every single person who is living in a tent right now at Mass. & Cass," Wu replied.

Boston city officials in November began enforcing the first orders to remove tents from the area, where substance abuse, mental health issues and homelessness have converged to create a humanitarian crisis. People living in the encampment near the intersection of Massachusetts Avenue and Melnea Cass Boulevard were given verbal and written notices that they had 48 hours to remove their tents and belongings. The notices were accompanied by information about available shelter beds and treatment options.

An executive order signed in mid-October by then-Mayor Kim Janey said, "...existing laws, coupled with the public health emergency, dictate that tents and temporary shelters will no longer be allowed on the public ways in the city of Boston." Janey's order also created a structure to manage and coordinate resources from the city, state and other stakeholders.

# SOUTH BOSTON COMMUNITY HEALTH CENTER'S YOUTH AMBASSADORS GO DIGITAL IN AN EFFORT TO GET THEIR FRIENDS VACCINATED

outh Boston Community Health Center's Youth Ambassadors are determined to get their friends protected from the Covid-19 virus. The teens, all fully vaccinated, spearheaded a video/social media project to encourage other teens to get vaccinated after discovering that many of their peers and classmates were still not vaccinated against the virus. Michael Indresano, of Indresano Productions donated his studio time and talent to help the teens bring their vision to reality. The campaign went live today on SBCHC's YouTube channel at

"We couldn't be more proud of these young people" said Bill Halpin, CEO of South Boston Community Health Center "the Youth Ambassadors have always been an important voice among their peers on critical health issues like substance abuse and anti-vaping efforts. We were really encouraged when they wanted to reach out to other teens about the vaccine".

The Youth Ambassadors brainstormed with Linda Doran, Youth Program Coordinator, to streamline their concept. Then they enlisted the participation of other

vaccinated teens from the Edgerly Family South Boston Boys and Girls Club; the South Boston Neighborhood House and students from the Edward M. Kennedy Academy for Health Careers where several of the Youth Ambassadors attend. Michael Indresano invited the teens to his South Boston studio where the production team brought their ideas to life during two days of shooting. It was an empowering experience for the teens. "They felt heard and respected" Linda said, "everyone on the team was welcoming and really valued what our kids had to say".



For the past 21 months, South Boston Community Health Center (SBCHC) has been a force in

Boston's Covid-19 response. Because of early preparation and foresight, they were among the first centers in the state of Massachusetts to be awarded a direct federal Covid-19 supply and were the very first (and for some time the only) site offering the Covid-19 vaccine to the public in all of Suffolk County. The SBCHC has distributed over 30,000 vaccines and has tested over 17,000 people for the virus. Their positive impact on this public health crisis has been significant.



Like New England, Indianapolis is also coming off their bye in Week 14. Unlike the Patriots though, the Colts are not on a seven-game win streak, which is the longest win streak in the league, entering Week 15.

Indianapolis is coming off a win over the Houston Texans before the bye. The 7-6 Colts have won four of their last five, and are in second place in the AFC South. If the playoffs began after Week 14, Indy would be the No. 6 seed in the AFC and would be heading to Kansas City to play the No. 3 seed Chiefs in the Wild Card round.

The Patriots are 9-4 and are the No. 1 seed in the AFC. Their latest win came in Buffalo on Monday Night Football in Week 13. Because of horrendous wind conditions, New England chose to throw the ball

just three times, and ran the ball 46 times for a total of 222 rush yards.

After their upcoming game against the Colts, the Patriots will then play back-to-back games at home against the Bills and Jackson-ville Jaguars, followed by their final game of the regular season in Week 18 against the Dolphins in Miami.

The Patriots are a 2-point underdog in Indianapolis on Saturday night.

# AMID FAILED LABOR TALKS, MLB LOCKOUT BEGINS

ajor League Baseball has officially locked out its players, giving the sport its first work stoppage since a mid-season strike by the players that ended the 1994 season and continued into the beginning of the 1995 season.

Now, it's the league creating the work stoppage, as the previous collective bargaining agreement expired earlier this month.

As a result, the annual Winter Meetings have been canceled, and team officials cannot communicate with their players.

MLB Commissioner Rob Manfred released a statement to address the lockout, titled, "A letter to baseball fans." Part of the letter read:

"Despite the league's best efforts to make a deal with the Players Association, we were unable to extend our 26 year-long history of labor peace and come to an agreement with the MLBPA before the current CBA expired. Therefore, we have been forced to commence a lockout of Major League players, effective at 12:01am ET on December 2.

"I want to explain to you how we got here and why we have to take this action today. Simply put, we believe that an offseason lockout is the best mechanism to protect the 2022 season. We hope that the lockout will jumpstart the negotiations and get us to an agreement that will allow the season to start

on time. This defensive lockout was necessary because the Players Association's vision for Major League Baseball would threaten the ability of most teams to be competitive. It's simply not a viable option. From the beginning, the MLBPA has been unwilling to move from their starting position, compromise, or collaborate on solutions."

While the league says it's using a lockout to "jumpstart" negotiations, the Players Association is calling the lockout unnecessary, and believes the league is simply just trying to strong arm the Players into an agreement.

The Major League Baseball Players Association sent out a much shorter statement that read, in full:

"This shutdown is a dramatic measure, regardless of the timing. It is not required by law or for any other reason. It was the owners' choice, plain and simple, specifically calculated to pressure Players into relinquishing rights and benefits, and abandoning good faith bargaining proposals that will benefit not just Players, but the game and industry as a whole.

"These tactics are not new. We have been here before, and Players have risen to the occasion time and again — guideed by a solidarity that has been forged over generations. We will do so again here.

"We remain determined to return to the field under the terms of a negotiated collective bargaining agreement that is fair to all parties, and provides fans with the best version of the game we all love."
